## 2. SYSTEM TEST CONFIGURATION

# 2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

#### 2.2. EUT Exercise

An engineering test mode (software/firmware) that applicant provided was utilized to manipulate the EUT into transmit, selection of the test channel, and modulation scheme.

### 2.3. Test Procedure

#### 2.3.1 Conducted Emissions

The EUT is a placed on as turn table which is 0.8 m above ground plane. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz,. The CISPR Quasi-Peak and Average detector mode is employed according to §15.207. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument. #### 2.3.2 Radiated Emissions

The EUT is a placed on as turn table. For emissions testing, the table height shall be 80 cm above the reference ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max, emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes and measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna.

Fig. 2-1 Radiated Emission

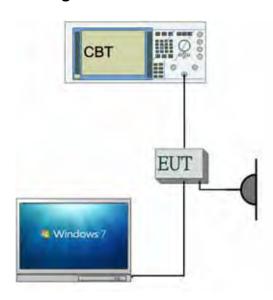
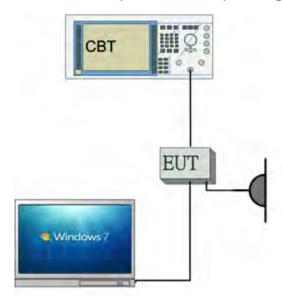


Fig. 2-2 Conducted (Antenna Port) Configuration

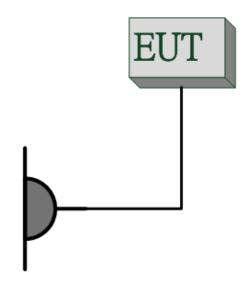

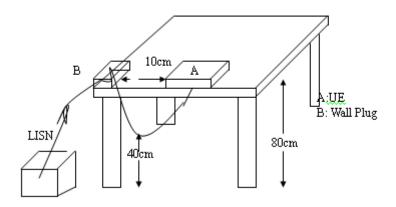

### 10. RADIATED BANDEDGE AND SPURIOUS EMISSION MEASUREMENT

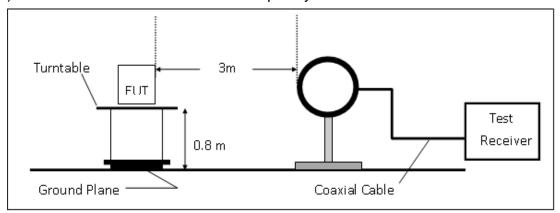

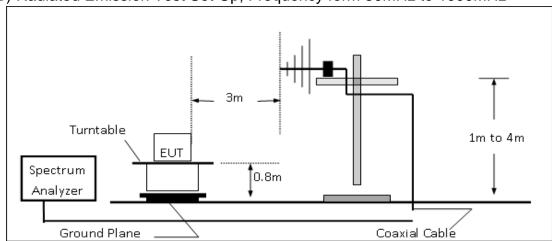

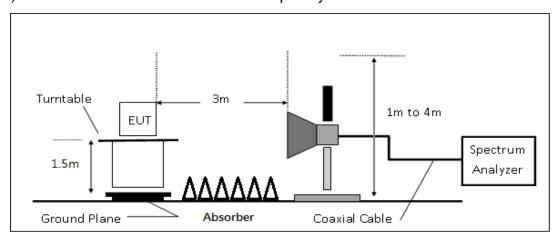
(A) Radiated Emission Test Set-UP Frequency Below 30MHz.

# 10.4. Measurement Procedure Radiated Emission

- 1. The testing follows FCC Public Notice DA 00-705 Measurement Guidelines.
- 2. The EUT was placed on a turn table with 0.8m above ground plane.
- 3. The turn table shall rotate 360 degrees to determine the position of maximum emission level.
- 4. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.

When measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna.
- 7. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.

### 14. ANTENNA REQUIREMENT

# 14.1. Standard Applicable

For intentional device, according to §15.203, an intentional radiator shall be designed to ensure that no antenna other than furnished by the responsible party shall be used with the device.

If the transmitting antenna is greater than 6dBi, the power shall be reduced by the same level in dB comparing to gain minus 6dBi.

#### 14.2. Antenna Connected Construction

The antenna connector is designed with unique type RF connector and no consideration of replacement. Please see EUT photo and antenna spec. for details.

The antenna gain is less than 6dBi. Therefore, it is not necessary to reduce maximum output power limit.
