

6.6.3 Measurement Procedure and Data

Test Procedure:

- (1)On a test site, the EUT shall be placed on a turntable and in the position closest to the normal use as declared by the user.
- (2) The test antenna shall be oriented initially for vertical polarization located 3m from the EUT to correspond to the transmitter.
- (3)The output of the antenna shall be connected to the measuring receiver and either a peak or quasi-peak detector was used for the measurement as indicated on the report. The detector selection is based on how close the emission level was approaching the limit.




