If the emission level of the EUT in peak mode was 10dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.</p> <p>g. The device could be operated by either battery or USB charge. The radiation measurements are performed in X, Y, Z axis positioning.
