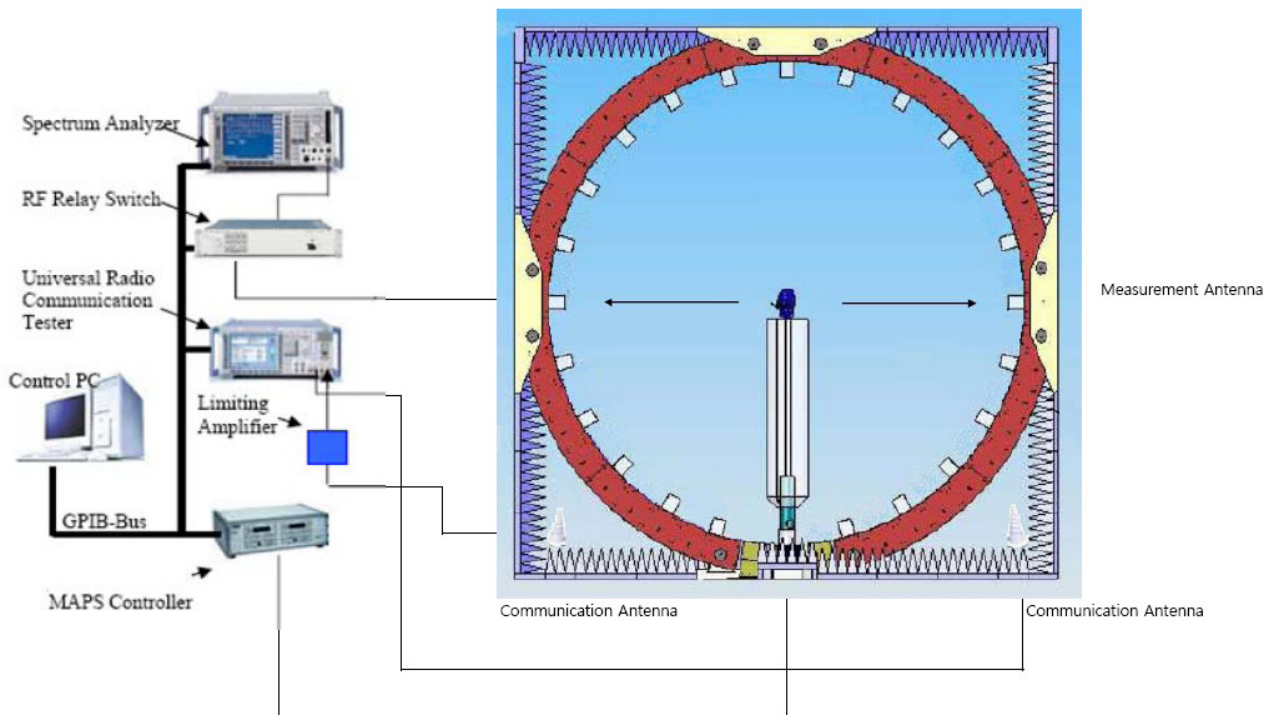

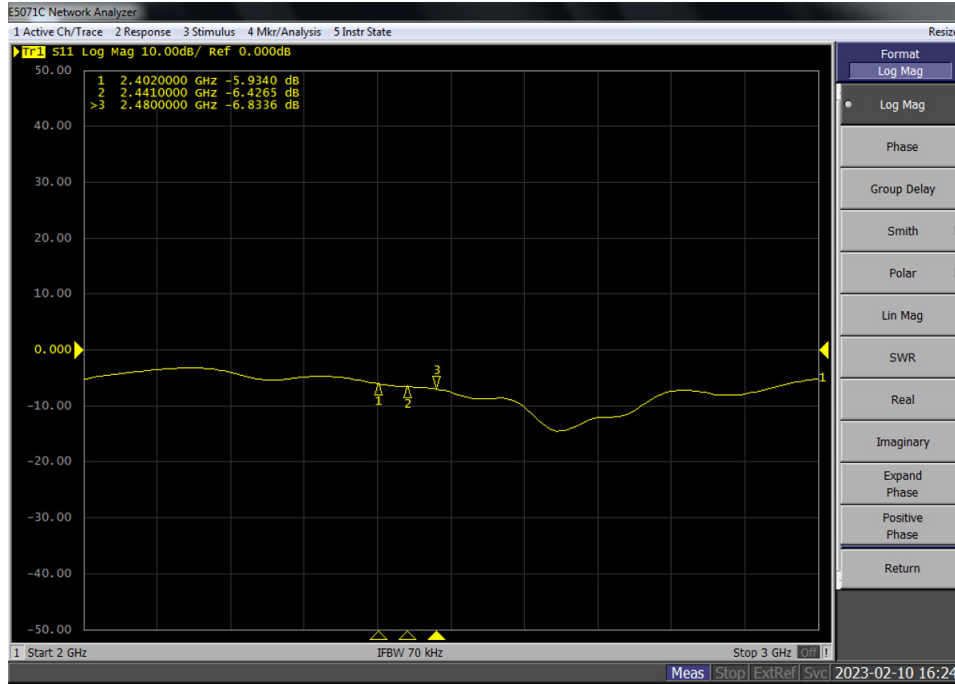

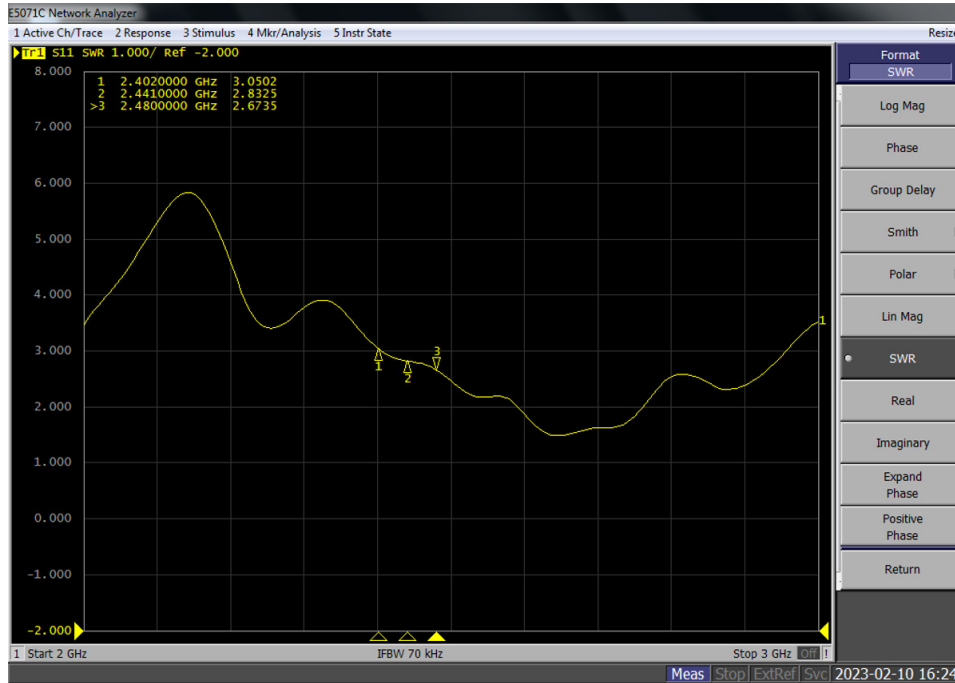

6.1 Return Loss



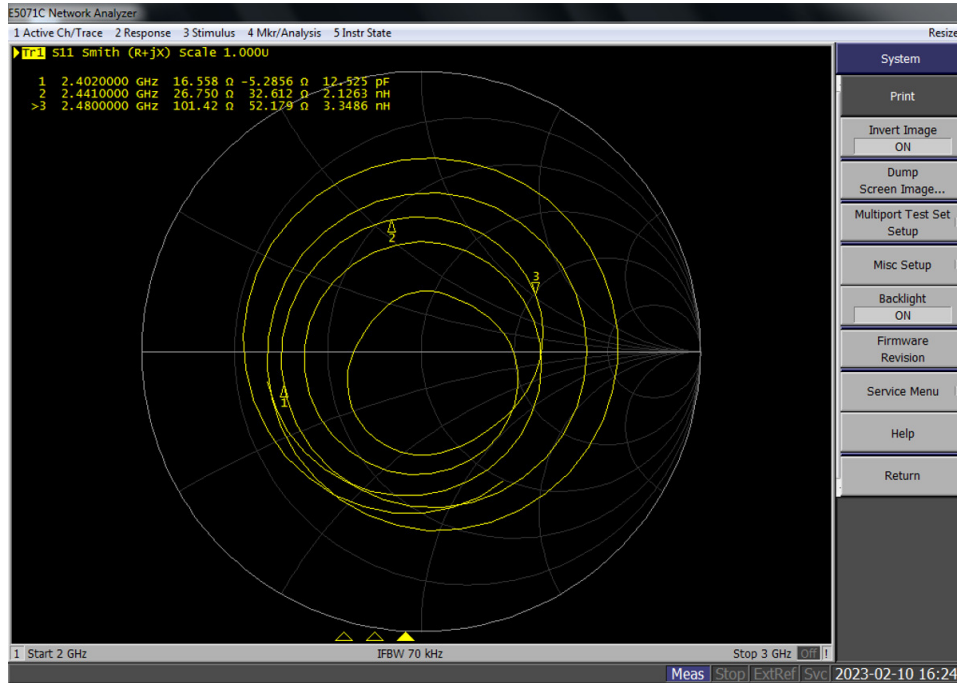

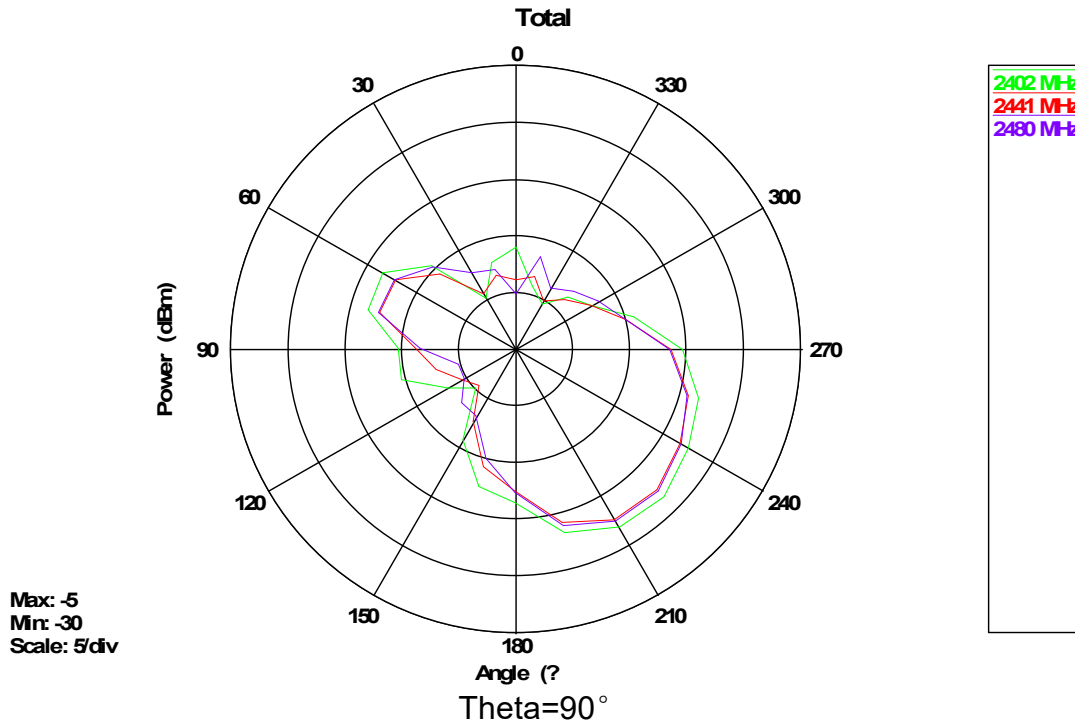

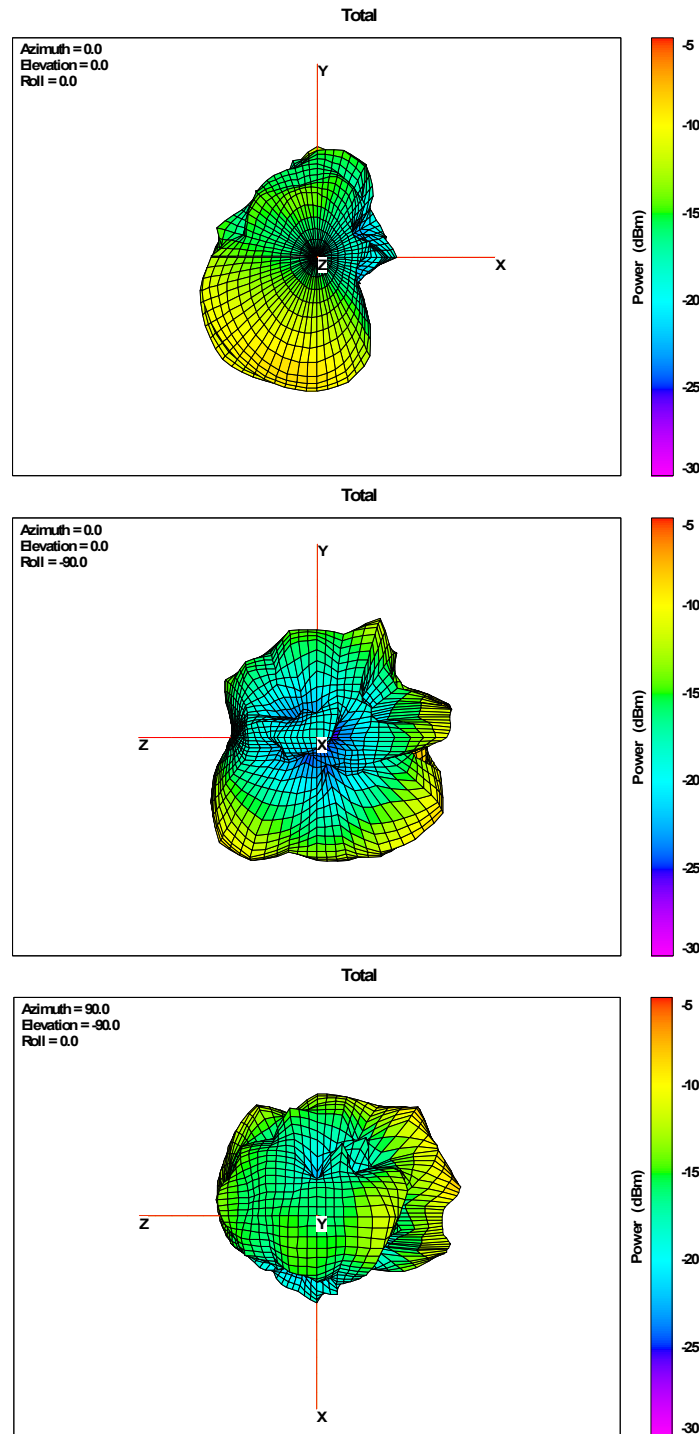

7 2-D Antenna Pattern



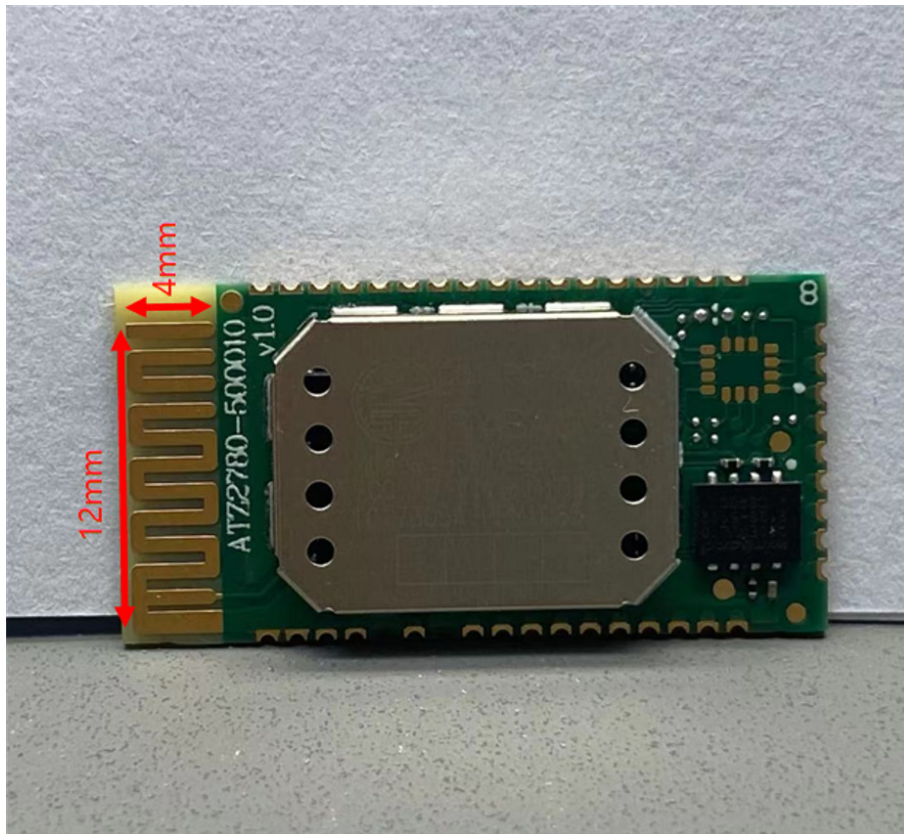
8 3-D Antenna Pattern
