BATTERY INFORMATION:

- 1. Replacement of batteries must be done by a Adult.
- 2. Do not mix old and new batteries.
- 3. Do not mix Alkaline and standard(Carbon-zinc) or rechargeable(Nickel-cadmium) batteries.
- 4. Do not use rechargeable batteries.
- 5. The supply terminals are not to be short-circuited.
- 6. Do not recharge batteries not intended to be recharged.
- 7. Exhausted batteries are to be removed from toy.
- 8. Only batteries of equivalent type are to be used.
- 2. Batteries are to be inserted with the correct polarity.

USING THE MORSE CODE FUNCTION:

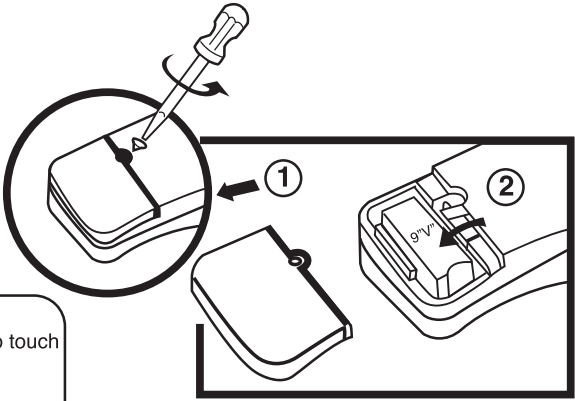
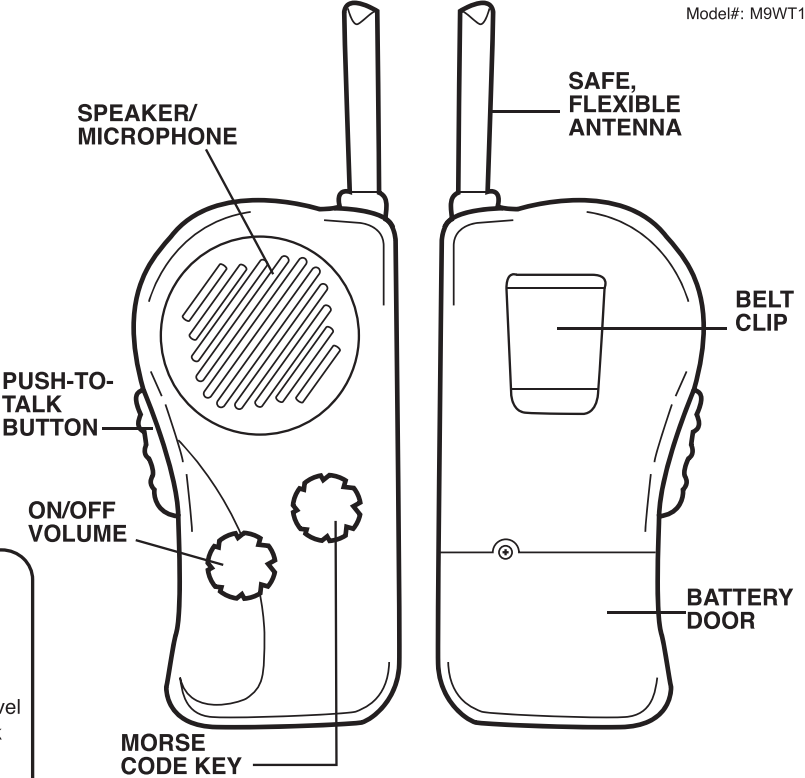
- 1. For transmitting a signal, turn the transceiver by rotating the **On/Off Volume** control past click.
- 2. While pushing the **Push-To-Talk** button), press in the **Morse Code** button momentarily and release for desired signals.
- 3. For receiving a signal, adjust **Volume** control for normal listening level
- 4. When back to voice communications again, use normal push-to-talk operation

OPERATING YOUR TRANSCEIVER:

- 1. Remove screw, open battery door and snap in a 9 Volt battery.
- 2. Turn the transceiver by rotating the **On/Off Volume** control past click. Your transceiver is now ready to operate.
- 3. Press the **Push-To-Talk** button for transmitting.
- 4. Release the **Push-To-Talk** button for receiving.
- 5. When transmitting, speak clearly in a normal voice, holding the set about 3" from your mouth
- 6. Best transmission and reception are obtained when the antenna is held in a vertical position

CAUTION:

- 1. Your Transceiver Set has been fully adjusted prior to shipment from the factory. Be sure not to touch the internal components other than replacing the batteries.
- 2. When the sound becomes weak, it is time to change the batteries.
- 3. After use, always return the **On/Off Volume** control to the **OFF** position.
- 4. Keep your set in a dry and clean place.
