#### **USAGE OF THE DAE 4**

The DAE unit is a delicate, high precision instrument and requires careful treatment by the user. There are no serviceable parts inside the DAE. Special attention shall be given to the following points:

**Battery Exchange**: The battery cover of the DAE4 unit is closed using a screw, over tightening the screw may cause the threads inside the DAE to wear out.

**Shipping of the DAE**: Before shipping the DAE to SPEAG for calibration, remove the batteries and pack the DAE in an antistatic bag. This antistatic bag shall then be packed into a larger box or container which protects the DAE from impacts during transportation. The package shall be marked to indicate that a fragile instrument is inside.

**E-Stop Failures**: Touch detection may be malfunctioning due to broken magnets in the E-stop. Rough handling of the E-stop may lead to damage of these magnets. Touch and collision errors are often caused by dust and dirt accumulated in the E-stop. To prevent E-stop failure, the customer shall always mount the probe to the DAE carefully and keep the DAE unit in a non-dusty environment if not used for measurements.



## Frequency Response of E-Field (TEM-Cell:ifi110 EXX, Waveguide: R22)





Uncertainty of Frequency Response of E-field: ± 6.3% (k=2)


## Receiving Pattern ( $\phi$ ), $\vartheta = 0^{\circ}$









Uncertainty of Axial Isotropy Assessment: ± 0.5% (k=2)


## Dynamic Range f(SAR<sub>head</sub>) (TEM cell , f<sub>eval</sub>= 1900 MHz)









## Frequency Response of E-Field (TEM-Cell:ifi110 EXX, Waveguide: R22)





Uncertainty of Frequency Response of E-field:  $\pm$  6.3% (k=2)


## Receiving Pattern ( $\phi$ ), $\vartheta = 0^{\circ}$



TEM f=1800 MHz,R22









Uncertainty of Axial Isotropy Assessment: ± 0.5% (k=2)


## Dynamic Range f(SAR<sub>head</sub>) (TEM cell , f<sub>eval</sub>= 1900 MHz)






Uncertainty of Linearity Assessment: ± 0.6% (k=2)
