To Whom It May Concern:

TÜV SÜD America Inc. Certification Body (TÜV SÜD CB) is accredited by the American National Standards Institute (ANSI) to ISO/IEC 17065 and is recognized by the Federal Communications Commission (FCC) and Innovation, Science and Economic Development (ISED) Canada a Certification body. One of the requirements of ISO/IEC 17065 is the certification body shall have a legally enforceable agreement for the provision of certification activities to its clients. The certification agreement shall take into account the responsibilities of the certification body and its clients.

By signing this agreement the client identified in the Client section at the end of this form has entered into a contract for our TÜV SÜD CB's certification services by which client agrees to abide by the Client Requirements listed below and issue payment for TÜV SÜD CB certification fees.

Client Requirements:

TÜV SÜD CB requires that the client agrees to the following:

1. The client shall always fulfil the applicable regulatory agencies requirements for the certification scheme, including implementing appropriate changes when such changes are communicated by TÜV SÜD CB.
2. If the certification applies to ongoing production, the certified product shall continue to fulfil the requirements that relate directly to the product, specified in standards or in other normative documents identified by the certification scheme.
3. The client shall make all necessary arrangements for
 - a. The conduct of the evaluation and surveillance (if required), including provision for examining documentation and records, and access to the relevant equipment, location(s), area(s), personnel, and client's subcontractors;
 - b. Investigation of complaints;
 - c. The participation of observers, if applicable.
4. The client shall not make any claims regarding certification that are not consistent with the scope of certification.
5. The client shall not use its product certification in such a manner as to bring TÜV SÜD CB into disrepute and shall not make any statement regarding its product certification that TÜV SÜD CB may consider misleading or unauthorized.
6. Upon suspension, withdrawal, or termination of certification, the client shall discontinue its use of all advertising matter that contains any reference thereto and shall take action as required by the certification scheme (e.g. the return of certification documents) and shall take any other required measure.
7. If the client provides copies of the certification documents to others, the documents shall be reproduced in their entirety or as specified in the certification scheme.
8. In making reference to its product certification in communication media such as documents, brochures or advertising, the client shall comply with the requirements of TÜV SÜD CB or as specified by the certification scheme.
9. The client shall comply with any requirements that may be prescribed in the certification scheme relating to the use of marks of conformity, and on information related to the product.
10. The client shall keep a record of all complaints made known to it relating to compliance with certification requirements and shall make these records available to TÜV SÜD CB when requested, and
 - a. Shall take appropriate action with respect to such complaints and any deficiencies found in products that affect compliance with the requirements for certification.
 - b. Shall document the actions taken.
11. The client shall inform TÜV SÜD CB, without delay, of changes that may affect its ability to conform to the certification requirements.

- Modifications to the product or the production method,

12. FCC requires applicants keep **Production Samples** on hand for at least one year after last production date and make said samples available at any time to the FCC or TÜV SÜD CB for validation (surveillance) testing.
 13. ISED Canada requires that certificate holders shall make provisions to always have production samples available upon request by TÜV SÜD CB or by ISED Canada, for auditing purposes. TÜV SÜD CB shall notify ISED Canada if the request for a sample cannot be met. Failure to provide a production sample for post-certification audit may adversely affect future certification submissions.
 14. In the event of an investigation of noncompliance by ISED Canada, the certificate holder will be asked to provide to ISED Canada, records of the quality control process and any relevant information that would help identify issues related to compliance. It is expected that all certificate holders will be able to demonstrate a quality control process used for production inspection and testing in accordance with good engineering practices.
 15. ISED Canada requires the client to keep a record of all complaints made known to the client relating to a product's compliance with requirements of the relevant standard and to make these records available to the CB or Regulatory Body when requested.
