Product Description for Equipment Under Test (EUT)

Objective

This report is prepared on behalf of *XIAMEN COMFORT SCIENCE & TECHNOLOGY GROUP CO., LTD.* in accordance with Part 2, Subpart J, and Part 15, Subparts A and C of the Federal Communications Commission's rules.

The objective is to determine the compliance of EUT with FCC rules, section 15.203, 15.205, 15.207 and 15.209.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices.

All emissions measurement was performed at Shenzhen Accurate Technology Co., Ltd. The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

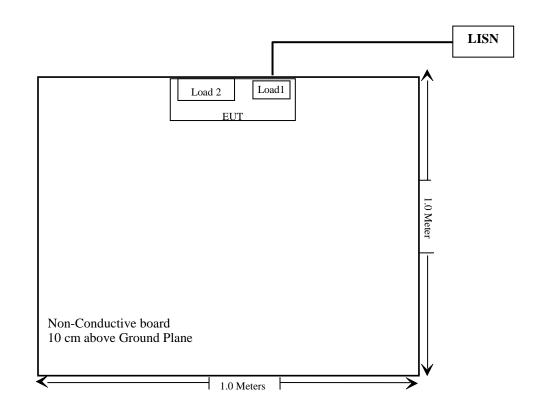

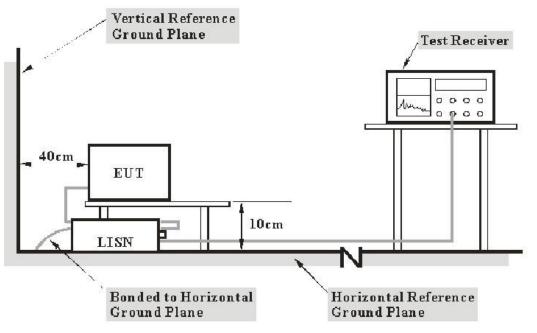

EMI Test Receiver Setup

The EMI test receiver was set to investigate the spectrum from 150 kHz to 30 MHz.

Test Procedure

Maximizing procedure was performed on the six (6) highest emissions of the EUT.

All final data was recorded in the Quasi-peak and average detection mode.

Corrected Factor & Margin Calculation

The basic equation is as follows:

Level (QuasiPeak or Average) = Reading Level + Transd Factor

Note:

Transd Factor = Cable loss + Factor of coupling device

The "**Margin**" column of the following data tables indicates the degree of compliance within the applicable limit. For example, a margin of 7dB means the emission is 7dB below the limit. The equation for margin calculation is as follows:

Margin = Limit – Level

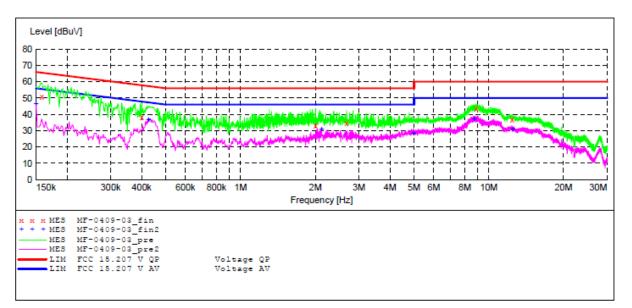

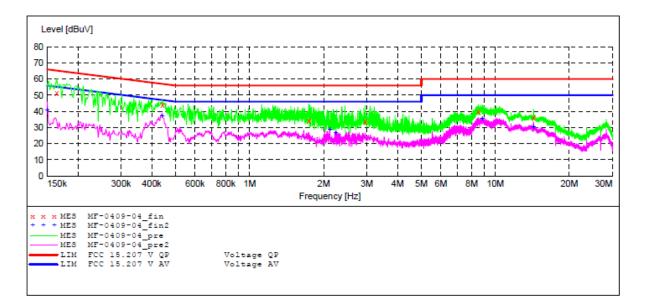

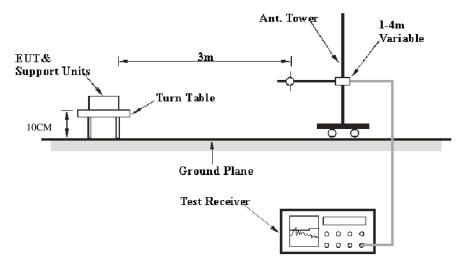

EUT Setup



The radiated emission tests were performed in the 3-meter chamber test site, using the setup accordance with the ANSI C63.10-2013. The specification used was the FCC Part Subpart C limits.

The spacing between the peripherals was 10 cm.

EMI Test Receiver Setup

The system was investigated from 9 kHz to 1 GHz.

During the radiated emission test, the EMI test Receiver was set with the following configurations:

The emission limits shown in the above table are based on measurements employing a CISPR quasi-peak detector except for the frequency bands 9-90 kHz, 110-490 kHz and above 1000 MHz. Radiated emission limits in these three bands are based on measurements employing an average detector.

If the maximized peak measured value complies with the limit, then it is unnecessary to perform an QP/Average measurement

Corrected Amplitude & Margin Calculation

The basic equation is as follows:

Result = Meter Reading+ Factor

Note:

Factor (dB/m)= Antenna factor + Cable Loss - Amplifier gain

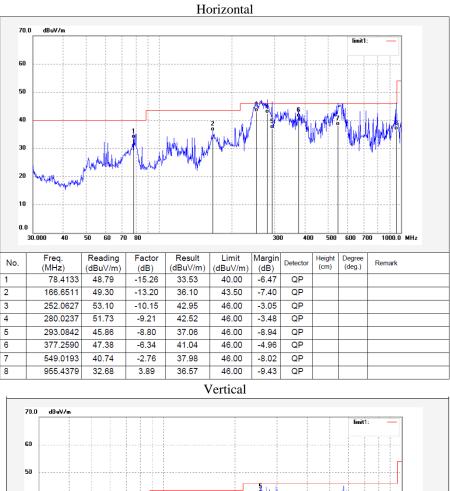

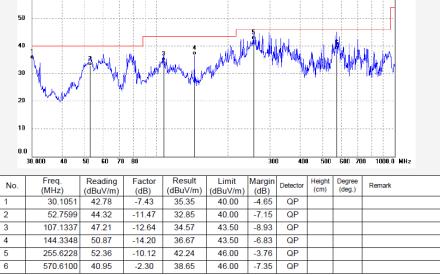
