

Test Procedure:	 The RF exposure test was performed in shielded chamber The measurement probe was placed at test distance(8cm) which is between the edge of the charger and the geometric centre of probe. The measurement probe used to search of highest strength. The highest emission level was recorded and compared with limit as soon as measurement of each points (A,B,C) were completed. 




