






#### Cellular Band (Part 22H)



The spectrum was to be investigated to the tenth harmonics of the highest fundamental frequency as specified in § 2.1051.

#### **Test Procedure**

The RF output of the transceiver was connected to a spectrum analyzer and simulator through appropriate attenuation. The resolution bandwidth of the spectrum analyzer was set at 1MHz. Sufficient scans were taken to show any out of band emissions up to 10<sup>th</sup> harmonic.




#### Cellular Band (Part 22H)



#### 30 MHz - 1 GHz (GPRS Mode)



#### 1 GHz – 10 GHz (GPRS Mode)







For mobile digital stations, the attenuation factor shall be not less than  $40 + 10 \log (P) dB$  on all frequencies between the channel edge and 5 megahertz from the channel edge,  $43 + 10 \log (P) dB$  on all frequencies between 5 megahertz and X megahertz from the channel edge, and  $55 + 10 \log (P) dB$  on all frequencies more than X megahertz from the channel edge, where X is the greater of 6 megahertz or the actual emission bandwidth as defined in paragraph (m)(6) of this section. In addition, the attenuation factor shall not be less that  $43 + 10 \log (P) dB$  on all frequencies between 2490.5 MHz and 2496 MHz and 55 + 10 log (P) dB at or below 2490.5 MHz. #### **Test Procedure**

The transmitter was placed on a wooden turntable, and it was transmitting into a non-radiating load which was also placed on the turntable.

The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and polarization as well as EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. The test was performed by placing the EUT on 3-orthogonal axis.

The frequency range up to tenth harmonic of the fundamental frequency was investigated.

Remove the EUT and replace it with substitution antenna. A signal generator was connected to the substitution antenna by a non-radiating cable. The absolute levels of the spurious emissions were measured by the substitution.

#### **Test Procedure**

Frequency Stability vs. Temperature: The equipment under test was connected to an external DC power supply and the RF output was connected to communication test set via feed-through attenuators. The EUT was placed inside the temperature chamber. The DC leads and RF output cable exited the chamber through an opening made for the purpose.

After the temperature stabilized for approximately 20 minutes, the frequency output was recorded from the communication test set.

Frequency Stability vs. Voltage: For hand carried, battery powered equipment; reduce primary supply voltage to the battery operating end point which shall be specified by the manufacturer.
