# 3.1. Pseudorandom frequency hopping sequence

The channel is represented by a pseudo-random hopping sequence hopping through the 79 RF channels. The hopping sequence is unique for the piconet and is determined by the Bluetooth device address of the master; the phase in the hopping sequence is determined by the Bluetooth clock of the master. The channel is divided into time slots where each slot corresponds to an RF hop frequency. Consecutive hops correspond to different RF hop frequencies. The nominal hop rate is 1 600 hops/s.

# 3.2. Medium access protocol

The manufacturer declares that the device uses Bluetooth protocol. It confirmed that Medium access protocol is implemented.

# 3.3. Occupied hops while the equipment is operating

While the equipment is operating (transmitting and/or receiving) each channel of the hopping sequence is occupied at least once during four times the product of the dwell time per hop and the number of channels.






#### 5.1.1. Transmitter radiated spurious emissions

The diagram below shows the test setup that is utilized to make the measurements for emission from 30 Mz to 1 Gz emissions.




The diagram below shows the test setup that is utilized to make the measurements for emission from 1 GHz to 24 GHz emissions.

# 5.2. Limit

According to \$15.247(d), in any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement , provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval , as permitted under paragraph(b)(3) of this section , the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in section \$15.209(a) is not required. In addition, radiated emission which in the restricted band, as define in section \$15.205(c))

According to § 15.109(a), for an intentional radiator devices, the general required of field strength of radiated emissions from unintentional radiators at a distance of 3 meters shall not exceed the following values :

# 5.3. Test procedures

Radiated emissions from the EUT were measured according to the dictates of ANSI C63.4:2003

#### 5.3.1. Test procedures for radiated spurious emissions

- 1. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- 2. During performing radiated emission below 1 GHz, the EUT was set 3 meters away from the interference receiving antenna, which was mounted on the top of a variable-height antenna tower. During performing radiated emission above 1 GHz, the EUT was set 3 meters away from the interference-receiving antenna.
- 3. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- 4. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- 5. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- 6. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

#### % Remark;

- 1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120 klz for Peak detection (PK) or Quasi-peak detection (QP) at frequency below 1 Glz.
- 2. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1 Mz for Peak detection and frequency above 1 Gz.
- 3. The resolution bandwidth of test receiver/spectrum analyzer is 1 Mz and the video bandwidth is 10 Hz for Average detection (AV) at frequency above 1 Gz.

# 5.3.2. Test procedures for conducted spurious emissions

- 1. The transmitter output was connected to the spectrum analyzer through an attenuator.
- 2.The bandwidth of the fundamental frequency was measured with the spectrum analyzer using RBW = 100 kHz, VBW = 100 kHz.





#### B. Middle channel (2 441 Mz)







- 1. The 20 dB band width was measured with a spectrum analyzer connected to RF antenna connector (conducted measurement) while EUT was operating in transmit mode at the appropriate center frequency. The analyzer center frequency was set to the EUT carrier frequency, using the analyzer. Display Line and Marker Delta functions, the 20 dB band width of the emission was determined.






#### A. Low channel (2 402 Mb) – 20 dB bandwidth




# B. Middle channel (2 441 Mz) – 20 dB bandwidth





# 8.2. Limit

The maximum peak output power of the intentional radiator shall not exceed the following:

- 1. §15.247(a)(1), Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW
- 2. §15.247(b)(1), For frequency hopping systems operating in the 2 400 2 483.5 Mb employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5 725 5 805 Mb band: 1 Watt.

# 8.3. Test procedure

- 1. The RF power output was measured with a Spectrum analyzer connected to the RF Antenna connector(conducted measurement) while EUT was operating in transmit mode at the appropriate center frequency, A spectrum analyzer was used to record the shape of the transmit signal.
- The bandwidth of the fundamental frequency was measured with the spectrum analyzer using; Span = approximately 5 times the 20 dB bandwidth, centered on a hopping channel RBW ≥ 20 dB BW, VBW ≥ RBW, Sweep = auto, Detector function = peak, Trace = max hold








#### B. Middle channel (2 441 Mtz)





# 9. Hopping channel separation

#### 9.1. Test setup



## 9.2. Limit

§15.247(a)(1) Frequency hopping system operating in 2 400 – 2 483.5 Mb. Band may have hopping channel carrier frequencies that are separated by 25 kb or two-third of 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW.

#### 9.3. Test procedure

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Position the EUT as shown in test setup without connection to measurement instrument. Turn on the EUT and connect it to measurement instrument. Then set it to any one convenient frequency within its operating range.
- 3. By using the max hold function record the separation of adjacent channels.
- 4. Measure the frequency difference of these two adjacent channels by spectrum analyzer mark function. And then plot the result on spectrum analyzer screen.
- 5. Repeat above procedures until all frequencies measured were complete.
- 6. Set center frequency of spectrum analyzer = middle of hopping channel.
- 7. Set the spectrum analyzer as RBW = 100 kHz, VBW = 100 kHz, Span = 5 MHz and Sweep = auto.








#### **Operation mode: 8DPSK**

## 11.2. Limit

15.247(a)(1)(iii) For frequency hopping system operating in the 2 400 – 2 483.5 Mb band, the average time of occupancy on any frequency shall not be greater than 0.4 second within a 31.6 second period.

A period time = 0.4(s) \* 79 = 31.6(s)

## 11.3. Test procedure

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Position the EUT as shown in test setup without connection to measurement instrument. Turn on the EUT and connect its antenna terminal to measurement instrument via a low loss cable.
- 3. Adjust the center frequency of spectrum analyzer on any frequency be measured and set spectrum analyzer to zero span mode. And then, set RBW and VBW of spectrum analyzer to proper value.
- 4. Measure the time duration of one transmission on the measured frequency. And then plot the result with time difference of this time duration.
- 5. Repeat above procedures until all frequencies measured were complete.
- 6. The Bluetooth has 6 type of payload, DH1, DH3, DH5, 3DH1, 3DH3, 3DH5. The hopping rate is 1 600 per second.

# 12. Antenna requirement

# 12.1. Standard Applicable

For intentional device, according to FCC 47 CFR Section §15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC 47 CFR Section §15.247 (b) if transmitting antennas of directional gain greater than 6 dBi are used, the power shall be reduced by the amount in dB that the gain of the antenna exceeds 6 dBi.

Pd the limit of MPE, 1 mW/cm<sup>2</sup>. If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance where the MPE limit is reached.
