Long term confidentiality is requested under the special condition that the internal circuit cards are enclosed in metal mechanical casings that are epoxied together. Equipment users are unable to remove the casings to view the circuit boards without damaging the mechanical housing. Internal photos are controlled as proprietary and confidential information within Sagotech's configuration management system. They are only released to outside parties under a Non-Disclosure Agreement (NDA). An NDA Exhibit is provided as a separate attachment. Authorized technicians are restricted to Sagotech employees.

The Applicant understands that pursuant to Rule 0.457(d)(1)(ii), disclosure of this Application and all accompanying materials will not be made before the date of the Grant for this Application.

1- The asterisked items (*) require further justification before permanent confidentiality will be allowed. These also currently require review by the FCC under their Permit-But-Ask policy before the grant is issued and can delay completion of an application. Further justification should be added to the note above. One such example for a potted device would be: "The EUT is FULLY potted using a non-removable epoxy based material. Removal of potting material causes irreparable damage to internal circuitry. See photographs exhibits that outline the device before and after potting."

2- These items require no additional justification to be held confidential but must be requested regardless. Note that most Part 15 device do not require a tune-up procedure. If no tune-up procedure is required, then do not check the tune-up procedure box.

3- These items are unique to the FCC only and require additional fees. It allows for keeping all items confidential until product begins shipping. Once product starts shipping then BABT must be notified to cancel the short term confidentiality.
