


Fig.1 Photograph of the SAR measurement System




Fig.2.1 Photograph of the Tissue Simulant Fig.2.2 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body) Fluid liquid depth 15cm for Left-head Side




Fig.3 Right Head Section / Cheek-Touch Position_ Slider off




Fig.5 Left Head Section / Cheek-Touch Position_ Slider off




Fig.7 Right Head Section / Cheek-Touch Position_ Slider on




Fig.8 Right Head Section / Ear-Tilt Position(15°)_ Slider on




Fig.9 Left Head Section / Cheek-Touch Position_ Slider on




Fig.12 Body worn- EUT back to flat phantom and distance between flat phantom and mobile phone is 1.5 cm




Fig.16 Antenna position of EUT
