

Operation:


Download App from the desired App Store for the desired Bluetooth enabled devices such as cell phones, tablets, and laptops.

Validate Bluetooth device is enable on your cell phone, tablet, and or laptop.

Click on the Application icon.



Select the desired device to control from the dropdown menu.







Head Rest, Lumbar, and Recline Functions

Depress the desired icon for Head Rest, Lumbar, and Recline to either open or close to the desired position and release to stop.

Home icon



The purpose of the Home icon is to fully reposition the Head Rest, Lumbar, and the Recliner to the fully seated position.

Depress and hold the Home icon to reposition the chair until fully seated position. Release icon to stop at any time.

Set Memory 1 Position

Depress the Open and or Close icon to the desired position for user 1 for all three functions. i.e. Head Rest, Lumbar, and Recline. Then depress the Set icon for Memory 1; slight chair movement will indicate that the memory position has been set. This small movement is feedback to the user that Memory 1 function is set. Then release button. Memory 1 is set.

Press and hold the Home Icon until the chair is in the fully seated position. Depress the Memory 1 Go icon and the chair will reposition to the set Memory 1 position.

Set Memory 2 Position

Depress the Open and or Close icon to the desired position for user 2 for all three functions. i.e. Head Rest, Lumbar, and Recline. Then depress and hold the Set icon for memory 2 until there is chair movement. This small movement is feedback to the user that Memory 2 is set. Then release button. Memory 2 is set.

Press and hold the Home Icon until the chair is in the fully seated position. Depress the Memory 2 Go icon and the chair will reposition to the set Memory 2 position.









Massage Functions (Optional)

Mode - Depress the Steady, Wave, or Pulse Icon for desired massage function.

Intensity - Depress the High, Medium, or Low icon for desired massage strength.

The Power icon will illuminate white indicating the massage function is ON. Depress Power icon at any time to turn ON or OFF massage function.

NOTE: The massage function has a 20 Minute Timer.





Heat Functions (Optional)

Mode - Depress the Steady, Wave, or Pulse Icon for desired massage function.







Light Functions (Optional)



Depress the Light icon to activate the light.

Cooling Functions (Optional)

Depress the Snowflake icon to activate the cooling cup.

NOTE: The cooling function has a 1 Hour Timer.

Disconnect

Depress the X in the upper left hand of the screen for pull down menu to disconnect control to the chair.
