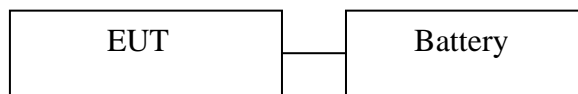

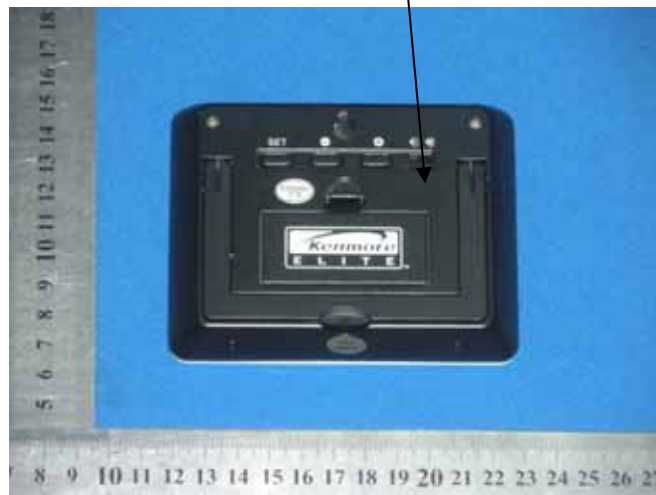

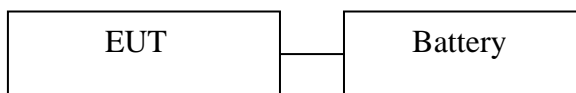

6.6. Test Procedure

The EUT is put on a table of non-conducting material that is 80cm high. The vertical conducting wall of shielding is located 40cm to the rear of the EUT. The power line of the EUT is connected to the AC mains through a Artificial Mains Network (A.M.N.). A EMI test receiver (R&S Test Receiver ESCS30) is used to test the emissions form both sides of AC line. The bandwidth of EMI test receiver is set at 9kHz.

The bandwidth of the test receiver (R&S Test Receiver ESHS30) is set at 10KHz.

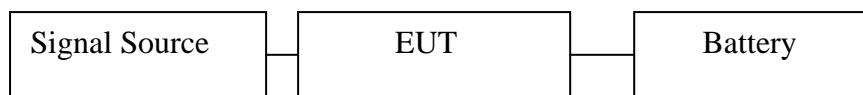

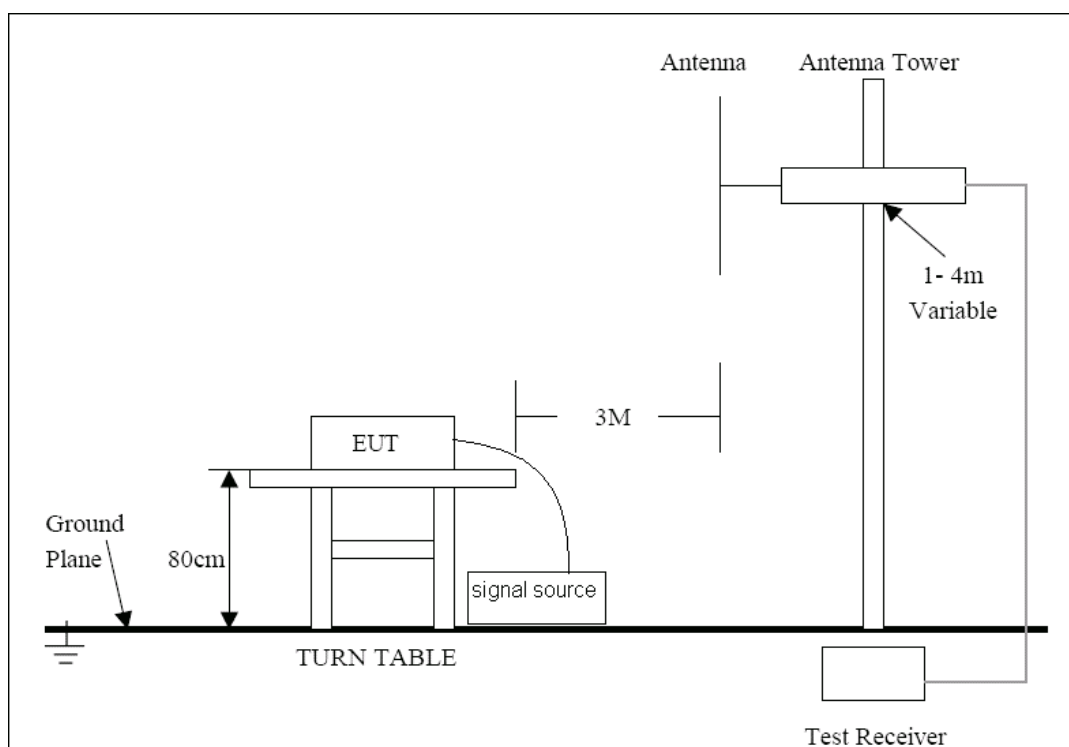

7.6.3.Let the EUT work in test mode(EUT working) and measure it.

7.7. Test Procedure

The measurement procedures found in ANSI C63.4-2003 as required by 47 CFR Part 15 Subpart A Section 15.31(a)(3).

A signal generator is used to radiate an unmodulated CW signal to the EUT in order to “cohere” the individual components of the characteristic broadband emissions from EUT. The EUT is placed on a turn table which is 0.8 meter above ground. The turn table can rotate 360 degrees to determine the position of the maximum emission level. The EUT is set 3 meters away from the receiving antenna which is mounted on a antenna tower. The antenna can move up and down between 1 to 4 meters to find out the maximum emission level. Broadband antenna (calibrated by dipole antenna) are used as a receiving antenna. Both horizontal and vertical polarization of the antenna are set on measurement.

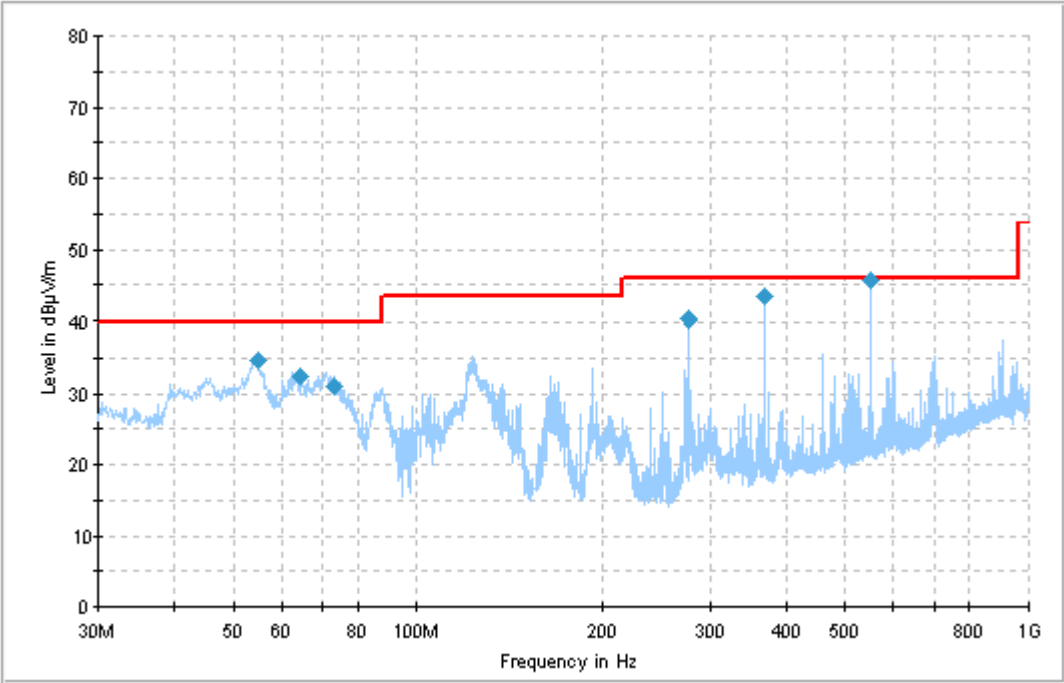
The bandwidth setting on the test receiver (R&S TEST RECEIVER ESCS20) is 120 KHz. The EUT is tested in Semi-anechoic Chamber. The frequency range from 30MHz to 1000 MHz is checked. All the test results are listed in Section 7.8. and all the scanning waveform are attached within **Appendix I**.
