2. FCC Exclusion result

2.1 Body SAR Test Exclusions Applied _Bluetooth 4.2 LE

Since this product is a Bluetooth adapter product, It is used near the user's body. so Body SAR standard is applied.

According to the FCC KDB 447498 D01 v06 section 4.3.1, for 100 MHz to 6 GHz and test separation distances ≤ 50 mm, the 1-g SAR test exclusion thresholds are determined by the following:

a) For 100 MHz to 6 GHz and test separation distances \leq 50 mm, the 1-g SAR test exclusion thresholds are determined by the following:

[(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)] · [√f(GHz)] \leq 3.0 for 1-g SAR, where
