Country code region setting is done in a specific file which is included in the driver. However, we don't provide user to modify the country region. It cannot be modified by end user or an installer.

A master device is defined as a device operating in a mode in which it has the capability to transmit without receiving an enabling signals to other devices

A client device is defined as a device operating in a mode in which the transmissions of the device are under control of the master. A device in client mode is not able to initiate a network.

On DFS channels, the WLAN driver on the device operates under the control of an AP at all times, except when in Ad-Hoc Mode, on US non-DFS channels. As described in the answer to question (2), the device passively scans DFS frequencies until a master device is detected. The control of this functionality is not accessible to anyone under any conditions. Furthermore, the firmware is locked by proprietary password and cannot be changed or modified by end user.
