### 1. RF Exposure Evaluation

#### 1.1. Limits

#### SAR Test Exclusion Thresholds for 100 MHz - 6 GHz and ≤ 50 mm

Approximate SAR Test Exclusion Power Thresholds at Selected Frequencies and Test Separation Distances are illustrated in the following Table. The equation and threshold in Note 1 must be applied to determine SAR test exclusion.

distances ≤ 50 mm are determined by:

[(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance, mm)] \*  $[\sqrt{f(GHz)}] \le 3.0$  for 1-g SAR and  $\le 7.5$  for 10-g extremity SAR, where

- f(GHz) is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation
- The result is rounded to one decimal place for comparison
- 3.0 and 7.5 are referred to as the numeric thresholds in the step 2 below

The test exclusions are applicable only when the minimum test separation distance is  $\leq$  50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm according to 5) in section 4.1 is applied to determine SAR test exclusion.

#### 1.2. Test Procedure

Software provided by client enabled the EUT to transmit and receive data at lowest, middle and highest channel individually.

The temperature and related humidity: 18°C and 78% RH.

#### 1.3. Test Result of RF Exposure Evaluation

Antenna Gain: The maximum Gain measured in fully anechoic chamber is 2.7dBi for 2.4GHz in logarithm scale.

#### **Output Power into Antenna:**

Test Mode	Frequency Band (MHz)	Maximum output power to antenna (mW)
Bluetooth	2402~2480	1.08

Per FCC KDB 447498 D01v05r02, the SAR exclusion threshold for distances < 50mm is defined by the following equation:

$$\frac{Max\ Power\ of\ Channel\ (mW)}{Test\ Separation\ Dist\ (mm)}*\sqrt{Frequency(GHz)} \le 3.0$$

Based on the maximum conducted power of Bluetooth and the antenna to use separation distance, WLAN SAR was not required;

$$[(1.08 \text{ mW/5})^* \sqrt{2.480}] = 0.335 < 3.0.$$

Note: When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion.
