# **Applicable Standards & Test Procedures**

In accordance with the Federal Communications Code of Federal Regulations, dated October 1, 2010, Part 2, Subpart J, Paragraphs 2.907, 2.911, 2.913, 2.925, 2.926, 2.1031 through 2.1057, and applicable parts of paragraph 15, Part 15C Paragraph 15.247 the following information is submitted.

Test procedures used are the established Methods of Measurement of Radio-Noise Emissions as described in the ANSI C63.4-2009 Document, FCC documents KDB 662911 MIMO, DA00-1407 and DA00-705 and/or TIA/EIA 603-1. Testing for the AC line-conducted emissions were performed as defined in sections 7 and 13.1.3, testing of the radiated emissions was performed as defined in sections 8 and 13.1.4 of ANSI C63.4-2009. Testing of the intentional radiated emissions was performed as defined in section 13 of ANSI C63.4-2009.

## **Equipment Function and Configuration**

The EUT is a 2412-2462 MHz Single Input Single Output 802.11 b/g/n Digital Transmission System transmitter. The design offers two options for transmitter output, either a printed circuit board mounted chip antenna or u/fl provision for connection to authorized external antenna. The equipment is used to transmit data in applications offering broadband wireless connectivity. The equipment is marketed for use to incorporate a wireless link to exchange data information from one point to another. For testing purposes, the ARCFlex 802.11b/g/n Module was connected to the manufacturer supplied text fixture and POE power adapter. The test fixture was connected to the laptop and communicating over network interface allowing for operational control of the transmitter. The ARCFlex 802.11b/g/n Module receives power from the support text fixture, which was powered from supplied POE AC adapter. Two POE adapters were supplied for testing. The EUT offers connection port for authorized antennas and requires power supplied from external support circuitry. No other interfacing options are provided. For testing purposes, the ARCFlex 802.11b/g/n Module was powered from the POE power adapter and set to transmit in available data modes. Worst-case data presented in this report. The device is marketed for OEM use and professional installation. The antenna connection and options comply with the unique antenna connection requirements.



#### Test Procedures

#### AC Line Conducted Emission Test Procedure

The EUT operates from DC power only. The EUT must be connected to support circuitry for power using approved AC adapter/POE for operation. For testing purposes, the manufacturer supplied test fixture and POE AC power adapter was used to power the EUT and system. Testing for the AC line-conducted emissions testing was performed as defined in sections 7 and 13.1.3 of ANSI C63.4-2009. The test setup including the EUT was arranged in typical equipment configurations and placed on a 1 x 1.5-meter wooden bench, 0.8 meters high located in a screen room. The power lines of the system were isolated from the power source using a standard LISN with a 50-µHy choke. EMI was coupled to the spectrum analyzer through a 0.1 μF capacitor internal to the LISN. The LISN was positioned on the floor beneath the wooden bench supporting the EUT. The power lines and cables were draped over the back edge of the table.

#### Radiated Emission Test Procedure

The EUT was placed on a rotating 1 x 1.5-meter wooden platform, 0.8 meters above the ground plane at a distance of 3 meters from the FSM antenna. Testing for the radiated emissions was performed as defined in sections 8 and 13.1.4 of ANSI C63.4-2009. EMI energy was maximized by equipment placement, raising and lowering the FSM antenna, changing the antenna polarization, and by rotating the turntable. Each emission was maximized before data was taken using a spectrum analyzer. Refer to photographs in the test setup exhibits for EUT placement during testing.

#### **Intentional Radiators**

As per CFR47, Subpart C, paragraph 15.247 the following information is submitted.

#### Antenna Requirements

The EUT design incorporates either PCB mounted chip antenna or u.fl antenna connection port for use with authorized antenna systems only. The design is marketed for OEM and professional installation and use as described in accompanying documentation. The antenna connection point complies with the unique antenna connection requirements. The requirements of 15.203 are fulfilled; there are no deviations or exceptions to the specification.

#### Restricted Bands of Operation

Spurious emissions falling in the restricted frequency bands of operation were measured at a distance of three meters on the OATS. The EUT utilizes frequency, determining circuitry, which generates harmonics falling in the restricted bands. Emissions were measured at the OATS, using appropriate antennas or pyramidal horns, amplification stages, and a spectrum analyzer. No other significant emission was observed which fell into the restricted bands of operation.

#### Summary of Results for Radiated Emissions in Restricted Bands

The EUT demonstrated compliance with the radiated emissions requirements of CFR 47 Part 15C Intentional Radiators. The EUT demonstrated a minimum margin of -1.1 dB below the radiated emissions requirements in restricted frequency bands. Peak, Quasi-peak, and average amplitudes were checked for compliance with the regulations. Worst-case emissions are reported with other emissions found in the restricted frequency bands at least 20 dB below the requirements.

#### AC Line Conducted Emissions Procedure

The EUT was arranged in the test fixture emulating worst-case equipment configuration. This configuration was placed on a 1 x 1.5-meter wooden bench 80 cm above the conducting ground plane, floor of a screen room. The bench was positioned 40 cm away from the wall of the screen room. The LISN was positioned on the floor of the screen room 80-cm from the rear of the EUT. The manufacturer supplied POE power adapter was connected to the LISN. A second LISN was positioned on the floor of the screen room 80-cm from the rear of the supporting equipment of the EUT. All power cords except the EUT were then powered from the second LISN. EMI was coupled to the spectrum analyzer through a 0.1 µF capacitor, internal to the LISN. Power line conducted emissions testing were carried out individually for each current carrying conductor of the EUT. The excess length of lead between the system and the LISN receptacle was folded back and forth to form a bundle not exceeding 40 cm in length. The screen room, conducting ground plane, analyzer, and LISN were bonded together to the protective earth ground. Preliminary testing was performed to identify the frequency of each radio frequency emission displaying the highest amplitude. The cables were repositioned to obtain maximum amplitude of measured EMI level. Once the worst-case configuration was identified, plots were made of the EMI from 0.15 MHz to 30 MHz then the data was recorded with maximum conducted emissions levels. Refer to figures one through four for plots of the EUT powered by POE adapter AC Power Line conducted emissions.




Figure 1 AC Line Conducted Emissions Line 1 (POE 1)




Figure 2 AC Line Conducted Emissions Line 2 (POE 1)




Figure 3 AC Line Conducted Emissions Line 1 (POE 2)




Figure 4 AC Line Conducted Emissions Line 2 (POE 2)

#### General Radiated Emissions Procedure

The EUT was arranged in a typical equipment configuration and operated through all available modes with worst-case data recorded. Preliminary testing was performed in a screen room with the EUT positioned 1 meter from the FSM. Radiated emissions measurements were performed to identify the frequencies, which produced the highest emissions. Plots were made of the radiated frequency spectrum from 30 MHz to 25,000 MHz for the preliminary testing. Refer to figures five through eleven for plots of the general radiated emissions spectrum (POE 1 configuration) taken in a screen room. Refer to figures twelve through eighteen for plots of the general radiated emissions spectrum (POE 2 configuration) taken in a screen room. Each radiated emission was then maximized at the OATS location before final radiated emissions measurements were performed. Final data was taken with the EUT located at the OATS at a distance of 3 meters between the EUT and the receiving antenna. The frequency spectrum from 30 MHz to 25,000 MHz was searched for general radiated emissions. Measured emission levels were maximized by EUT placement on the table, rotating the turntable through 360 degrees, varying the antenna height between 1 and 4 meters above the ground plane and changing antenna position between horizontal and vertical polarization. Antennas used were Broadband Biconical from 30 to 200 MHz, Biconilog from 30 to 1000 MHz, Log Periodic from 200 MHz to 1 GHz and or double Ridge or pyramidal horns and mixers from 1 GHz to 40 GHz, notch filters and appropriate amplifiers and external mixers were utilized.




Figure 5 General Radiated Emissions taken at 1 meter in screen room (POE 1)




Figure 6 General Radiated Emissions taken at 1 meter in screen room (POE 1)




Figure 7 General Radiated Emissions taken at 1 meter in screen room (POE 1)




Figure 8 General Radiated Emissions taken at 1 meter in screen room (POE 1)




Figure 9 General Radiated Emissions taken at 1 meter in screen room (POE 1)




Figure 10 General Radiated Emissions taken at 1 meter in screen room (POE 1)




Figure 11 General Radiated Emissions taken at 1 meter in screen room (POE 1)




Figure 13 General Radiated Emissions taken at 1 meter in screen room (POE 2)




Figure 14 General Radiated Emissions taken at 1 meter in screen room (POE 2)




Figure 15 General Radiated Emissions taken at 1 meter in screen room (POE 2)




Figure 16 General Radiated Emissions taken at 1 meter in screen room (POE 2)




Figure 17 General Radiated Emissions taken at 1 meter in screen room (POE 2)




Figure 18 General Radiated Emissions taken at 1 meter in screen room (POE 2)

The equipment utilizes the internal antenna and external u.fl antenna connection ports for either transmit or receive. The EUT and test configurations were placed on a wooden turntable 0.8 meters above the ground plane at a distance of 3 meters from the FSM antenna. The peak and quasi-peak amplitude of the frequencies below 1000 MHz were measured using a spectrum analyzer. The peak and average amplitude of emissions above 1000 MHz including were measured using a spectrum analyzer. Data was recorded from the analyzer measurement result. . Antennas used for radiated emissions testing were Broadband Biconical from 30 to 200 MHz, Biconilog from 30 to 1000 MHz, Log Periodic from 200 MHz to 1 GHz and or double Ridge or pyramidal horns and mixers from 1 GHz to 60 GHz, notch filters, and appropriate amplifiers and external mixers were utilized. Plots were made of transmitter antenna port conducted performance taken in a screen room. Refer to figures nineteen through fifty-four showing plots of the EUT emissions performance displaying compliance with the specifications.




Figure 19 Plot of Antenna Port Emissions (Across Operational Band, 20MHz CCK Mode)




Figure 20 Plot of Antenna Port Emissions (Across Operational Band, 20MHz CCK Mode)




Figure 21 Plot of Antenna Port Emissions (Across Operational Band, 20MHz OFDM Mode)




Figure 22 Plot of Antenna Port Emissions (Across Operational Band, 20MHz OFDM Mode)




Figure 23 Plot of Antenna Port Emissions (Across Operational Band, 40MHz Mode)




Figure 24 Plot of Antenna Port Emissions (Across Operational Band, 40MHz Mode)

Figure 27 Plot of 6dB Band width (20 MHz Mode, CCK 2462 MHz)




Figure 28 Plot of 6dB Band width (20 MHz Mode, OFDM 2412 MHz)




Figure 29 Plot of 6dB Band width (20 MHz Mode, OFDM 2437 MHz)




Figure 30 Plot of 6dB Band width (20 MHz Mode, OFDM 2462 MHz)




Figure 31 Plot of 6dB Band width (40 MHz Mode, 2422 MHz)




Figure 32 Plot of 6dB Band width (40 MHz Mode, 2437 MHz)

Figure 33 Plot of 6dB Band width (40 MHz Mode, 2452 MHz)




Figure 34 Plot of Power Spectral Density (20 MHz Mode, CCK 2412 MHz)




Figure 35 Plot of Power Spectral Density (20 MHz Mode, CCK 2437 MHz)




Figure 36 Plot of Power Spectral Density (20 MHz Mode, CCK 2462 MHz)




Figure 37 Plot of Power Spectral Density (20 MHz Mode, OFDM 2412 MHz)




Figure 38 Plot of Power Spectral Density (20 MHz Mode, OFDM 2437 MHz)




Figure 39 Plot of Power Spectral Density (20 MHz Mode, OFDM 2462 MHz)




Figure 40 Plot of Power Spectral Density (40 MHz Mode, 2422 MHz)




Figure 41 Plot of Power Spectral Density (40 MHz Mode, 2437 MHz)




Figure 42 Plot of Power Spectral Density (40 MHz Mode, 2452 MHz)

Figure 43 Plot of Band Edge Compliance at Antenna port (20 CCK MHz)




Figure 44 Plot of Band Edge Compliance at Antenna port (20 CCK MHz)




Figure 45 Plot of Band Edge Compliance at Antenna port (20 OFDM MHz)




Figure 46 Plot of Band Edge Compliance at Antenna port (20 OFDM MHz)




Figure 47 Plot of Band Edge Compliance at Antenna port (40 MHz)




Figure 48 Plot of Band Edge Compliance at Antenna port (40 MHz)




Figure 49 Plot of Antenna port conducted emissions




Figure 50 Plot of Antenna port conducted emissions




Figure 51 Plot of Antenna port conducted emissions




Figure 52 Plot of Antenna port conducted emissions




Figure 53 Plot of Antenna port conducted emissions




Figure 54 Plot of Antenna port conducted emissions

### **Summary of Results for Transmitter Radiated Emissions of Intentional Radiator**
