Read and observe the enclosed safety instructions in all cases to ensure that the device can be used in a safe manner.



Overview of functions

Switching on and operating the device

- Make sure the device is connected to the power source, the device will automatically turn on when the car starts.
- After switching on for the first time, select the country-specific settings matching your requirements.
- Briefly tap on the symbols of the screen in order to open the separate areas.
- When the power is turned off, the device will automatically turn off.

Using in the Vehicle



DANGER!

Use the device in the vehicle only in the **holder intended for this purpose**. The device may only be installed and operated in such vehicles so that the **driver cannot be distracted**.

When removing the BYOC RSE SYSTEM from the holder when traveling or when the engine is running, a warning message appears on the screen.

ATTENTION!

Children in **the passenger compartment in reboard position**: Remove the BYOC RSE SYSTEM as well as the corresponding holder from the backrest of the front seat – Risk of injury.



Information on troubleshooting

The device cannot be switched on

Rechargeable battery is empty – Using the adjacent options specified, charge the rechargeable battery and switch on again.

No volume

The volume is at 0 – Increase the volume.

Playing back has been interrupted – Continue playback or restart.

Films / photos / music files / applications are not displayed as expected

The file format is not supported – The playback formats are specified in the online help.

The data carrier cannot be read – Check correct connection and read again.

Symbols have been deleted – Add the symbol (e.g., an App) back to the desired area.

Please note that Apps can be loaded only for landscape mode.
