3 TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4 and FCC CFR 47 2.1046, 2.1047, 2.1049, 2.1051, 2.1053, 2.1055, 2.1057, 15.207, 15.209 and 15.247.

3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

3.2 EXERCISEEUT

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

3.3 GENERAL TEST PROCEDURES

Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 13.1.4.1 of ANSI C63.4.

3.6 DESCRIPTION OF TEST MODES

The EUT has been tested under operating condition.

After verification, all tests were carried out with the worst case test modes as shown below GFSK(1M) and 8-DPSK(3 Mbps) Channel Low (2402MHz) · Mid (2441MHz) and High (2480MHz), these were chosen for full testing.

5 FACILITIES AND ACCREDITATIONS

5.1 FACILTIES

All measurement facilities used to collect the measurement data are located at CCS China Kunshan Lab at 10#Weiye Rd, Innovation Park Eco. & Tec. Development Zone Kunshan city JiangSu, (215300), CHINA.

The sites are constructed in conformance with the requirements of ANSI C63.4 and CISPR Publication 22

5.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with pre-selectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

5.3 LABORATORY ACCREDITATIONS AND LISTING

The test facilities used to perform radiated and conducted emissions tests are accredited by American Association for Laboratory Accreditation Program for the specific scope accreditation under Lab Code: 200581-0 to perform Electromagnetic Interference tests according to FCC Part 15 and CISPR 22 requirements. 


6.2 BAND EDGES MEASUREMENT

LIMIT

According to §15.247(c), in any 100 kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator in operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in15.209(a).


Detector mode: Average Polarity: Vertical








Detector mode: Average Polarity: Horizontal




Detector mode: Average Polarity: Vertical








Detector mode: Average Polarity: Horizontal






6.3 PEAK POWER SPECTRAL DENSITY

LIMIT

- 1. For direct sequence systems, the peak power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8dBm in any 3kHz band during any time interval of continuous transmission.
- 2. The direct sequence operating of the hybrid system, with the frequency hopping operation turned off, shall comply with the power density requirements of paragraph (d) of this section.





Measurement of 20dB Bandwidth





6.5 HOPPING CHANNEL SEPARATION

6.8 SPURIOUS EMISSION CONDUCTED MEASUREMENT

LIMIT

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in Section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in Section 15,205(a), must also comply with the radiated emission limits specified in Section 15.209(a) (see Section 15.205(c)).

For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). 


