


# POWER & BLUETOOTH PAIRING

- 1. Press the Power button for 2-3 seconds to turn your BRAVEN READY PRO™ on or off.
- 2. Activate / enable Bluetooth® on your device's settings.
- 3. Speaker automatically enters pairing mode upon powering on. To pair a second device, press and hold the Bluetooth button. Go to your phone or device's Bluetooth® settings and select "BRAVEN READY PRO" from the list.
- **4.** Enter "0000" if asked for a pass code.

Your BRAVEN will remember the last 8 devices it has paired with.

**NOTE:** If your BRAVEN does not have an active Bluetooth® connection and is left on, it automatically powers off after 30 minutes. To restart your BRAVEN you will need to press and hold the power button for 2-3 seconds.

# USING BRAVEN BLUETOOTH® SMART

Download the BRAVEN READY™ Outdoor Speaker App from Google Play or the App Store to power on, pair for audio streaming and customize your listening experience.





# CHARGING YOUR BRAVEN

- Before using your BRAVEN for the first time, charge the unit until the battery indicator light turns off.
- To charge your BRAVEN, plug the included Micro-USB cable into a wall power adapter (not included) or into a powered USB port on a computer. Plug the Micro-USB connector end of the cable into the BRAVEN charging port.
- Once fully charged, your BRAVEN READY PRO<sup>™</sup> has 16 hours of playtime at medium volume.

# CHARGING EXTERNAL DEVICES

Your BRAVEN is designed to charge USB devices that draw from 0.3A - 1A using the full-sized USB port located behind the I/O port cover. To use external charging:

- 1. Turn your BRAVEN on.
- 2. Plug the Micro USB power cable that came with your phone, mp3 player, or other mobile device into the USB port on your BRAVEN.
- 3. Plug the other end of the cable into your mobile device, and it will immediately begin charging.

## **SPEAKERPHONE**

Press the Mic button button on your BRAVEN to answer the call over the speaker. Press the Play / Pause Mic button again to end the call.

# WATERPROOF FEATURES

The BRAVEN READY PRO™ is IP68 waterproof, and is designed to withstand rainfall, waterjets, water splashing, or a dunk in the pool.

**IMPORTANT:** To ensure your BRAVEN READY PRO $^{\mathbb{M}}$  speaker is prepared for use in a wet environment, remove all cable connections and tightly close the I/O port cover on the back of the speaker. If this cover is not securely fastened to the speaker, BRAVEN READY PRO $^{\mathbb{M}}$  will not be waterproof.

# **USING BRAVEN VOICE CONTROL**

To activate Siri or Google Commands with your BRAVEN, short press the Mic button. You can now say commands through your BRAVEN, with your phone at a distance.


# USING TRUEWIRELESS STEREO PAIRING

TrueWireless allows you to wirelessly pair two BRAVEN READY PRO™ speakers in right & left channel audio.

To activate TrueWireless, long press the "battery check button" on the back of both speakers at the same time until a pairing chime emits. Within 30 seconds, a beep will indicate that both speaker have successfully paired.

# **USING THE ACTION MOUNT**

The included Action Mount allows you to attach your BRAVEN READY PRO to most GoPro™ mounting systems. To attach the Action Mount to the READY PRO, align the mount with the holes on the bottom of your BRAVEN. Secure the mount using the included screws and hex wrench.



# RESETTING YOUR BRAVEN

To reset your BRAVEN READY SOLO™ to factory settings, press the Reset button located on the back of your speaker.
