The EIRP = $[(FS*D)^2 / 30]$ mW = 7.27dBm which is within the production variation.

The minimum peak radiated emission for the EUT is $99.8dB\mu V/m$ at 3m in the frequency 2480MHz

The sum of the ratios of the spatially averaged results to the applicable frequency dependent MPE limits = 0.00126/1 + 0.00025/1 = 0.00151 < 1

Since the sum of the MPE ratios for all simultaneously transmitting antennas incorporated in the device is \leq 1.0, the EUT is considered to satisfy MPE compliance for simultaneous transmission operations.

The following RF exposure statement or similar sentence is proposed to be included in the user manual:

"FCC RF Radiation Exposure Statement Caution: This Transmitter must be installed to provide a separation distance of at least 20 cm from all persons."
