# 3.1 DESCRIPTION OF TEST MODES

The EUT has been tested under engineering test mode condition and the EUT staying in continuous transmitting mode.

This uncertainty represents an expanded uncertainty expressed at approximately the 95% confidence level using a coverage factor of k=2.

The measured result is above (below) the specification limit by a margin less than the measurement uncertainty; it is therefore not possible to state compliance based on the 95% level of confidence. However, the result indicates that compliance (non-compliance) is more probable than non-compliance) with the specification limit.



For devices operating above 900 MHz, the emission shall be no wider than 0.5% of the center frequency. Bandwidth is determined at the points 20 dB down from the modulated carrier.

# TEST PROCEDURE

- 1. Place the EUT on the table and set it in transmitting mode.
- 2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
- 3. Set center frequency of spectrum analyzer = operating frequency.
- 4. Set the spectrum analyzer as RBW, VBW=1MHz, Span = 0Hz, Adjust Sweep = 20ms
- 5. Repeat above procedures until all frequency measured were complete.



# TEST PROCEDURE

- 1. The EUT is placed on a turntable, which is 0.8m or 1.5m above ground plane.
- 2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
- 3. EUT is set 3m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emissions.
- 4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- 5. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- 6. Set the spectrum analyzer in the following setting as:

Below 1GHz:

RBW=100kHz / VBW=300kHz / Sweep=AUTO

Above 1GHz:

(a) PEAK: RBW=VBW=1MHz / Sweep=AUTO


(b) AVERAGE: RBW=1MHz / VBW=10Hz / Sweep=AUTO

7. Repeat above procedures until the measurements for all frequencies are complete.



#### Below 30MHz




#### Below 1 GHz





# 6.5 POWERLINE CONDUCTED EMISSIONS

#### <u>LIMIT</u>

For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). The limits at specific frequency range is listed as follows:
