## 2. RF Exposure evaluation for FCC

### 2.1. Assessment procedure

According to 447498 D01 General RF Exposure Guidance v06

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq$  50 mm are determined by:

$[(\text{max. power of channel, including tune-up tolerance, mW})/(\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}] \leq 3.0$  for 1-g SAR and  $\leq 7.5$  for 10-g extremity SAR, where:

f(GHz) is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation

The result is rounded to one decimal place for comparison

#### Estimtion Result:

Worse case is as below: [2480 MHz, -1.18 dBm, (0.762 mW) output power]

$(0.762/5) \cdot [\sqrt{2.480(\text{GHz})}] = 0.24 < 3.0$  for 1-g SAR

Then SAR evaluation is not required.
