

## 5 SAR Evaluation

### 5.1 RF Exposure Compliance Requirement

#### 5.1.1 Standard Requirement

According to KDB447498D01 General RF Exposure Guidance v06

##### 4.3.1. Standalone SAR test exclusion considerations

Unless specifically required by the published RF exposure KDB procedures, standalone 1-g head or body and 10-g extremity SAR evaluation for general population exposure conditions, by measurement or numerical simulation, is not required when the corresponding SAR Exclusion Threshold condition, listed below, is satisfied.

#### 5.1.2 Limits

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq 50$  mm are determined by:

$$\left[ \frac{\text{(max. power of channel, including tune-up tolerance, mW)}}{\text{(min. test separation distance, mm)}} \right] \cdot \sqrt{f(\text{GHz})} \leq 3.0$$
 for 1-g SAR and  $\leq 7.5$  for 10-g extremity SAR, where

$f(\text{GHz})$  is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation<sup>17</sup>

The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is  $\leq 50$  mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is  $< 5$  mm, a distance of 5 mm is applied to determine SAR test exclusion

#### 5.1.3 EUT RF Exposure

The Max. power (including tune-up tolerance) is 2.25 dBm on the highest channel 2.48 GHz (\*)  
 2.25 dBm logarithmic terms convert to numeric result is nearly 1.68 mW

According to the formula. calculate the test exclusion thresholds:

$$\text{General RF Exposure} = \frac{\text{(Max. Power of channel, including tune-up tolerance, mW)} * \sqrt{f(\text{GHz})}}{\text{(min. test separation distance, mm)}}$$

$$\text{General RF Exposure} = (1.68 \text{ mW} / 5 \text{ mm}) * \sqrt{2.48 \text{ GHz}} = 0.53 \tag{1}$$

SAR requirement:

$$S = 3.0 \tag{2}$$

$$(1) < (2)$$

So the SAR report is not required.
