1 GENERAL

1.1 Purpose

The purpose of this report is to demonstrate compliance with Part 15 Subpart C of the FCC's Code of Federal Regulations and Industry Canada's Radio Standards Specification RSS-210.

1.2 Product description

The Ultraclenz, LLC models FAS1527-00, FAS1527-01, FAS1527-02 are part of the UltraClenz' patient safeguard system which monitors health workers' sanitation in hospitals. The equipment is a badge that incorporates a 2.4 GHz wireless transceiver and a 125 kHz receiver. The models FAS1527-00, FAS1527-01, FAS1527-02 are identical except for the enclosure color.

1.3 Test Methodology and Considerations

The model FAS1527-00 was tested in full and was deemed representative of all the models listed. The unit was powered via battery. The EUT was evaluated for radiated emissions in three orthogonal orientations corresponding to the XY, XZ and YZ planes. The 2.4 GHz radio was continuously pulsing during the evaluation. The average levels were calculated using a duty cycle correction factor of 0.864 % as defined in the equipment theory of operation.

The unintentional emissions evaluations is documented separately in a verification report.

2.2 Laboratory Accreditations/Recognitions/Certifications

2.3 Radiated & Conducted Emissions Test Site Description

2.3.1 Semi-Anechoic Chamber Test Site

The EMC radiated test facility consists of an RF-shielded enclosure. The interior dimensions of the indoor semi-anechoic chamber are approximately 48 feet (14.6 m) long by 36 feet (10.8 m) wide by 24 feet (7.3 m) high and consist of rigid, 1/8 inch (0.32 cm) steel-clad, wood core modular panels with steel framing. In the shielded enclosure, the faces of the panels are galvanized and the chamber is self-supporting. 8-foot RF absorbing cones are installed on 4 walls and the ceiling. The steel-clad ground plane is covered with vinyl floor.

The turntable is driven by pneumatic motor, which is capable of supporting a 2000 lb. load. The turntable is flushed with the chamber floor which it is connected to, around its circumference, with a continuous metallic loaded spring. An EMCO Model 1050 Multi-device Controller controls the turntable position.

A pneumatic motor is used to control antenna polarizations and height relative to the ground. The height information is displayed on the control unit EMCO Model 1050.

The control room is an RF shielded enclosure attached to the semi-anechoic chamber with two bulkhead panels for connecting RF, and control cables. The dimension of the room is 7.3 m x 4.9 m x 3 m high and the entrance doors of both control and conducted rooms are 3 feet (0.91 m) by 7 feet (2.13 m).

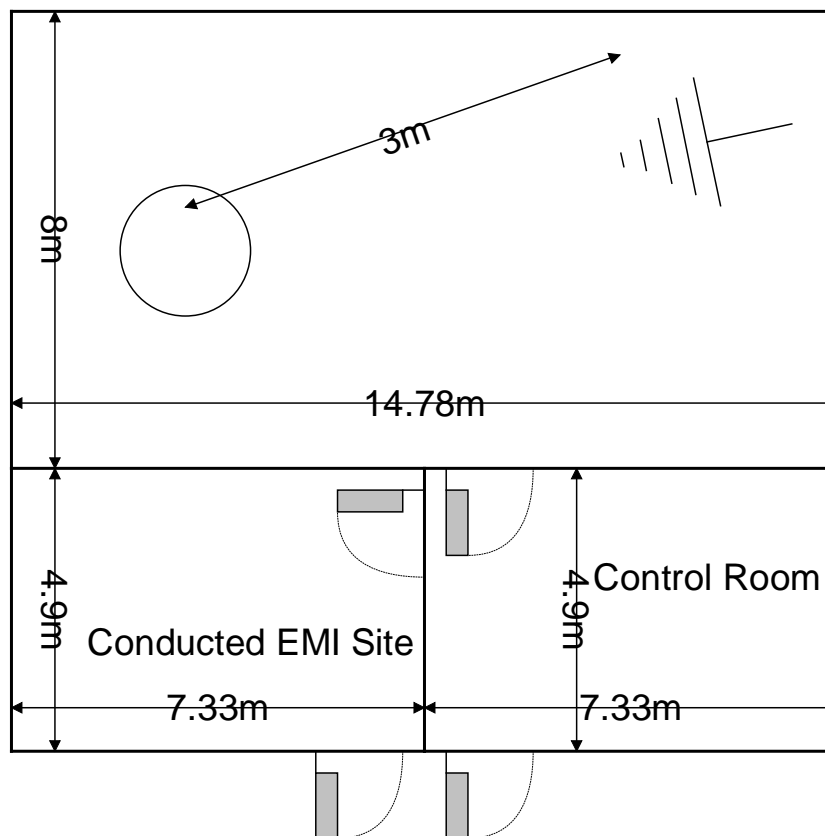


Figure 2.3.1-1: Semi-Anechoic Chamber Test Site

A diagram of the Semi-Anechoic Chamber Test Site is shown in Figure 2.3.1-1 below:

2.3.2 Conducted Emissions Test Site Description

The dimensions of the shielded conducted room are 7.3 x 4.9 x 3 m³. As per ANSI C63.4 2003 requirements, the data were taken using two LISNs; a Solar Model 8028-50 50 Ω /50 μ H and an EMCO Model 3825, which are installed as shown in Photograph 3. For 220 V, 50 Hz, a Polarad LISN (S/N 879341/048) is used in conjunction with a 1 kVA, 50 Hz/220 V EDGAR variable frequency generator, Model 1001B, to filter conducted noise from the generator.

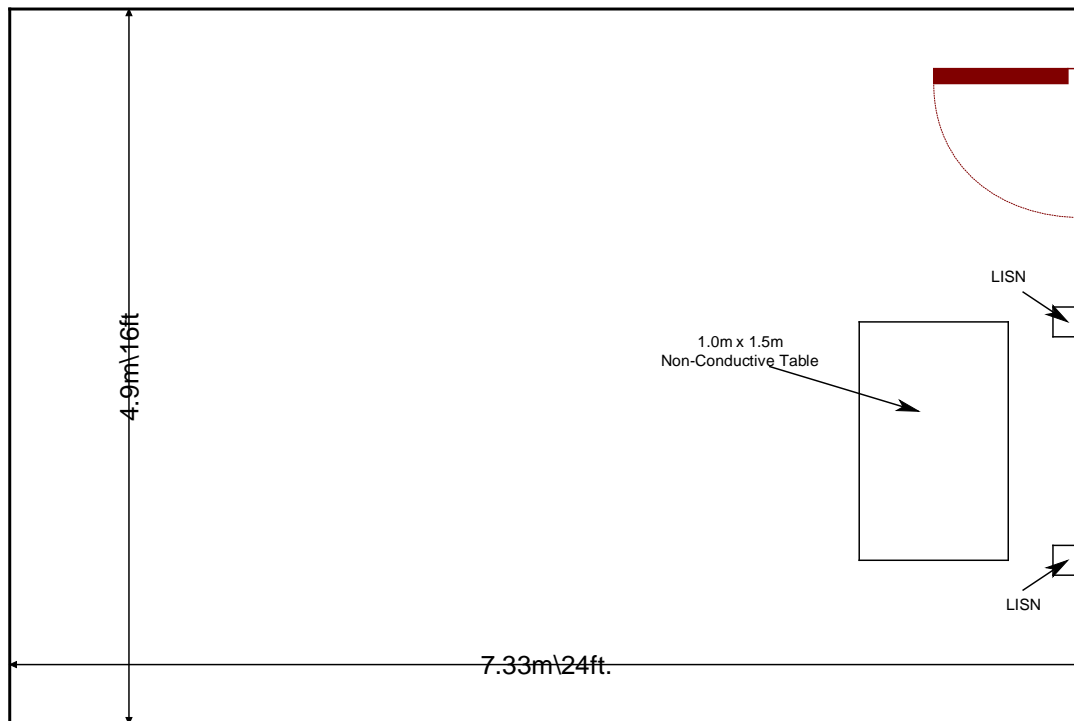


Figure 2.3.2-1: AC Mains Conducted EMI Site

A diagram of the room is shown below in figure 2.3.2-1:

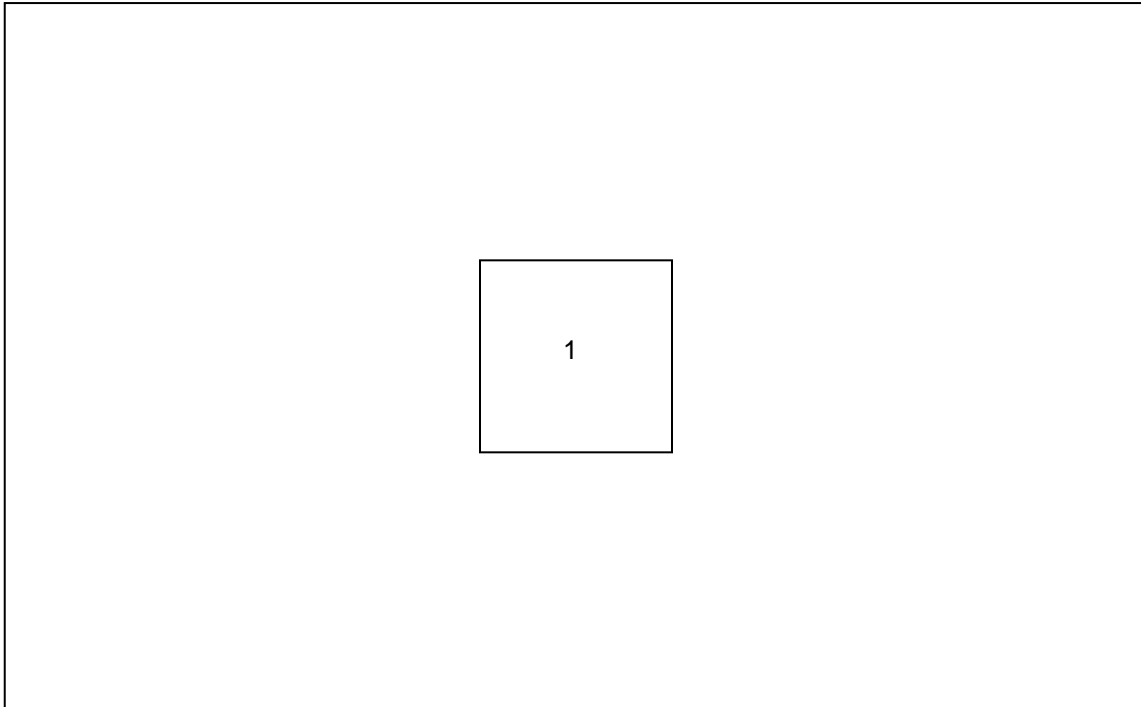

7 SUMMARY OF TESTS

Along with the tabular data shown below, plots were taken of all signals deemed important enough to document.

7.1 Antenna Requirement – FCC: Section 15.203

The FAS1527-00 uses an internal 6.3 dBi PCB inverted-F antenna, thus meeting the requirements of 15.203.

7.2 20dB / 99% Bandwidth: FCC Section 15.215, IC RSS-Gen 4.6.1

7.2.1 Measurement Procedure

The EUT was rotated through 360° and the receive antenna height was varied from 1m to 4m so that the maximum radiated emissions level would be detected.

The spectrum analyzer span was set to 2 to 5 times the estimated bandwidth of the emission. The RBW was to $\geq 1\%$ to 5% of the estimated emission bandwidth. The trace was set to max hold with a peak detector active. The Delta function of the analyzer was utilized to determine the 20 dB bandwidth of the emission.

The 99% occupied bandwidth was measured with the spectrum analyzer span set to fully display the emission, including the emissions skirts. The RBW was greater or equal to 1% of the span. The occupied 99% bandwidth was measured by using a delta marker at the lower and upper frequencies leading to 0.5% of the total power.

7.2.2 Measurement Results

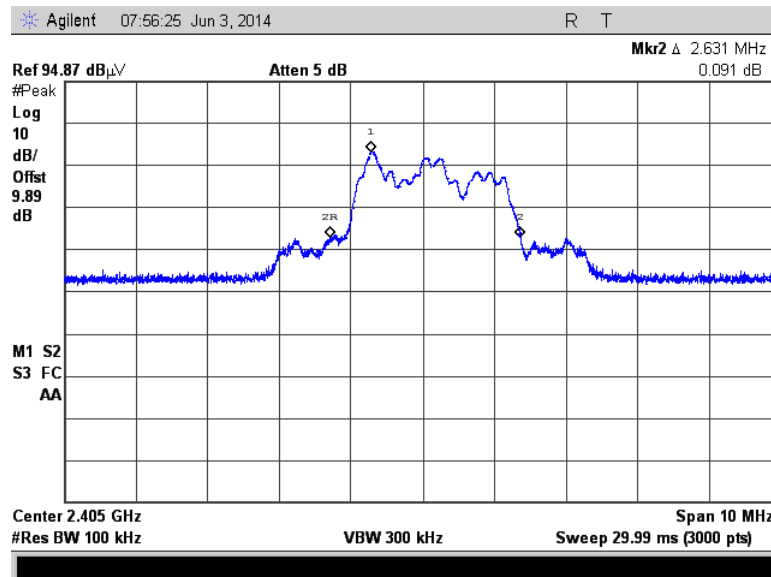


Figure 7.2.2-1: 20dB BW

Results are shown below in Table 7.2.2-1 and Figures 7.2.2-1 through 7.2.2-2

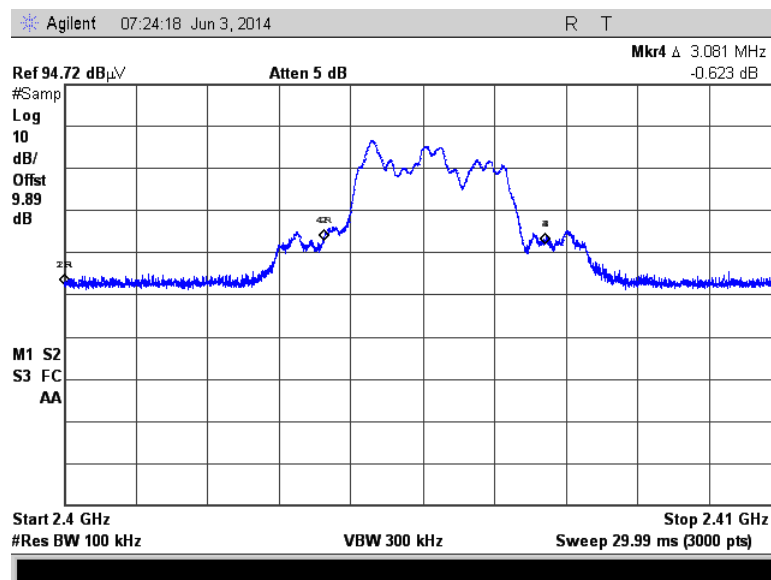


Figure 7.2.2-2: 99% OBW

7.3 Radiated Spurious Emissions - FCC Section 15.249 (a); IC: RSS-210 A2.9

7.3.1 Measurement Procedure

Radiated emissions tests were made over the frequency range of 30MHz to 26GHz, 10 times the highest fundamental frequency.

The EUT was rotated through 360° and the receive antenna height was varied from 1m to 4m so that the maximum radiated emissions level would be detected. For frequencies below 1000MHz, quasi-peak measurements were made using a resolution bandwidth RBW of 120 kHz and a video bandwidth VBW of 300 kHz. For frequencies above 1000MHz, peak and average measurements made with RBW and VBW of 1 MHz and 3MHz respectively.

The unit was continuously pulsing during the evaluation. A Duty Cycle Correction of 0.864% corresponding to -41.27 dB was applied to the peak measurements for the average results. The justification of the duty cycle is provided in the customer's theory of operation.

7.3.2 Measurement Results

Radiated spurious emissions found in the band of 30MHz to 26GHz are reported in the Table 7.3.2-1 below.

Note:

- The fundamental emissions measurements were measured using a resolution bandwidth of 1 MHz with the field strength integrated over the 99% occupied bandwidth.
- All emissions above 4810 MHz were attenuated below the permissible limits and the noise floor of the measurement equipment.

Margin: $54\text{dBuV/m} - 4.89\text{ dBuV/m} = 49.1\text{ dB}$
