



## How to use summary

1. Attach the selected **wish™** Technology Head to the Handset
2. Attach the matching Treatment Capsule to the Technology Head
3. Press the ON button and adjust the speed control.
4. **Treat.** Gently press the Handset with the Treatment Capsule onto the treatment area in circular movements.
5. **Repeat.** Repeat the treatments as suggested.

### IMPORTANT!

Consult a doctor or medical professional any other aesthetic procedures that you have undergone might cause any uncertainty regarding potential side effects.

### IMPORTANT!

The **wish™** Handset is designed to be stored in the charger when not in use. It is recommended to charge the device for at least 24 hours before initial use.

### IMPORTANT!

Do not submerge or douse the charger in water!

## Appendix A - Incompatible medications

Do not use **wish™** if you are taking medication for the following conditions.

- Medicines for cancer
- Medicines for heart or blood pressure problems
- Medicines for anxiety, depression and schizophrenia, insomnia and other Mental health conditions
- Medicines for skin conditions such as acne or psoriasis
- Medicines to treat bacterial, fungal or viral infections
- Medicines for pain relief and swelling, including inflammatory and rheumatoid conditions
- Medicines to treat allergies
- Medicines to treat or prevent malaria
- Medicines for epilepsy
- Medicines for stomach problems

Some medicines or products for these conditions may cause photosensitivity. Photosensitivity is a skin reaction that happens when you are exposed to light.


Problem	Possible Causes	Solution
<b>wush™</b> system cannot be activated	Handset battery is empty	Place the Handset into the charge for 24 hrs
	Battery charger electric plug is not connected to electrical outlet and therefore the battery is not charged	Connect the electric plug to an electrical outlet and allow the battery to be recharged for 24 hrs
	Technology Head is not attached to matching Treatment Capsule	Attach the compatible Treatment Capsule to the matching Technology Head (please review page 9)
Treatment suddenly paused	Accidentally pressed the ON/OFF button	Press ON/OFF button again to resume treatment




To increase speed level, press the right speed control button ►

To decrease speed level, press the left speed control button ◀




## 4. Operating instructions

Attach the technology head to the handset

2




Twist the technology head clockwise until you hear a "click"

3



Open the appropriate Treatment Capsule

4



Attach the treatment capsule to the technology head, and remove the plastic cup from the capsule

5



Press the ON / OFF button once and adjust the speed using the control buttons

6



Gently press the treatment capsule onto the desired treatment area and start making clockwise circular movements

After completion of treatment, detach the used treatment capsule and dispose. The treatment capsules are designed for one-time use only.

### Electrical warnings

#### Do not

- use if damage is found e.g. cracked case, handset, cracked or badly chipped Technology Heads, broken charger. Internal parts contain energy levels and voltages that are hazardous

- coil the power cable around the power supply charger during storage; this can lead to cable damage and early failure

- pull the power cable tight, bend it through very sharp angles or wrap it around the unit for storage, this may cause cable damage and early cable failure

- use if the power supply charger or the handset become too hot to touch

- apply excessive force to the buttons or display

- dismantle; **wush™** contains no user serviceable parts and internal energy levels and voltages are hazardous

- use a power supply or any other accessory unless they are specifically approved and supplied for use with **wush™**

#### Do

- Keep sharp objects away from the buttons

- Keep away from mouth and eyes

- Disposal of Treatment Capsules should be in accordance with any federal, state or local regulations

- Use of accessories, which are not approved, may be dangerous.

- Check that the voltage rating marked on the rating plate of the **wush™** corresponds to the actual supply voltage.

## 11. Warnings and safety information

wish™ is not suitable for everyone.

Read the following warnings carefully to check if it is suitable for you and always keep these instructions handy for future reference.

### Safety Instructions

wish™ Handset can only be used with genuine wish™ interchangeable Technology Heads and wish™ disposable Treatment Capsules

### When not to use

#### **DO NOT USE:**

- on children or allow children to use this product, it is not a toy.
- if you are under the age of consent in your country
- if you are pregnant
- for at least 24 hours after heavy drinking

### Medical warnings

If you have a medical condition or are taking any of the medicines described below, wish™ is not suitable for you.

**Do not use** if you have any of the listed conditions:

- heart disease
- pacemaker or internal defibrillator
- metal implants in the treatment area. Dental fillings or implants are not a concern
- skin cancer or a history of skin cancer – premalignant moles
- impaired immune system
- any active skin condition in the treatment area – e.g. cold sores, psoriasis, eczema or rash

- herpes Simplex – any condition stimulated by heat
- history of keloid scarring, abnormal healing of a wound or very fragile skin
- diabetes – diabetics are more prone to skin ulceration, poor skin healing and dry sensitive skin
- kidney disease – there is increased likelihood of skin bruising and medication is likely to be contraindicated
- any surgical procedures such as laser resurfacing or deep chemical peeling with the treatment area within the last 3 months or in the process of healing from such procedures
- any permanent dermal fillers within the treatment area. If you have temporary dermal fillers in the treatment area, please consult your doctor before starting treatment
- current use of medications, herbal preparations, vitamins or food supplements that cause your skin to become fragile or very dry

This is not an exhaustive list, if in doubt, please seek medical attention.

If you have a medical condition or you are taking medicines and are unsure about using wish™, seek medical attention.

Once the matching Technology Head and Treatment Capsules are attached to the fully charged Handset, you can begin your wish™ treatment. Press on the ON / OFF button to activate the device and immediately, vibrations will be emitted and a humming sound will be heard. The clock on the LCD display will start to count down on the treatment time.

**NOTE:** Light will be emitted for the BlueV ( Blemish Reduction) and Red Light ( Rejuvenation) treatments.

**NOTE:** Wish is waterproof, and is designed to be used in the shower. However, using the device submerged in water or directly under running water may reduce the effect of the treatment.

Gently press the Treatment Capsule onto the skin and you will feel the vibrations. Start by making circular movements clockwise.

### PAUSE option

- 1. Pause** - the Handset can be paused during treatment by pressing the ON/ OFF button, the remaining treatment sequence will be saved in device memory.
- 2. Resume** - the Handset can be reactivated by pressing the ON/ OFF button and the device will automatically resume the treatment with the remaining sequence.

### Treatment Completion

- 1. Alert** - a beep will be heard after half of the treatment session is completed.
- 2. Completion** - a second and final beep will be heard when the treatment session is completed. The clock display will reset to 0.

### **IMPORTANT!**

Be sure to return the Handset to the charger after each use, The Wish System is specifically designed to be stored in the charger for extended periods of time without harming the battery

## 5. Frequency of use

### Rejuvenation Treatment

- Up to twice a week

### Anti Aging Treatment

- Up to twice a week

### Blemish Reduction (BlueV)

- For optimal results, use the BlueV in combination with the Rejuvenation technology
- Daily application of the BlueV and Rejuvenation treatment for 10 days: twice a day, morning and night
- Begin your treatment cycle with the Rejuvenation Technology Head & the Calmink Milk Capsule  
After 12 Hours use the BlueV Technology Head with the Calming Milk Capsule
- Once you have noticed an improvement in skin blemish, follow up treatments should be applied up to twice a week according to your skin condition and necessity.

### Microdermabrasion

- Up to twice a week

## 6. Getting ready for a treatment

The handset charger should be connected to a power outlet for at least 24 hours to fully charge the handset prior to initial use.

Be sure that the handset is fully charged and ready to use.

### Setting up **wish™**

**wish™** consists of four parts;  
handset charger, handset, technology head and treatment capsule.

Each time you use **wish™**, please inspect all parts for damage. If damage is found it should not be used.

Place the charger on a firm, flat surface.

### Preparations

1. Read - this instruction manual thoroughly
2. Prepare - the treatment area - remove all jewelry on or near the treatment area, for example - earrings, necklaces etc.
3. Clean - the treatment area - remove all make up and be certain that your skin is clean and dry.

## 10. Possible adverse reactions

Some people will experience slight discomfort (heat or redness of the skin) when using **wish™** - this is normal. You may feel heat and a slight itch during the Rejuvenation (LED Red light) or Blemish Reduction (LED Blue light) treatments, possibly followed by localized redness in the skin. This feeling ceases at the end of the treatment. Cool the affected area with pure aloe vera gel. Or slight tingling during the Anti-aging treatment (micro-current). This type of reaction usually disappears within 24 hours and is not a side effect that needs any special action. Apply fragrance free moisturizer and wear SPF30 sun lotion as a daily regimen. Adverse reactions are usually immediate or appear within 24 hours. In rare cases they may take up to 72 hours to appear.

### Adverse reactions and what to do if you get them

Effect	What to do if you get them
Strong pain in the area being treated	Stop treatment immediately, cool the affected area with cooling gel packs and apply Biafine emulsion or other known over the counter emulsions used for skin calming. Seek medical attention.
Itching of the treated area	Cool the skin with cooling gel packs and apply Biafine emulsion or other known over the counter emulsions used for skin calming. If itching continues past the first 24 hours, seek medical attention.
Strong pain in the area being treated	Cool the affected area with cooling gel packs, apply Biafine emulsion or other known over the counter emulsions used for skin calming. If there is no improvement after a further 24 hours, seek medical attention.
Blistering or burning of the skin	Stop the treatment immediately, cool the area with cooling gel packs. Apply Biafine emulsion or other known over the counter emulsions used for skin calming. Seek immediate medical attention.
Swelling and/or bruising	Stop the treatment immediately, cool the area with cooling gel packs. Apply Biafine emulsion or other known over the counter emulsions used for skin calming. Protect from sunlight for two weeks. If swelling continues after 48 hours, seek medical attention.
Changes to the pigmentation (colour) of the skin in the area treated	Stop treatment immediately and seek medical attention. Moisturise with fragrance-free moisturiser and avoid exposure to sunlight. Wear SPF30 sun lotion. Your skin pigment should return to normal in time.

## 8. Aftercare

After treatment, your skin should feel different and refreshed. We recommend to leave the nourishing serums on the treated area for at least 20 minutes so that the skin can further absorb the serum essence. Afterwards, simply wash or wipe off the excess serum with warm water or moist cloth.

Avoid exposing the treated area to the sun for at least 24 hours after the treatment. Protect the treated areas exposed to the sun with SPF 30 sun lotion throughout the course of treatment and for two weeks after your last treatment.

### DO NOT:

\* Sunbathe, or use a Tanning Bed or fake tan during treatment and for at least two weeks after the last treatment.

\* Use bleaching creams or perfumed products for at least 24 hours after treatment. The above may cause irritation in the treated areas

## 9. Cleaning **wish™**


Detach the Technology Head from the Handset and clean both parts under running water. Pat dry the cleaned parts with a clean and dry cloth.

Place the Handset into the charger after use.







## 7. **wish™** Treatments

### Rejuvenation Treatment

Collagen and Elastin breakdown are the main factors in aging skin. The body naturally reduces the production of collagen as we age from 30s onwards.

With the reduced levels of collagen, the skin becomes less supple and elastic. This results in enlarged pores, and an increase in fine lines, wrinkles.

To reverse the effects of aging skin, Red Light or LED technology is widely accepted to be the principle treatment methodology. Non-invasive and pain free, Red Light technology does not injure the skin or lead to any scarring and is therefore safe for home use purposes.

Red Light can stimulate fibroblast cells in skin to produce collagen and elastin. With increased production of collagen and elastin, the skin regains a more supple and youth appearance.
