### 2.1. General description:

The Wish is cordless multi-application aesthetic device. Wish features five switchable technology heads. Between the hand piece and the Treatment Capsules there is RFID communications. On the hand piece the RFID is implemented by TI chip TRF7960. The interface is through 3 push buttons and LCD display.

The Wish unit has 3 possible configurations: models A, B, C. The difference between all the configurations are presented below. The models A and B are powered from Ni-MH battery 2.4VDC; the model C is powered from interchangeable 2x1.2V or 1.5V.

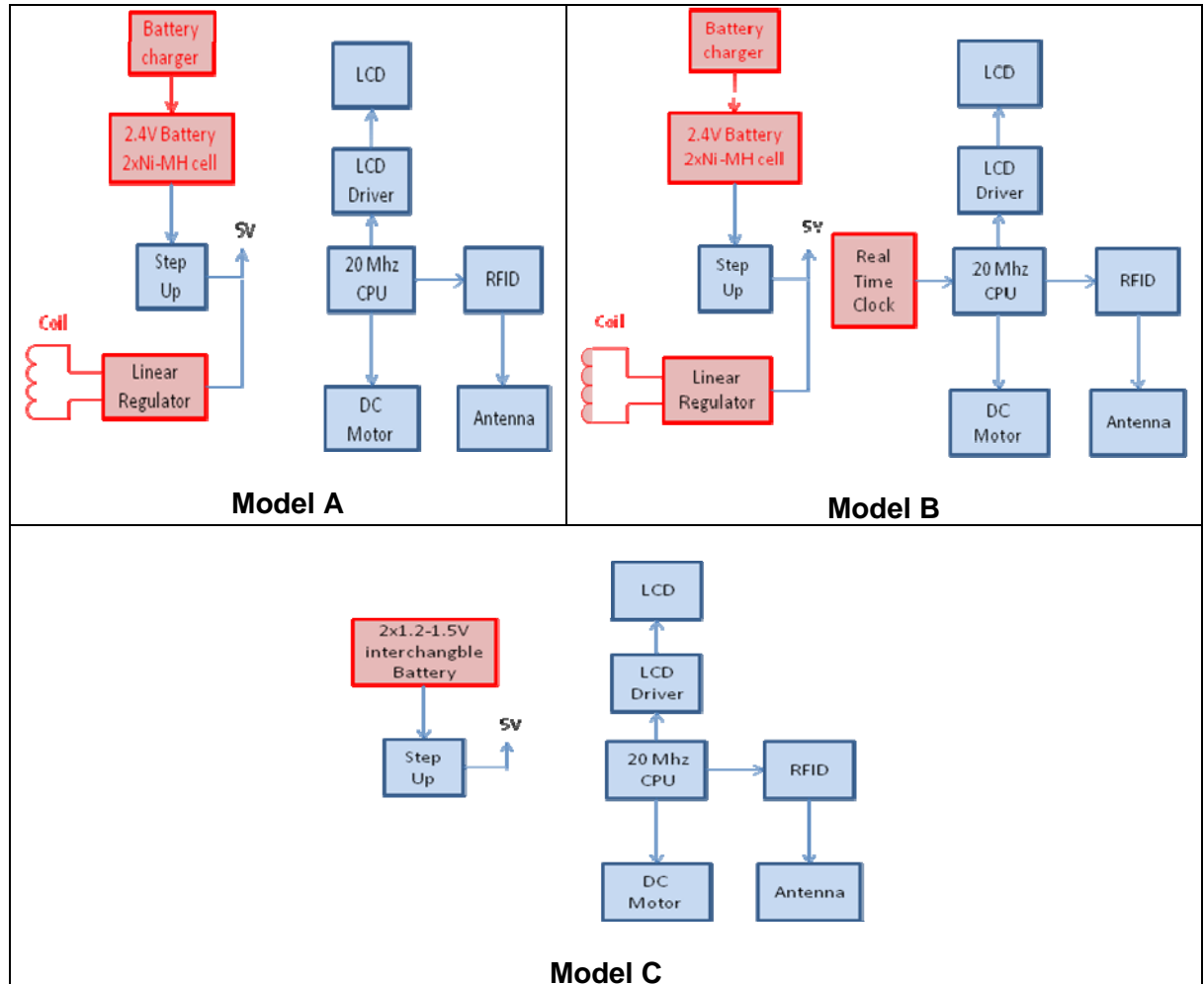

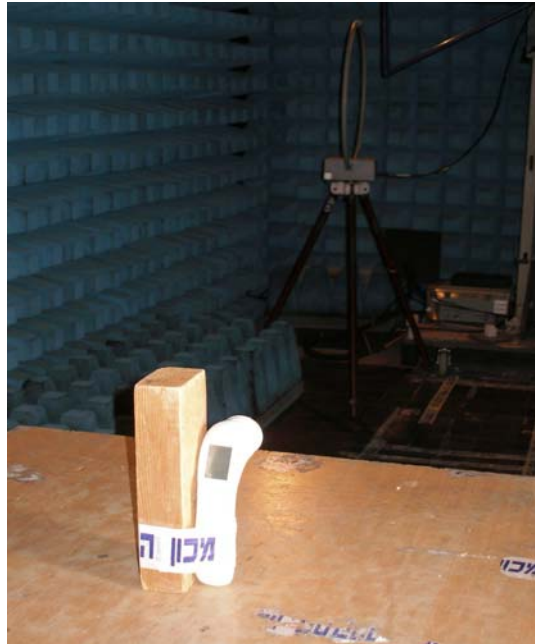

# 3. **Measurements, examinations and derived results**

## 3.1. *Location of the Test Site:*

Preliminary radiated test was conducted at the EMC laboratory of the Standards Institution of Israel in Tel-Aviv.

The final radiated emission test was conducted in an Open Area Test Site located at Kibbutz Native Halamed Hai in Emek HaEla, Israel.

## 3.2. *Test condition:*

Temperature: 24°C. Humidity: 63 %. Atmospheric pressure: 1012 mbar.

## 3.3. *Initial visual check and functional test:*

Initial visual check and brief built- in- test of the EUT was performed before testing.

- No external damages were found.
- The test on the EUT passed successfully.

### **3.4. Radiated emission test.**

#### **3.4.1. General:**

Per FCC Part 15 subpart C Section 15.225, 15.209 and subpart B Section 15.109.

- \* Initial scans were made using a peak detector but still using the appropriate ANSI IF bandwidth.
- \* A tolerance limit was set 10 dB below the specification limit. Levels above the tolerance limit were retested using the Peak and Q. Peak detector.

#### **3.4.2. Preliminary radiated emission tests:**

Preliminary investigation measurements were performed up to tenth harmonic of fundamental in a semi-anechoic chamber at distance 3 meter. The EUT was setup in its typical configuration and operated in its various modes. For each mode of operation the frequency spectrum was monitored. EUT configuration, cable configuration and mode of operation, which produced the maximum level of emission, were documented. A list of frequencies to be tested was prepared.

#### **3.4.3. Final measurements procedure:**

The final radiated emission measurements were performed at the Open Area Test Site at the same (3 m) test distance. The EUT was operated as described above. The EUT was installed on a turn - table. Measurements were performed with active loop antenna at frequencies below 30 MHz and with Biconilog 30 MHz-2 GHz antenna above 30 MHz. The measurements were performed at each frequency that was founded previously at which the signal level was 10 dB below the limit or less. The levels were maximized by rotating turntable through 360° and changing antenna-to-EUT polarization from vertical to horizontal. The worse case result was noted in tables.

#### **3.4.4. Radiated emission test results:**

All received emissions from the EUT were found below FCC Part 15 Subpart B Section 15.109 and Subpart C sections 15.209 and 15.225.

### 3.6. AC main conducted emissions test

Per FCC Part 15 subpart B section 15.107 and subpart C section 15.207.

#### **Test configuration:**

The EUT was placed on a non-metallic table in a shielded room at a height of 80 cm from the floor and 40 cm from the vertical ground plane (wall) of the room.

#### **3.6.1. Test procedure:**

The EUT was operated in charging mode.

First, initial scans were performed. Final measurements were performed at the frequencies where emission exceeded the tolerance limit.

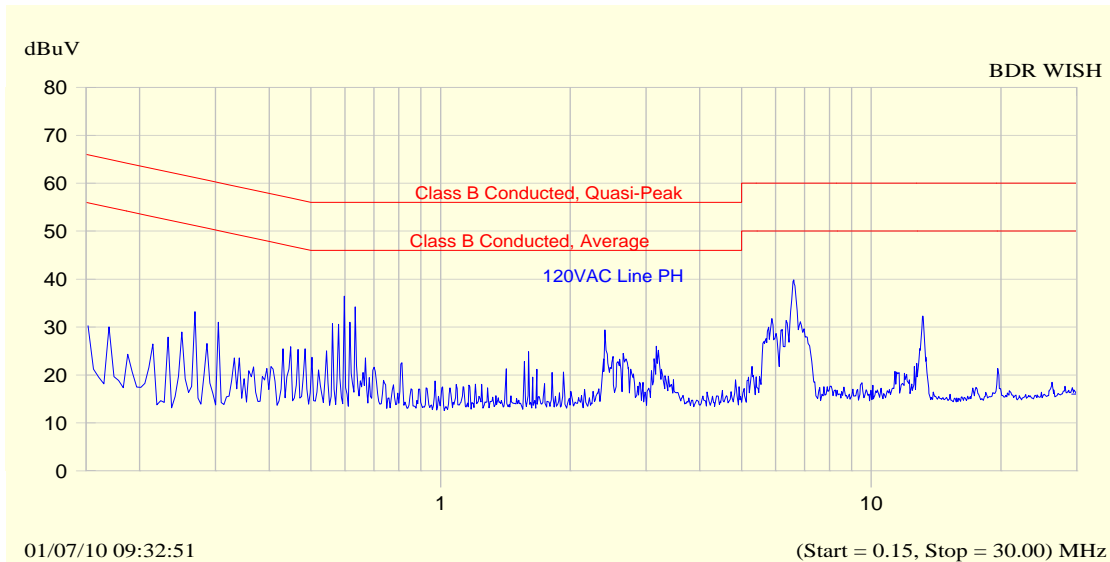

**Plot # 5. Tested line Phase.**



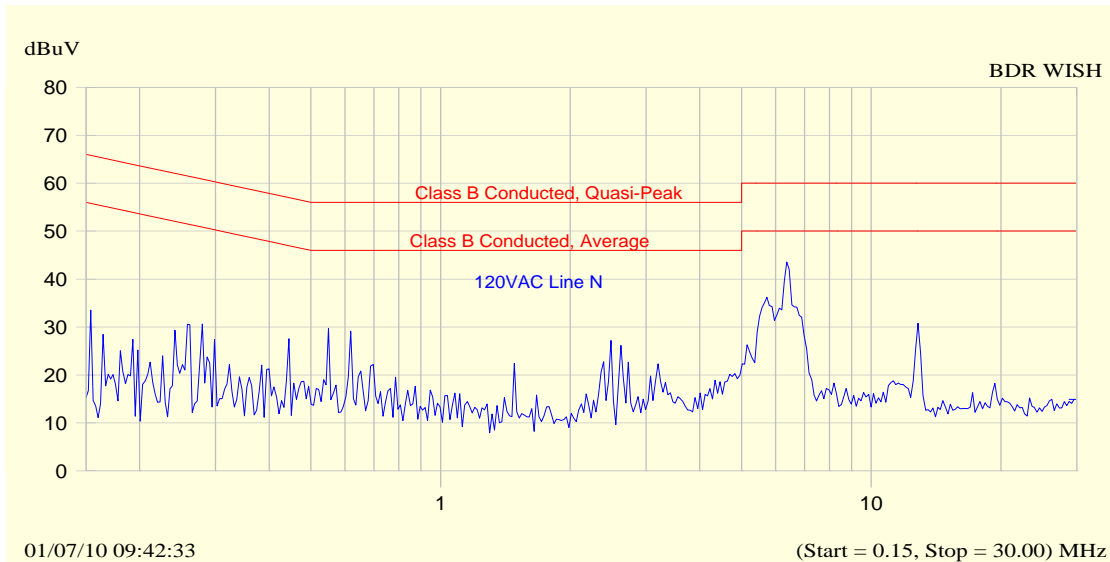

**3.8.1. Test procedure**

The EUT was placed in a climatic chamber and allowed to stabilize at 20°C temperature and battery nominal voltage 2.4VDC for at list 15 min. The reference carrier frequency was taken. The temperature of climatic chamber was varied from -20°C to +50°C. Measured changes of frequencies were noted in table #4.

**3.8.2. Requirements:**

The frequency tolerance of the carrier signal shall be maintained within +/- 0.01% of the operating frequency (1.356 kHz) over a temperature variation of -20 degrees to +50 degrees C at normal supply voltage, and for a variation in the primary supply voltage from 85% to 115% of the rated supply voltage. For battery operated equipment, the equipment tests shall be performed using a new battery.
