LED Indicator

Medium eartips fit for most of the people, recommend to try it for the first tim

Start to Using



Take out both 2 earbuds then re-insert them back into the case to activate the earphones. Notes: If Earbuds fail to be charged, please charge the case via USB cable(for details, please refer the following step)

How to pair

- 1. Activating the EarBuds
- 2.Take out the EarBuds from the case, they will auto power on and pair with each other.
 3.The master earbud LED light flashes Red and White, and the sub earbud LED light flashes White, the earbuds enter pairing mode
- 4. Search for "C10J" on mobile devices and tap to pair it to both EarBuds

Wearing



Put the Earbuds into ears lightly with mic towards to the front side.

Charging


(a) Charging the Earbuds



Insert the Earbuds into the charging case(Pogo pins should be well-connected)

LED lights will be Red while charging. Once completely charged the lights would turn off

(i) Charging the Case



Note: There are 4 LED lights to show the charging case battery status, its means there is 25%, 50%, 75%, 100% battery in sequence.

Functions

U Power-On

Method 1: Take out the EarBuds from the charging case, it will auto power on. Method 2: Tap the multi-function buttons for 1s



Power-Off

Method 1: Put the EarBuds back into the charging case, it will auto power off. Method 2: Tap the multi-function buttons for 3s



Play the music

Tap the multi-function button to play the music



Play the music

Tap the multi-function button to pause the music



Skip to next song

Tap the multi-function button for 2 times to play next song



Voice Assistant

Tap the multi-fuction button for 3 times to active ate the voice assistant (eg.Siri)



2 Answer/Hang up the call

Tap the multi-function button to answer the call, Tap the button again to hang up.
