

1.3.1 Facilities




2.1 Conducted RF Output Power

2.1.1 Requirement

According to FCC section 2.1046(a), for transmitters other than single sideband, independent sideband and controlled carrier radiotelephone, power output shall be measured at the RF output terminals when the transmitter is adjusted in accordance with the tune-up procedure to give the values of current and voltage on the circuit elements specified in FCC section 2.1033(c)(8).

2.1.2 Test Description

1. Test Setup:



The EUT, which is powered by the Battery, is coupled to the Spectrum Analyzer (SA) and the System Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 500hm; the path loss as the factor is calibrated to correct the reading. The EUT is commanded by the SS to operate at the maximum output power i.e. Power Control Level (PCL) = 5 and Power Class = 4. A call is established between the EUT and the SS.

The Power Meter was just used for the Conducted RF Output Power test of WCDMA Model.








(Plot A1: GSM 850MHz Channel = 128)






(Plot A2: GSM 850MHz Channel = 190)




(Plot A3: GSM 850MHz Channel = 251)






(Plot B1: GSM 1900MHz Channel = 512)

2.2 99% Occupied Bandwidth

2.2.1 Definition

According to FCC section 2.1049, the occupied bandwidth is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers radiated are each equal to 0.5 percent of the total mean power radiated by a given emission.

Occupied bandwidth is also known as the 99% emission bandwidth,


(Plot A: GSM 850MHz Channel = 128)




(Plot B: GSM 850MHz Channel = 190)











(Plot D: GSM 1900MHz Channel = 512)

2.3 Frequency Stability


2.3.1 Requirement

According to FCC section 22.355 and FCC section 24.235, the frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block. According to FCC section 2.1055, the test conditions are:

- (a) The temperature is varied from -30° C to $+50^{\circ}$ C at intervals of not more than 10° C.
- (b) For hand carried battery powered equipment, the primary supply voltage is reduced to the battery operating end point which shall be specified by the manufacture. The supply voltage shall be measured at the input to the cable normally provided with the equipment, or at the power supply terminals if cables are not normally provided.

2.3.2 Test Description

1. Test Setup:



The EUT, which is powered by the DC Power Supply directly, is located in the Temperature Chamber. The EUT is commanded by the System Simulator (SS) to operate at the maximum output power i.e. Power Control Level (PCL) = 5 and Power Class = 4. A call is established between the EUT and the SS via a Common Antenna.

2.3.3 Test Verdict

The nominal, highest and lowest extreme voltages are separately 3.7VDC, 4.2VDC and 3.6VDC, which are specified by the applicant; the normal temperature here used is 25°C. The frequency

2.4 Conducted Out of Band Emissions

2.4.1 Requirement

According to FCC section 22.917(a) and FCC section 24.238(a), the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least 43+10*log(P)dB. This calculated to be -13dBm.

2.4.2 Test Description

See section 2.1.2 of this report.

2.4.3 Test Result

The measurement frequency range is from 30MHz to the 10th harmonic of the fundamental frequency. The lowest, middle and highest channels are tested to verify the out of band emissions.








(Plot A1: GSM 850MHz Channel = 128, 30MHz to 1GHz)




(Plot A1.1: GSM 850MHz Channel = 128, 1GHz to 9GHz)






(Plot A2: GSM 850MHz Channel = 190, 30MHz to 1GHz)




(Plot A2.1: GSM 850MHz Channel = 190, 1GHz to 9GHz)






(Plot A3: GSM 850MHz Channel = 251, 30MHz to 1GHz)




(Plot A3.1: GSM 850MHz Channel = 251, 1GHz to 9GHz)






(Plot B1: GSM 1900MHz Channel = 512, 30MHz to 1GHz)




(Plot B1.1: GSM 1900MHz Channel = 512, 1GHz to 20GHz)






(Plot B2: GSM 1900MHz Channel = 661, 30MHz to 1GHz)

2.5 Band Edge

2.5.1 Requirement

According to FCC section 22.917(b) and FCC section 24.238(b), in the 1MHz bands immediately outside and adjacent to the frequency block a resolution bandwidth of at least one percent of the emission bandwidth (26dB emission bandwidth) of the fundamental emission of the transmitter may be employed.

2.5.2 Test Description

See section 2.1.2 of this report.

2.5.3 Test Result

The lowest and highest channels are tested to verify the band edge emissions.











(Plot B: GSM 850 Channel = 251)






(Plot C: GSM 1900 Channel = 512)



(Plot D: GSM 1900 Channel = 810)






2.6 Transmitter Radiated Power (EIRP/ERP)

2.6.1 Requirement

According to FCC section 22.913, the Effective Radiated Power (ERP) of mobile transmitters and auxiliary test transmitters must not exceed 7Watts, and FCC section 24.232, the broadband PCS mobile station is limited to 2 Watts e.i.r.p. peak power.

2.6.2 Test Description

1. Test Setup:



The EUT, which is powered by the Battery charged with the AC Adapter, is located in a 3m Full-Anechoic Chamber; the cable loss, air loss and so on of the site as factors are pre-calibrated using the "Substitution" method, and calculated to correct the reading.

A call is established between the EUT and the SS via a Common Antenna. The EUT is commanded by the SS to operate at the maximum and minimum output power (i.e. GSM850MHz band Power Control Level (PCL) = 5/19 and Power Class = 4, GSM1900MHz band Power Control Level (PCL) = 0/15 and Power Class = 1), and only the test result of the maximum output power was recorded.

- GSM Maximum RF output power: GSM850 33.39dBm, GSM 1900 28.21dBm, Please refer to section 2.1.3 of this report.
- Step size (dB): 3dB
- Minimum RF power: GSM850 3.2dBm, GSM 1900 0.4dBm.



The Test Antenna is a Bi-Log one (used for 30MHz to 1GHz) or a Horn one (used for above 3GHz), and it's located at the same height as the EUT. The Filters consists of Notch Filters and High Pass Filter.

2.6.3 Test Result

The Turn Table is actuated to turn from 0° to 360° , and both horizontal and vertical polarizations of the Test Antenna are used to find the maximum radiated power. The lowest, middle and highest channels are tested.

The substitution corrections are obtained as described below:

 $A_{SUBST} = P_{SUBST_TX} - P_{SUBST_RX} - L_{SUBST_CABLES} + G_{SUBST_TX_ANT}$

 $A_{TOT} = L_{CABLES} + A_{SUBST}$

Where A_{SUBST} is the final substitution correction including receive antenna gain.

P_{SUBST_TX} is signal generator level,

P_{SUBST RX} is receiver level,

L_{SUBST CABLES} is cable losses including TX cable,

G_{SUBST_TX_ANT} is substitution antenna gain.

A_{TOT} is total correction factor including cable loss and substitution correction

During the test, the data of A_{TOT} was added in the Test Spectrum Analyze, so Spectrum Analyze reading is the final values which contain the data of A_{TOT} .





2.7 Radiated Out of Band Emissions

2.7.1 Requirement

According to FCC section 22.917(a) and section 24.238(a), the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least 43+10*log(P)dB. This calculated to be -13dBm.

2.7.2 Test Description

See section 2.6.2 of this report.

Note: when doing measurements above 1GHz, the EUT has been within the 3dB cone width of the horn antenna during horizontal antenna.

2.7.3 Test Result

The measurement frequency range is from 30MHz to the 10th harmonic of the fundamental frequency. The Turn Table is actuated to turn from 0° to 360°, and both horizontal and vertical polarizations of the Test Antenna are used to find the maximum radiated power. The lowest, middle and highest channels are tested to verify the out of band emissions.
