The worst-case scenario for all measurements is based on the conducted output power measurement investigation results. Output power was measured on QPSK and 16QAM modulations. It was found that QPSK was the worst case. All testing was performed using QPSK modulations to represent the worst case unless otherwise stated. The test results shown in the following sections represent the worst case emission.

Annex A: Measurement Results

A.1 Output Power

A.1.1 Summary

During the process of testing, the EUT was controlled via communication tester to ensure max power transmission and proper modulation.

In all cases, output power is within the specified limits.

A.1.2 Conducted

A.1.2.1 Method of Measurements

The EUT was set up for the max output power with pseudo random data modulation.

These measurements were done at 3 frequencies (bottom, middle and top of operational frequency range) for each bandwidth.

The results below include a correction factor for cable loss that is provided by the customer.

A.1.3 Radiated

A.1.3.1 Description


This is the test for the maximum radiated power from the EUT.

Part 22.913(a) specifies "The ERP of mobile transmitters and auxiliary test transmitters must not exceed 7 watts".


A.1.3.2 Method of Measurement

The measurements procedures in ANSI C63.26 are used.

1. EUT was placed on a 0.8/1.5 meter high non-conductive stand at a 3 meter test distance from the receive antenna. A receiving antenna was placed on the antenna mast 3 meters from the EUT for emission measurements. The receiving antenna shall be varied from 1 to 4m in height above the reference ground. The test setup refers to figure below. Detected emissions were maximized at each frequency by rotating the EUT through 360° and the EUT is manipulated through all orthogonal planes representative of its typical use. The test is carried out with both vertical and horizontal polarization of the receiving antenna. The radiated emission measurements of all transmit frequencies in three channels (High, Middle, Low) were measured with rms detector.



- 2. The EUT is then put into continuously transmitting mode at its maximum power level during the test and the maximum value of the receiver should be recorded as (Pr).
- 3. The EUT shall be replaced by a substitution antenna. The test setup refers to figure below.



In the chamber, a substitution antenna for the frequency band of interest is placed at the reference point of the chamber. An RF Signal source for the frequency band of interest is connected to the substitution antenna with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A power (P_{Mea}) is applied to the input of the





substitution antenna and adjusts the level of the signal generator output until the value of the receiver reach the previously recorded (P_r). The power of signal source (P_{Mea}) is recorded. The test should be performed by rotating the test item and adjusting the receiving antenna polarization.

4. An amplifier should be connected to the Signal Source output port. And the cable should be connected between the Amplifier and the Substitution Antenna.

The cable loss (P_{cl}), the Substitution Antenna Gain (G_a) and the Amplifier Gain (P_{Ag}) should be recorded after test.

The measurement results are obtained as described below:

Power (EIRP) = $P_{Mea} + P_{Ag} - P_{cl} + G_a$

- 5. This value is EIRP since the measurement is calibrated using an antenna of known gain (2.15 dBi) and known input power.
- 6. ERP can be calculated from EIRP by subtracting the gain of the dipole, ERP = EIRP -2.15dBi.

The antenna gain provided by the client may affect the validity of the measurement results in this report, and the client shall bear the impact and consequences arising therefrom.

A.2 Emission Limit


A.2.1 Measurement Method

The measurements procedures in ANSI C63.26 are used. This measurement is carried out in fully-anechoic chamber.


The spectrum was scanned from 30 MHz to the 10th harmonic of the highest frequency generated within the equipment. The resolution bandwidth is set as outlined in Part 22.917. The spectrum was scanned with the mobile station transmitting at carrier frequencies that pertain to low, mid and high channels of WCDMA Band V.

The procedure of radiated spurious emissions is as follows:

1. EUT was placed on a 0.8/1.5 meter high non-conductive stand at a 3 meter test distance from the receive antenna. A receiving antenna was placed on the antenna mast 3 meters from the EUT for emission measurements. The receiving antenna shall be varied from 1 to 4m in height above the reference ground. The test setup refers to figure below. Detected emissions were maximized at each frequency by rotating the EUT through 360° and the EUT is manipulated through all orthogonal planes representative of its typical use. The test is carried out with both vertical and horizontal polarization of the receiving antenna. The radiated emission measurements of all non-harmonic and harmonics of the transmit frequency through the 10th harmonic were measured with peak detector.



- 2. The EUT is then put into continuously transmitting mode at its maximum power level during the test. And the maximum value of the receiver should be recorded as (Pr).
- 3. The EUT shall be replaced by a substitution antenna. The test setup refers to figure below.



In the chamber, a substitution antenna for the frequency band of interest is placed at the





reference point of the chamber. An RF Signal source for the frequency band of interest is connected to the substitution antenna with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A power (P_{Mea}) is applied to the input of the substitution antenna and adjust the level of the signal generator output until the value of the receiver reach the previously recorded (P_r). The power of signal source (P_{Mea}) is recorded. The test should be performed by rotating the test item and adjusting the receiving antenna polarization.

4. The Path loss (P_{pl}) between the Signal Source with the Substitution Antenna and the Substitution Antenna Gain (G_a) should be recorded after test.

A amplifier should be connected in for the test.

The Path loss (P_{DI}) is the summation of the cable loss and the gain of the amplifier.

The measurement results are obtained as described below:

Power (EIRP) = $P_{Mea} - P_{pl} + G_a$

- 5. This value is EIRP since the measurement is calibrated using an antenna of known gain (2.15 dBi) and known input power.
- 6. ERP can be calculated from EIRP by subtracting the gain of the dipole, ERP = EIRP 2.15dBi.

A.2.2 Measurement Limit

Part 22.917 specify that the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least 43 + 10log(P) dB.

A.2.3 Measurement Results

Radiated emissions measurements were made only at the upper, middle, and lower carrier frequencies of WCDMA Band V (826.4MHz, 836.6MHz and 846.6MHz). It was decided that measurements at these three carrier frequencies would be sufficient to demonstrate compliance with emissions limits because it was seen that all the significant spurs occur well outside the band and no radiation was seen from a carrier in one block of the WCDMA Band V into any of the other blocks. The equipment must still, however, meet emissions requirements with the carrier at all frequencies over which it is capable of operating and it is the manufacturer's responsibility to verify this.

All mode of operation were investigated and the worst case configuration results are reported in this section. The range of evaluated frequency is from 9 kHz to 10GHz. Measurement value show only up to 6 maximum emissions noted.

A.3 Frequency Stability

A.3.1 Method of Measurement

Frequency stability is a measure of the frequency drift due to temperature and supply voltage variations, with reference to the frequency measured at +20 °C and rated supply voltage. Two reference points are established at the applicable unwanted emissions limit using a RBW equal to the RBW required by the unwanted emissions specification of the applicable regulatory standard. These reference points measured using the lowest and highest channel of operation shall be identified as F_L and F_H respectively.

In order to measure the carrier frequency under the condition of AFC lock, it is necessary to make measurements with the EUT in a "call mode". This is accomplished with the use of CMU200.

- 1. Measure the carrier frequency at room temperature.
- 2. Subject the EUT to overnight soak at -30°C.
- 3. With the EUT, powered via nominal voltage, connected to the CMU200 and in a simulated call on mid channel of each band, measure the carrier frequency. These measurements should be made within 2 minutes of Powering up the EUT, to prevent significant self-warming.
- 4. Repeat the above measurements at 10°C increments from -30°C to +50°C. Allow at least 1.5 hours at each temperature, unpowered, before making measurements.
- 5. Remeasure carrier frequency at room temperature with nominal voltage. Vary supply voltage from minimum voltage to maximum voltage, in 0.1Volt increments remeasuring carrier frequency at each voltage. Pause at nominal voltage for 1.5 hours unpowered, to allow any self-heating to stabilize, before continuing.
- 6. Subject the EUT to overnight soak at $+50^{\circ}$ C.
- 7. With the EUT, powered via nominal voltage, connected to the CMU200 and in a simulated call on the centre channel, measure the carrier frequency. These measurements should be made within 2 minutes of Powering up the EUT, to prevent significant self-warming.
- 8. Repeat the above measurements at 10°C decrements from +50°C to -30°C. Allow at least 1.5 hours at each temperature, unpowered, before making measurements.
- 9. At all temperature levels hold the temperature to +/- 0.5 ℃ during the measurement procedure.

The frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block. As this transceiver is considered "Hand carried, battery powered equipment" Section 2.1055(d)(2) applies. This requires that the lower voltage for frequency stability testing be specified by the manufacturer. This transceiver is specified to operate with an input voltage of the lower, higher and nominal voltage. Operation above or below these voltage limits is prohibited by transceiver software in order to prevent improper operation as well as to protect components from overstress.

A.4 Occupied Bandwidth

Occupied bandwidth measurements are only provided for selected frequencies in order to reduce the amount of submitted data. Data were taken at the extreme and mid frequency. The table below lists the measured 99% BW. Spectrum analyzer plots are included on the following pages. The measurement method is from ANSI C63.26:

- a) The spectrum analyzer center frequency is set to the nominal EUT channel center frequency. The frequency span for the spectrum analyzer shall be set wide enough to capture all modulation products including the emission skirts.
- b) The nominal IF filter 3 dB bandwidth (RBW) shall be in the range of 1% to 5% of the anticipated OBW, and the VBW shall be set \geq 3 × RBW.
- c) Set the reference level of the instrument as required to prevent the signal amplitude from exceeding the maximum spectrum analyzer input mixer level for linear operation.
- d) Set the detection mode to peak, and the trace mode to max-hold.






WCDMA Band V (99%)-QPSK






Channel 4183-Occupied Bandwidth (99% BW)




WCDMA Band V (99%)-16QAM

Channel 4132-Occupied Bandwidth (99% BW)






Channel 4183-Occupied Bandwidth (99% BW)

A.5 Emission Bandwidth

The emission bandwidth is defined as the width of the signal between two points, one below the carrier center frequency and one above the carrier center frequency, outside of which all emissions are attenuated at least 26 dB below the transmitter power.

The measurement method is from ANSI C63.26:

- a) The spectrum analyzer center frequency is set to the nominal EUT channel center frequency. The span range for the spectrum analyzer shall be wide enough to see sufficient roll off of the signal to make the measurement.
- b) The nominal RBW shall be in the range of 1% to 5% of the anticipated OBW, and the VBW shall be set \geq 3 × RBW.
- c) Set the reference level of the instrument as required to prevent the signal amplitude from exceeding the maximum spectrum analyzer input mixer level for linear operation.
- d) The dynamic range of the spectrum analyzer at the selected RBW shall be more than 10 dB below the target "-X dB" requirement, i.e., if the requirement calls for measuring the -26 dB OBW, the spectrum analyzer noise floor at the selected RBW shall be at least 36 dB below the reference level.
- e) Set spectrum analyzer detection mode to peak, and the trace mode to max hold.






WCDMA Band V-QPSK (-26dBc)






Channel 4183-Emission Bandwidth (-26dBc BW)




WCDMA Band V-16QAM (-26dBc)






Channel 4183-Emission Bandwidth (-26dBc BW)

A.6 Band Edge Compliance

A.6.1 Measurement limit

Part 22.917, Part 24.238 and Part 27.53(h) specify that the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least 43 + 10 log(P) dB.


According to KDB 971168, a relaxation of the reference bandwidth is often provided for measurements within a specified frequency range at the edge of the authorized frequency block/band. This is often implemented by permitting the use of a narrower RBW (typically limited to a minimum RBW of 1% of the OBW) for measuring the out-of-band emissions without a requirement to integrate the result over the full reference bandwidth.







A.7 Conducted Spurious Emission

A.7.1 Measurement Method

The following steps outline the procedure used to measure the conducted emissions from the EUT.

- 1. In measuring unwanted emissions, the spectrum shall be investigated from 30 MHz or the lowest radio frequency signal generated in the equipment, whichever is lower, without going below 9 kHz, up to at least the frequency given below:
 - (a) If the equipment operates below 10 GHz: to the tenth harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower.
 - (b) If the equipment operates at or above 10 GHz: to the fifth harmonic of the highest fundamental frequency or to 100 GHz, whichever is lower.
- 2. Determine EUT transmit frequencies: below outlines the band edge frequencies pertinent to conducted emissions testing.
- 3. The number of sweep points of spectrum analyzer is greater than 2×span/RBW.



Channel 4132: 30MHz -8.49GHz




