## **4.2 DESCRIPTION OF TEST MODES**

The EUT has been tested under its typical operating condition.

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

The Transmitter was operated in the normal operating mode. The TX frequency was fixed which was for the purpose of the measurements.

Test of channel included the lowest and middle and highest frequency to perform the test, then record on this report.

Those data rates (802.11a: 54 Mbps; 802.11n(HT20): MCS0; 802.11ac(VHT20): MCS0; 802.11n(HT40): MCS0; 802.11ac(VHT40): MCS0; 802.11ac(VHT80): MCS0;) were used for all test.

Pre-defined engineering program for regulatory testing used to control the EUT for staying in continuous transmitting and receiving mode is programmed.

## **5.2 EQUIPMENT**

Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with preselectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."


Measurement Uncertainty for a level of Confidence of 95%



#### 7 SETUP OF EQUIPMENT UNDER TEST

## 7.1 RADIO FREQUENCY TEST SETUP

The WLAN component's antenna ports(s) of the EUT are connected to the measurement instrument per an appropriate attenuator. The EUT is controlled by PC/software to emit the specified signals for the purpose of measurements.



## 7.2 RADIO FREQUENCY TEST SETUP

The test site semi-anechoic chamber has met the requirement of NSA tolerance 4 dB according to the standards: ANSI C63.10. The test distance is 3m. The setup is according to the requirements in Section 13.1.4.1 of ANSI C63.10-2013 and CAN/CSA-CEI/IEC CISPR 22.

#### Below 30MHz:

The EUT is placed on a turntable 0.8 meters above the ground in the chamber. 3 meter away from the antenna (loop antenna). The Antenna should be positioned with its plane vertical at the specified distance from the EUT and rotated about its vertical axis for maximum response at each azimuth about the EUT. The center of the loop shall be 1 m above the ground. For certain applications, the loop antenna plane may also need to be positioned horizontally at the specified distance from the EUT.


#### Above 30MHz:

The EUT is placed on a turntable 0.8 meters above the ground in the chamber, 3 meter away from the antenna. The maximal emission value is acquired by adjusting the antenna height, polarisation and turntable azimuth. Normally, the height range of antenna is 1 m to 4 m, the azimuth range of turntable is 0° to 360°, and the receive antenna has two polarizations Vertical (V) and Horizontal (H).

#### Above 1GHz:

(Note: the FCC's permission to use 1.5m as an alternative per TCBC Conf call of Dec. 2, 2014.) The EUT is placed on a turntable 1.5 meters above the ground in the chamber, 3 meter away from the antenna. The maximal emission value is acquired by adjusting the antenna height, polarisation and turntable azimuth. Normally, the height range of antenna is 1 m to 4 m, the azimuth range of turntable is 0° to 360°, and the receive antenna has two polarizations Vertical (V) and Horizontal (H).


(a) Radiated Emission Test Set-Up, Frequency Below 30MHz



(c) Radiated Emission Test Set-Up, Frequency above 1000MHz






## 7.3 CONDUCTED EMISSION TEST SETUP

The mains cable of the EUT (maybe per AC/DC Adapter) must be connected to LISN. The LISN shall be placed 0.8 m from the boundary of EUT and bonded to a ground reference plane for LISN mounted on top of the ground reference plane. This distance is between the closest points of the LISN and the EUT. All other units of the EUT and associated equipment shall be at least 0.8m from the LISN.


Ground connections, where required for safety purposes, shall be connected to the reference ground point of the LISN and, where not otherwise provided or specified by the manufacturer, shall be of same length as the mains cable and run parallel to the mains connection at a separation distance of not more than 0.1 m.

According to the requirements in Section 13.1.4.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz using CISPR Quasi-Peak and average detector mode.

# 8 TEST REQUIREMENTS

## 8.1 BANDWIDTH MEASUREMENT

## 8.1.1 Applicable Standard

According to FCC Part 15.407(a)(1) for UNII Band I According to FCC Part 15.407(a)(3) for UNII Band III According to 789033 D02 Section II(C) According to 789033 D02 Section II(D) According to RSS-Gen 6.6, RSS 247 6.2

#### 8.1.2 Conformance Limit

The 26dB bandwidth is used to determine the conducted power limits. Within the 5.725-5.85 GHz band, the minimum 6 dB bandwidth of U-NII devices shall be at least 500 kHz.

#### 8.1.3 Test Configuration

Test according to clause 7.1 radio frequency test setup

#### 8.1.4 Test Procedure

According to 789033 D02 v02r01 section C&D, the following is the measurement procedure.

1. Emission Bandwidth (EBW)

a) Set RBW = approximately 1% of the emission bandwidth.

b) Set the VBW > RBW.

c) Detector = Peak.

d) Trace mode = max hold.

e) Measure the maximum width of the emission that is 26 dB down from the maximum of the emission. Compare this with the RBW setting of the analyzer. Readjust RBW and repeat measurement as needed until the RBW/EBW ratio is approximately 1%.

2. Minimum Emission Bandwidth for the band 5.725-5.85 GHz

Section 15.407(e) specifies the minimum 6 dB emission bandwidth of at least 500 KHz for the band 5.715-5.85 GHz. The following procedure shall be used for measuring this bandwidth:

a) Set RBW = 100 kHz.

b) Set the video bandwidth (VBW)  $\geq$  3  $\times$  RBW.

c) Detector = Peak.

 $\dot{d}$  Trace mode = max hold.

e) Sweep = auto couple.

f) Allow the trace to stabilize.

g) Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.

Note: The automatic bandwidth measurement capability of a spectrum analyzer or EMI receiver may be employed if it implements the functionality described above.

#### D. 99 Percent Occupied Bandwidth

The 99-percent occupied bandwidth is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers are each equal to 0.5 % of the total mean power of the given emission. Measurement of the 99-percent occupied bandwidth is required only as a condition for using the optional band-edge measurement techniques described in section II.G.3.d). Measurements of 99-percent occupied bandwidth may also optionally be used in lieu of the EBW to 789033 D02 v01r02 General UNII Test Procedures New Rules v01 define the minimum frequency range over which the spectrum is integrated when measuring maximum conducted output power as described in section II.E. However, the EBW must be measured to determine bandwidth dependent limits on maximum conducted output power in accordance with 15.407(a).



The following procedure shall be used for measuring (99 %) power bandwidth:

1. Set center frequency to the nominal EUT channel center frequency.

2. Set span = 1.5 times to 5.0 times the OBW.

3. Set RBW = 1 % to 5 % of the OBW

4. Set VBW  $\geq$  3 • RBW

5. Video averaging is not permitted. Where practical, a sample detection and single sweep mode shall be used. Otherwise, peak detection and max hold mode (until the trace stabilizes) shall be used.

6. Use the 99 % power bandwidth function of the instrument (if available).

7. If the instrument does not have a 99 % power bandwidth function, the trace data points are recovered and directly summed in power units. For devices operating in the bands 5.15-5.25 GHz, 5.25-5.35 GHz, and 5.47-5.725 GHz, the above procedures make use of 1 MHz RBW to satisfy directly the 1 MHz reference bandwidth specified in § 15.407(a)(5). For devices operating in the band 5.725-5.85 GHz, the rules specify a measurement bandwidth of 500 kHz. Many spectrum analyzers do not have 500 kHz RBW, thus a narrower RBW may need to be used. The rules permit the use of a RBWs less than 1 MHz, or 500 kHz, "provided that the measured power is integrated over the full reference bandwidth" to show the total power over the specified measurement bandwidth (i.e., 1 MHz, or 500 kHz). If measurements are performed using a reduced resolution bandwidth (< 1 MHz, or < 500 kHz) and integrated over 1 MHz, or 500 KHz bandwidth, the following adjustments to the procedures apply:

a) Set RBW  $\geq 1/T$ , where T is defined in section II.B.I.a).

b) Set VBW  $\geq$  3 RBW.

c) If measurement bandwidth of Maximum PSD is specified in 500 kHz, add 10log(500kHz/RBW) to the measured result, whereas RBW (< 500 KHz) is the reduced resolution bandwidth of the spectrum analyzer set during measurement.



### 8.4.1 Applicable Standard

## 8.4.2 Conformance Limit

For transmitters operating in the 5.15-5.25 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.

For transmitters operating in the 5.25-5.35 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.

For transmitters operating in the 5.47-5.725 GHz band: All emissions outside of the 5.47-5.725 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.

For transmitters operating in the 5.725-5.85 GHz band: All emissions shall be limited to a level of -27 dBm/MHz at 75 MHz or more above or below the band edge increasing linearly to 10 dBm/MHz at 25 MHz above or below the band edge, and from 25 MHz above or below the band edge increasing linearly to a level of 15.6 dBm/MHz at 5 MHz above or below the band edge, and from 5 MHz above or below the band edge increasing linearly to a level of 27 dBm/MHz at the band edge.

The emission measurements shall be performed using a minimum resolution bandwidth of 1 MHz. A lower resolution bandwidth may be employed near the band edge, when necessary, provided the measured energy is integrated to show the total power over 1 MHz.

Unwanted emissions below 1 GHz must comply with the general field strength limits set forth in §15.209 The emissions from an intentional radiator shall not exceed the field strength levels specified in the following table 15 209(a):

Compliance shall be demonstrated using CISPR quasi-peak detection; however, peak detection is permitted as an alternative to quasi-peak detection.

The EUT was placed on a turn table which is 0.8m above ground plane.

And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.

Repeat above procedures until all frequency measured was complete.

We use software control the EUT, Let EUT hopping on and transmit with highest power, All the modes have been tested and the worst result was reported.

Use the following spectrum analyzer settings:

Set RBW=120kHz for f < 1 GHz(30MHz to 1GHz), 200Hz for f<150KHz(9KHz to 150KHz), 9KHz for <30MHz(150KHz to 30KHz).

Follow the guidelines in ANSI C63.10-2013 with respect to maximizing the emission by rotating the EUT, measuring the emission while the EUT is situated in three orthogonal planes (if appropriate), adjusting the measurement antenna height and polarization, etc. A pre-amp and a high pass filter are required for this test, in order to provide the measuring system with sufficient sensitivity. Allow the trace to stabilize. The peak reading of the emission, after being corrected by the antenna factor, cable loss, pre-amp gain, etc., is the peak field strength, which must comply with the limit specified in Section 15.35(b). Submit this data.

Repeat above procedures until all frequency measured was complete.

Band edge measurements.

Unwanted band-edge emissions may be measured using either of the special band-edge measurement techniques (the marker-delta or integration methods) described below. Note that the marker-delta method is primarily a radiated measurement technique that requires the 99% occupied bandwidth edge to be within 2 MHz of the authorized band edge, whereas the integration method can be used in either a radiated or conducted measurement without any special requirement with regards to the displacement of the unwanted emission(s) relative to the authorized bandwidth.

Marker-Delta Method.

The marker-delta method, as described in ANSI C63.10, can be used to perform measurements of the radiated unwanted emissions level of emissions provided that the 99% occupied bandwidth of the fundamental is within 2 MHz of the authorized band-edge.

# **8.6 ANTENNA APPLICATION**

Requirement
An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.
If transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.
The applicant for equipment certification shall provide a list of all antenna types that may be used with the transmitter, where applicable (i.e. for transmitters with detachable antenna), indicating the maximum permissible antenna gain (in dBi) and the required impedance for each antenna. The test report shall demonstrate the compliance of the transmitter with the limit for maximum equivalent isotropically radiated power (e.i.r.p.) specified in the applicable RSS, when the transmitter is equipped with any antenna type, selected from this list.
