Photograph of the tissue simulant fluid liquid depth (Body)





Body - distance between flat phantom and EUT is 5 mm






Fig.3 EUT Back side to flat phantom







Fig.4 EUT Top side to flat phantom






Fig.5 EUT Right side to flat phantom







Fig.6 EUT Left side to flat phantom






Fig.7 EUT Bottom side to flat phantom






Fig.8 EUT Front side to flat phantom




Fig.10 Back view of EUT




Fig.11 Atenna location (front view and edge view)
