

# 12. Radio Frequency Exposure

### **12.1 Applicable Standards**

The measurements shown in this test report were made in accordance with the procedures given in

FCC Part 2 (Section 2.1093) KDB 447498 IEEE C95.1:2005

KDB 447498 D01 § 4.3(a)

For 100 MHz to 6 GHz and test separation distances  $\leq$  50 mm, the 1-g and 10-g SAR test exclusion thresholds are determined by the following:

[(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)]  $\cdot [\sqrt{f(GHz)}] \le 3.0$  for 1-g SAR, and  $\le 7.5$  for 10-g extremity SAR, where

\*f(GHz) is the RF channel transmit frequency in GHz

\* Power and distance are rounded to the nearest mW and mm before calculation

\*The result is rounded to one decimal place for comparison

\*The values 3.0 and 7.5 are referred to as numeric thresholds in step b) below

The test exclusions are applicable only when the minimum test separation distance is  $\leq$  50 mm, and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm according to 4.1 f) is applied to determine SAR test exclusion

## 12.2 EUT Specification

#### Remark:

 The maximum conducted output power is <u>4.06dBm (2.55mW)</u> at <u>2412MHz</u> (with <u>1.85dBi</u> antenna gain.)

DTS device is not subject to routine RF evaluation; MPE estimate is used to justify the compliance.

3. For mobile or fixed location transmitters, no SAR consideration applied.



# 12.3 Test Results

According to the KDB447498:

The SAR test exclusion thresholds Level:

[(max. power of channel, including tune-up tolerance, mW) /(min. test separation distance, mm)] \* sqrt (freq. in GHz) < 3.

### Calculation

2412-2462	4.06	2.55	15	29.00

Since the source-based time-averaging conducted output power is well below the SAR low threshold level, so the EUT is considered to comply with SAR requirement without testing

Note: Tune up tolerances have been taken in to account when calculating RF exposure evaluation.
