## 12. Radio Frequency Exposure

## 12.1 Applicable Standards

The measurements shown in this test report were made in accordance with the procedures given in FCC Part 2 (Section 2.1093)

#### **LIMIT**

KDB 447498 D01 § 4.3(a)

For 100 MHz to 6 GHz and test separation distances ≤ 50 mm, the 1-g and 10-g SAR test exclusion thresholds are determined by the following:

[(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)]  $[\sqrt{f(GHz)}] \le 3.0$  for 1-g SAR, and  $\le 7.5$  for 10-g extremity SAR, where

\*f(GHz) is the RF channel transmit frequency in GHz

- \* Power and distance are rounded to the nearest mW and mm before calculation
- \*The result is rounded to one decimal place for comparison
- \*The values 3.0 and 7.5 are referred to as numeric thresholds in step b) below

The test exclusions are applicable only when the minimum test separation distance is ≤ 50 mm, and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm according to 4.1 f) is applied to determine SAR test exclusion
