12. Radio Frequency Exposure

12.1 Applicable Standards

The measurements shown in this test report were made in accordance with the procedures given in FCC Part 2 (Section 2.1093)

For 100 MHz to 6 GHz and test separation distances ≤ 50 mm, the 1-g and 10-g SAR test exclusion thresholds are determined by the following:

[(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)] $[\sqrt{f(GHz)}] \le 3.0$ for 1-g SAR, and ≤ 7.5 for 10-g extremity SAR, where

*f(GHz) is the RF channel transmit frequency in GHz

- *The result is rounded to one decimal place for comparison
- *The values 3.0 and 7.5 are referred to as numeric thresholds in step b) below

The test exclusions are applicable only when the minimum test separation distance is \leq 50 mm, and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm according to 4.1 f) is applied to determine SAR test exclusion
