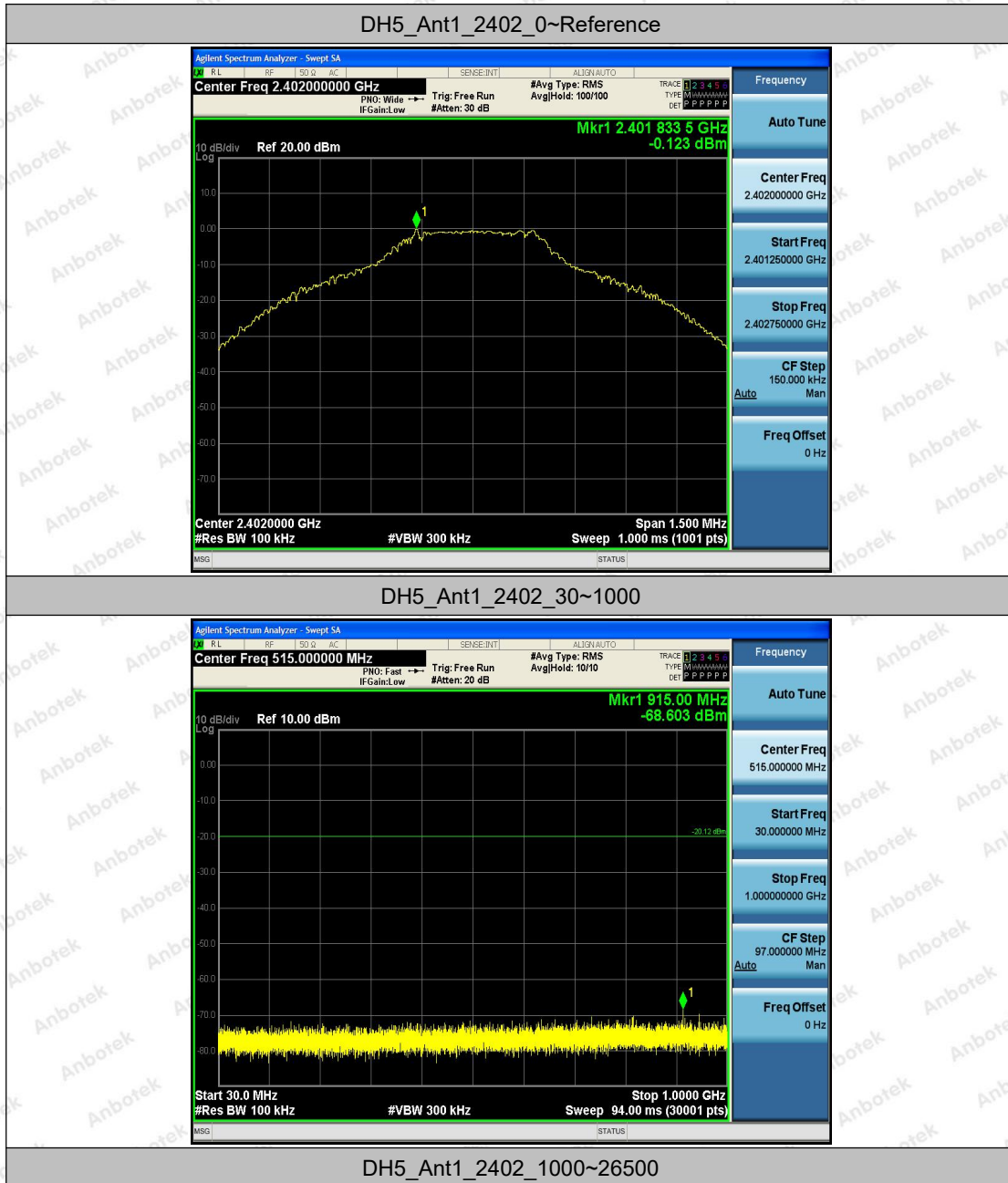


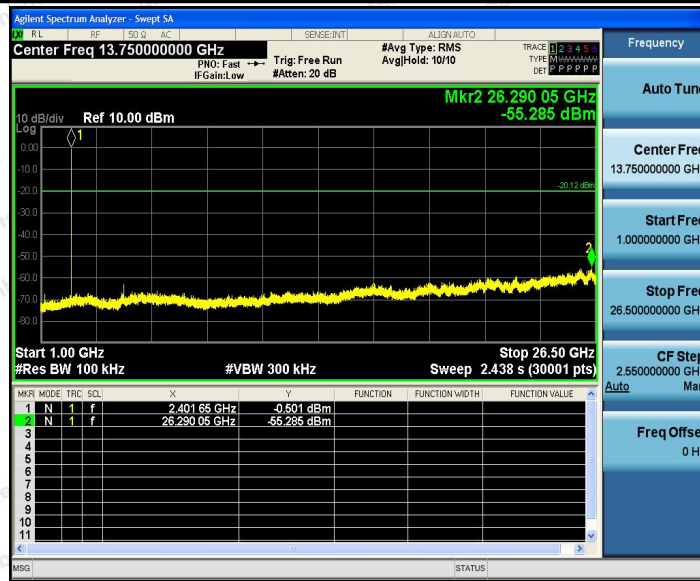

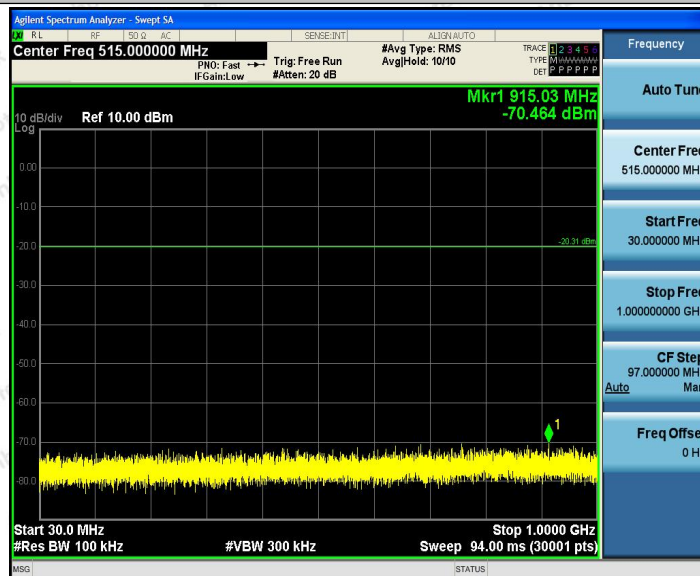

DH5_Ant1_2441_30~1000

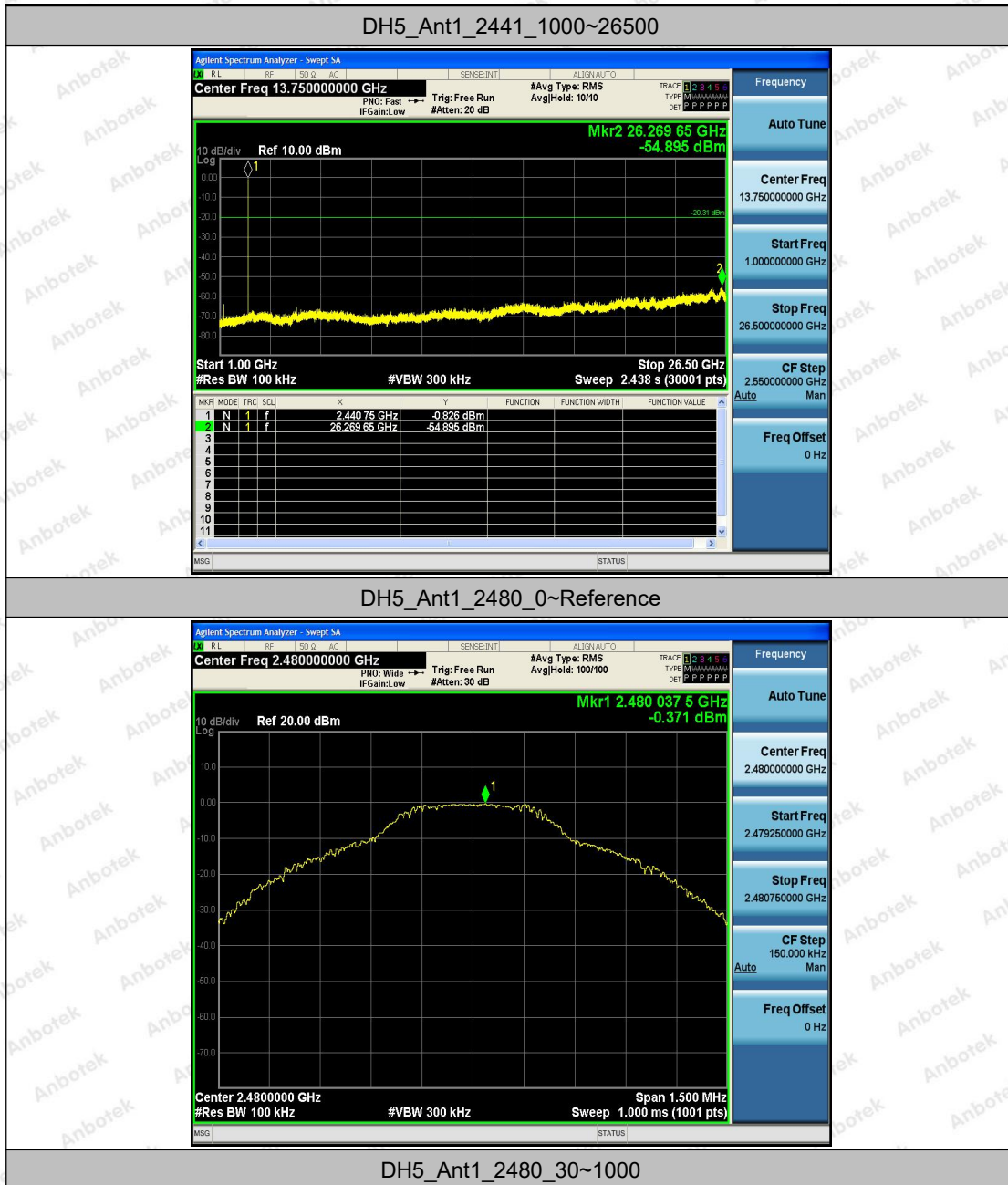
