



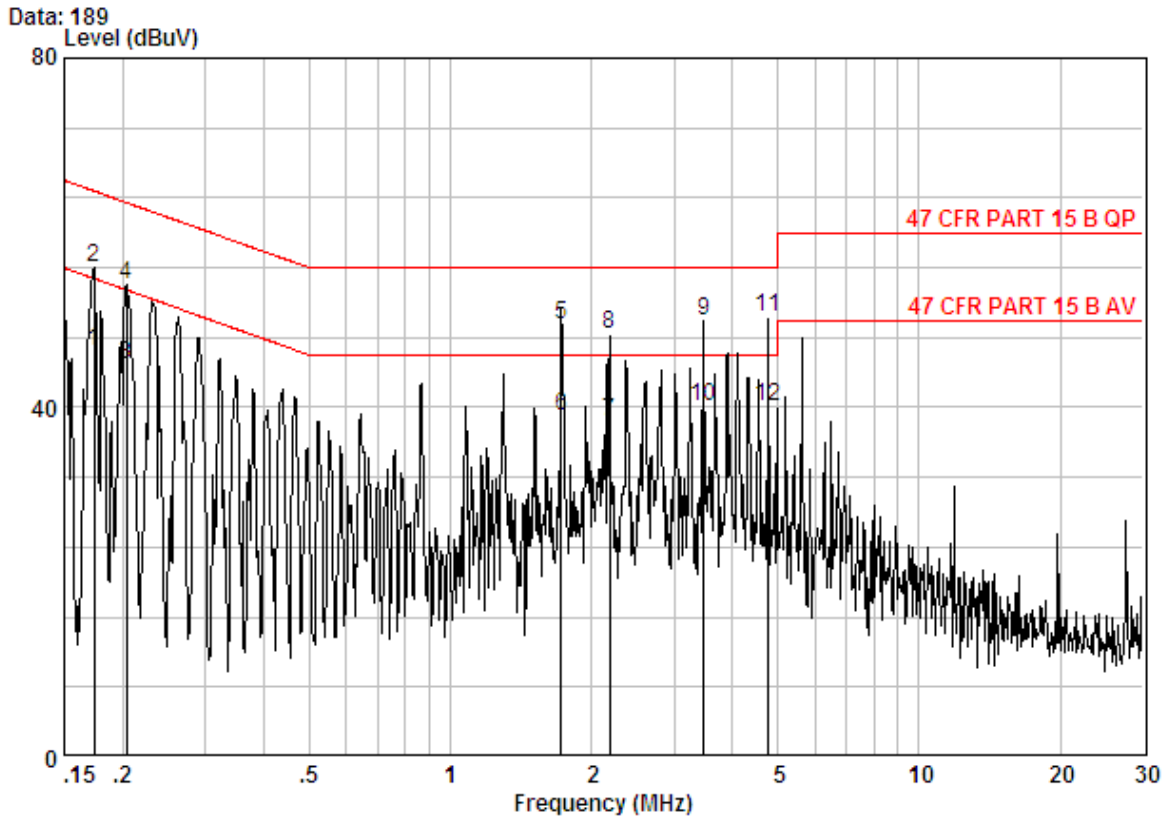

Live line:



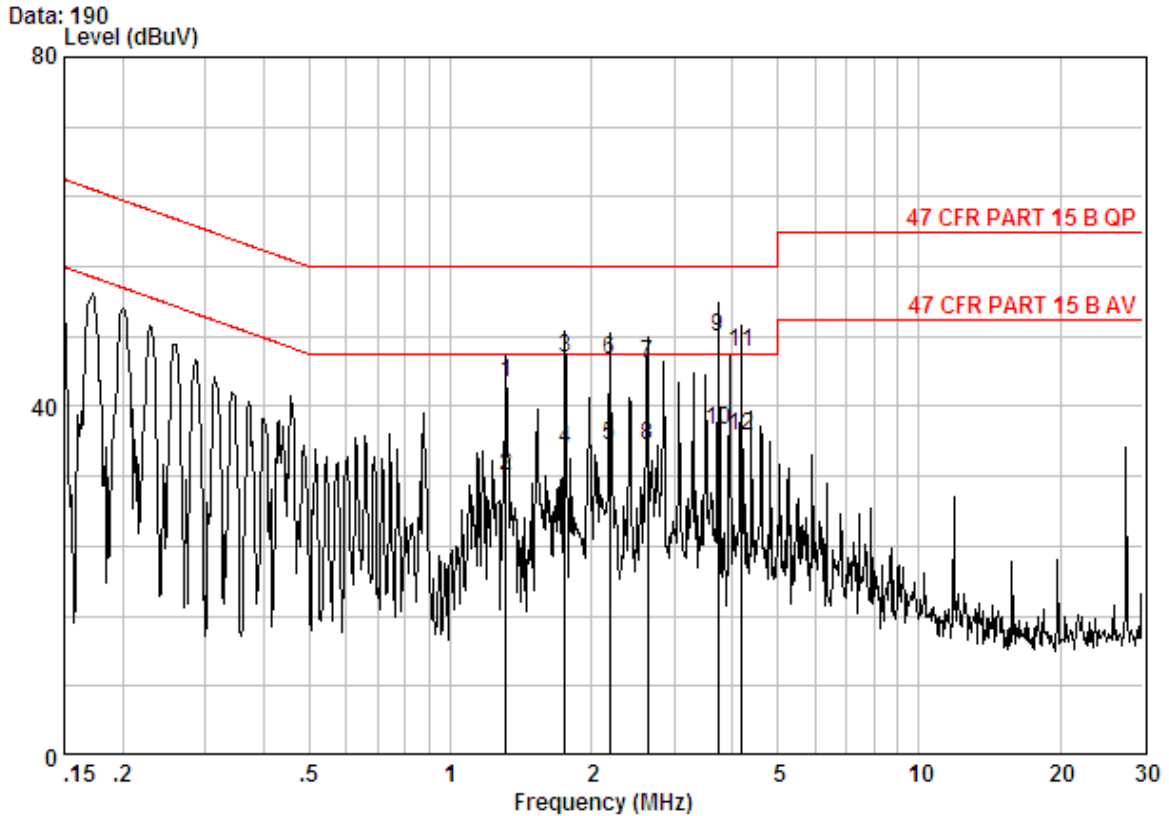

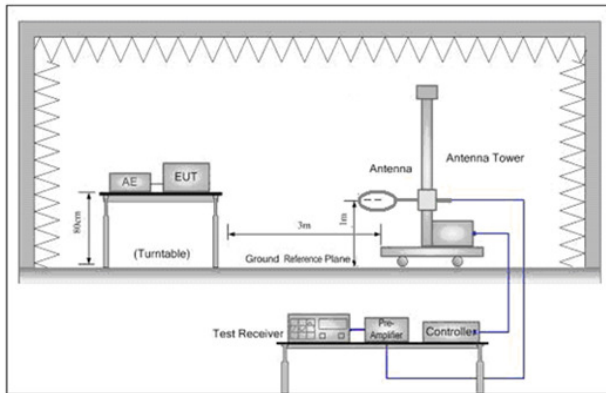


Figure 1. Below 30MHz

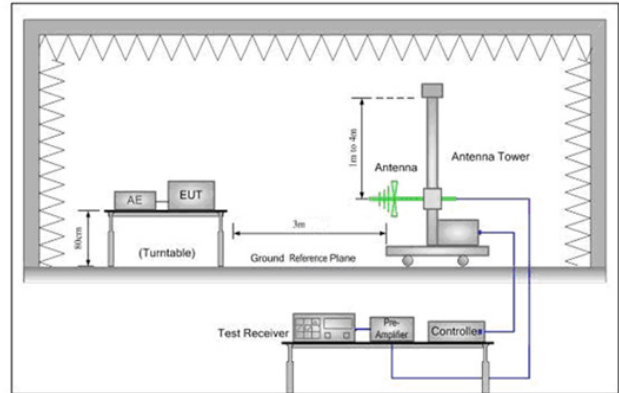


Figure 2. 30MHz to 1GHz

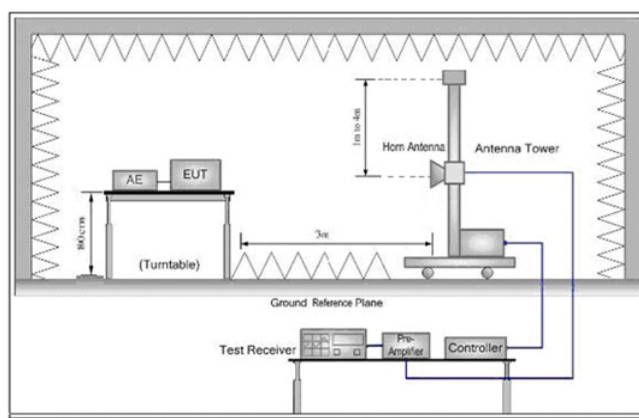


Figure 3. Above 1 GHz

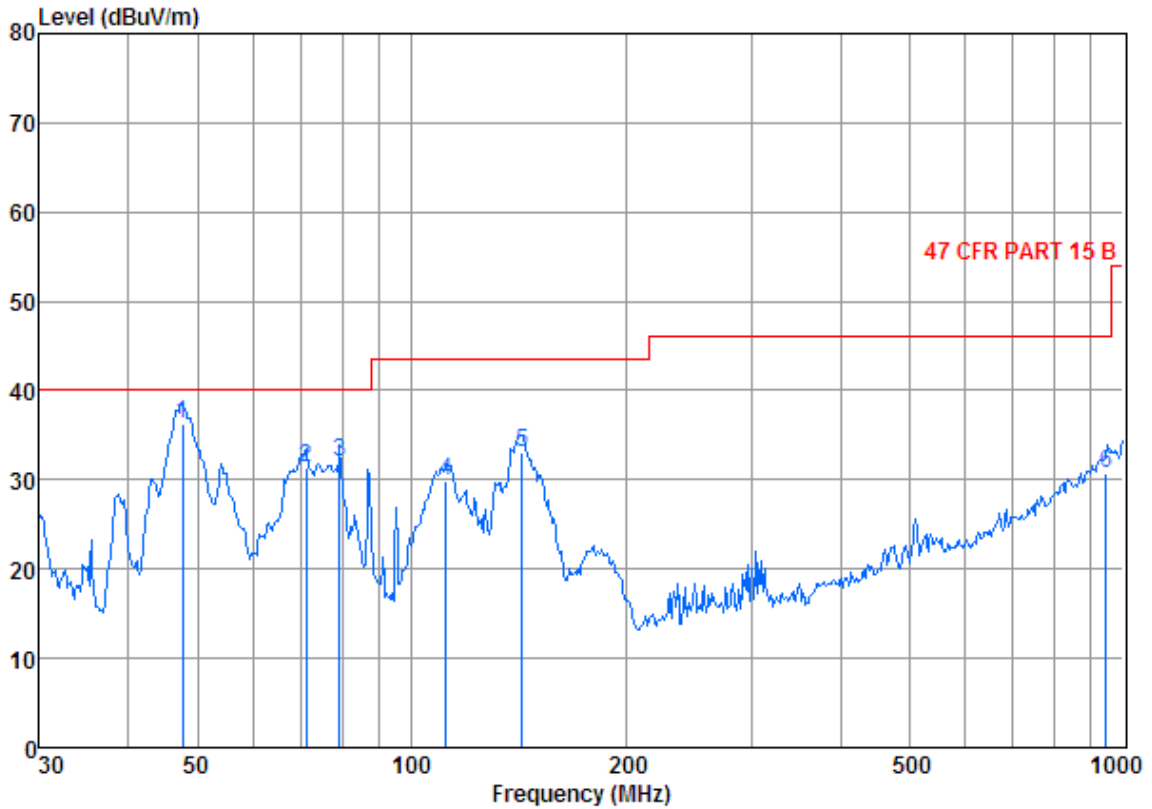

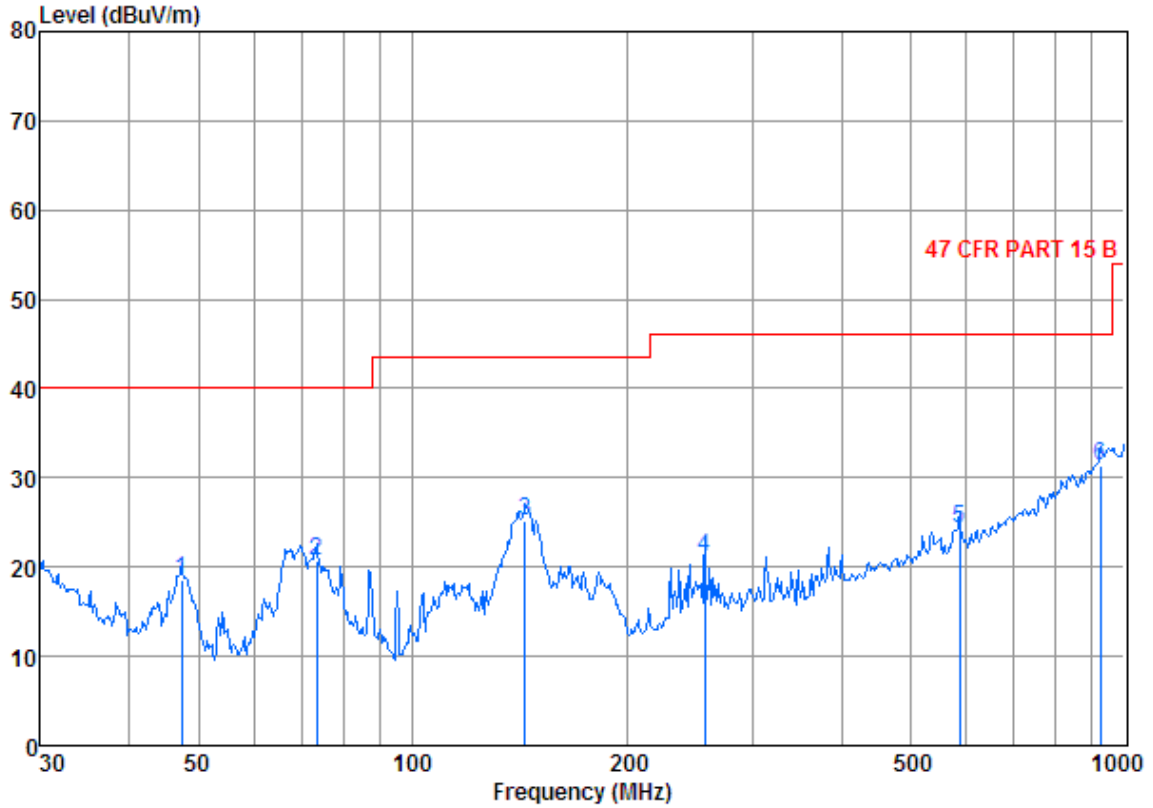

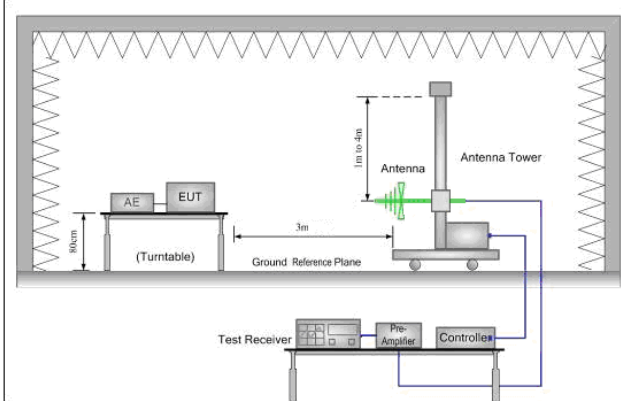


Figure 1. 30MHz to 1GHz

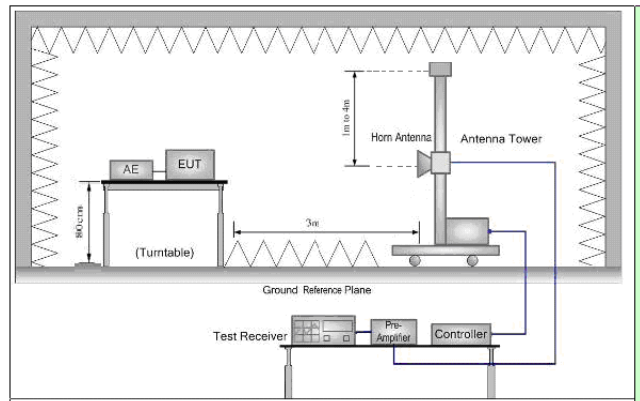


Figure 2. Above 1 GHz

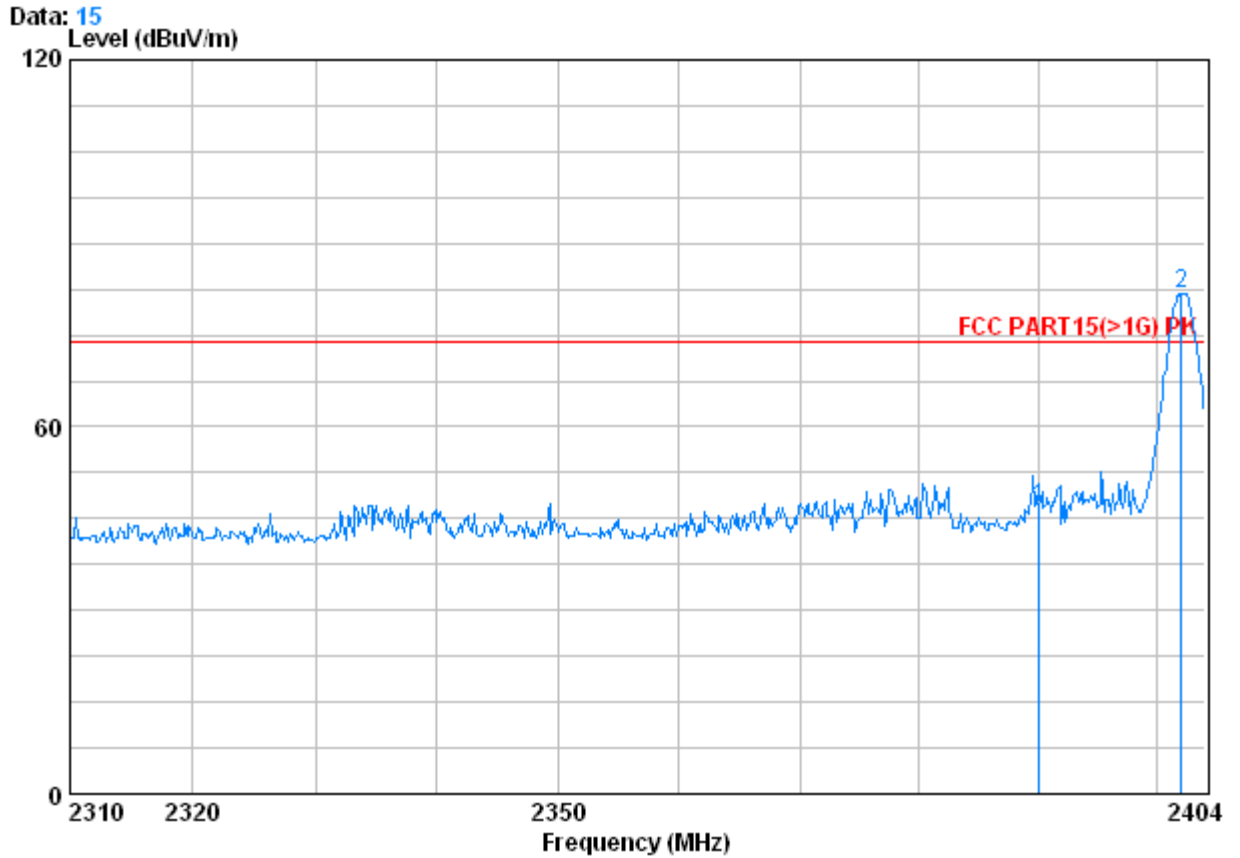

The field strength is calculated by adding the Antenna Factor, Cable Factor & Preamplifier. The basic equation with a sample calculation is as follows:

$$\text{Final Test Level} = \text{Receiver Reading} + \text{Antenna Factor} + \text{Cable Factor} - \text{Preamplifier Factor}$$

As shown in this section, for frequencies above 1GHz, the field strength limits are based on average limits. However, the peak field strength of any emission shall not exceed the maximum permitted average limits specified above by more than 20 dB under any condition of modulation.
