1.6. Test Procedure(s)

The measurement procedures described in the American National Standard for Methods of Measurement of Radio-Noise Emission from Low-Voltage Electrical and Electronic Equipment in the Range of 9 kHz to 40 GHz (ANSI C63.4-2009) and the guidance provided in KDB 558074 v03r02 were used in the measurement of the DUT.




2.1. Test Setup





2.2. Limit

According to §15.247(d), in any 100 klb bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 klb bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph(b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in section §15.209(a) is not required. In addition, radiated emission which in the restricted band, as define in section §15.205(a), must also comply the radiated emission limits specified in section §15.205(c))

According to § 15.209(a), Except as provided elsewhere in this Subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table:

2.3. Test Procedures

Radiated emissions from the EUT were measured according to the dictates in section 11.0 & 12.0 of KDB 558074 v03r02 and ANSI C63.4-2009.

2.3.1. Test Procedures for emission below 30 Mb

- 1. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- 2. Then antenna is a loop antenna is fixed at one meter above the ground to determine the maximum value of the field strength. Both parallel and perpendicular of the antenna are set to make the measurement.
- 3. For each suspected emission, the EUT was arranged to its worst case and then the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- 4. The test-receiver system was set to average or quasi peak detect function and Specified Bandwidth with Maximum Hold Mode.

2.3.2. Test Procedures for emission from above 30 Mb

- 1. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- 2. During performing radiated emission below 1 %, the EUT was set 3 meters away from the interference receiving antenna, which was mounted on the top of a variable-height antenna tower. During performing radiated emission above 1 %, the EUT was set 3 meter away from the interference-receiving antenna.
- 3. The antenna is a bi-log antenna, a horn antenna and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- 4. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- 5. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- 6. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

NOTE;

All data rates and modes were investigated for radiated spurious emissions. Only the radiated emissions of the configuration that produced the worst case emissions are reported in this section.

- 1. Unwanted Emissions into Non-Restricted Frequency Bands

-Average Power measurements procedure refer to section 12.2.5.2 The EUT shall be configured to operate at the maximum achievable duty cycle. Measure the duty cycle, x, of the transmitter output signal as described in section 6.0. Set RBW = 1 Mb, VBW \geq 3 x RBW, Detector = RMS, if span / (# of points in sweep) \leq (RBW/2). Satisfying this condition may require increasing the number of points in the sweep or reducing the span. If this condition cannot be satisfied then the detector mode shall be set to peak,

Averaging type = power (i.e., RMS).

As an alternative the detector and averaging type may be set for linear voltage averaging. Some instruments require linear display mode in order to use linear voltage averaging. Log or dB averaging shall not be used. Sweep time = auto, Perform a trace average of at least 100 traces.

A correction factor shall be added to the measurement results prior to comparing to the emission limit in order to compute the emission level that would have been measured had the test been performed at 100 percent duty cycle. The correction factor is computed as follows:

- 1) If power averaging (RMS) mode was used in step f), then the applicable correction factor is 10 log (1/x), where x is the duty cycle.
- 3. To get a maximum emission level from the EUT, the EUT is manipulated through three orthogonal planes. Definition of DUT three orthogonal planes were described in the test setup photo. Worst orthogonal plan of EUT is **Y axis** during radiation test.

2.3.3. Test Procedures for Conducted Spurious Emissions

All data rates and modes were investigated for conducted spurious emissions. Only the conducted emissions of the configuration that produced the worst case emissions are reported in this section.

Per the guidance of KDB 558074 v03r02, section 11.1 & 11.2, the reference level for out of band emissions is established from the plots of this section since the band edge emissions are measured with a RBW of 100 kHz. This reference level is then used as the limit in subsequent plots for out of band spurious emissions shown in section 2.4.3. The limit for out of band spurious emission at the band edge is 20 dB or 30 dB below the fundamental emission level measured in a 100 kHz bandwidth.

1. Conducted Emissions at Band Edge

- The Measurement refer to section 11.3

Set the center frequency and span to encompass frequency range to be measured, the RBW = 100 ຟ and VBW ≥ 3 x RBW, Detector = Peak, Sweep time = Auto couple, Trace = Max hold, Ensure that the number of measurement points ≥ span/RBW, The trace was allowed to stabilize.

2. Conducted Spurious Emissions

- The Measurement refer to section 11.3

 Start frequency was set to 30 Mb and stop frequency was set to 24.8 Gb (separated into two plots per channel), RBW = 1 Mb, VBW = 3 Mb Detector = Peak, Sweep time = Auto couple, Trace = Max hold, The trace was allowed to stabilize.
- RBW was set to 1 Mb rather than 100 klb in order to increase the measurement speed.
- The display line shown in section 2.4 plots denotes the limit at 20 dB below the fundamental emission level measured in a 100 kHz bandwidth. However, since the traces in the plots are measured with a 1 MHz RBW, the display line may not necessarily appear to be 20 dB below the level of the fundamental in a 1 MHz bandwidth.
- For plots showing conducted spurious emissions near the limits, the frequencies were investigated with a reduced RBW to ensure that no emissions were present.

3. Correction factor

- For plots showing conducted spurious emissions from 30 № to 24.8 औ, all path loss of wide frequency range was investigated and compensated to spectrum analyzer as correction factor. The reading values shown in plots were final result.

Middle Channel








Middle Channel



4.2. Limit

According to §15.247(b)(3), for systems using digital modulation in the 902 ~ 928 Mb, 2 400 ~ 2 483.5 Mb, and 5 725 ~ 5 850 Mb band: 1 Watt. As an alternative to a peak power measurement, compliance with the one watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antenna elements. The average must not include any intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.

According to §15.247(b)(4), the conducted output power limit specified in paragraph(b) of this section is based on the use of antenna with directional gains that do not exceed 6 dBi. Except as shown in paragraph(c) of this section, if transmitting antenna of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraph (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

4.3. Test Procedure

All data rates and modes were investigated for this test. The full data for the worst case data rate are reported in this section.

The test follows section 9.1.2 & 9.2.3.1 of FCC KDB Publication 558074 v03r02

- Peak power meter method

-The maximum peak conducted output power may be measured using a broadband peak RF power meter. The power meter shall have a video bandwidth that is greater than or equal to the DTS bandwidth and shall utilize a fast-responding diode detector.

- Average power meter method

- a) Measurements may be performed using a wideband RF power meter with a thermocouple detector or equivalent if all of the conditions listed below are satisfied.
- 1) The EUT is configured to transmit continuously, or to transmit with a constant duty factor.
- 2) At all times when the EUT is transmitting, it shall be transmitting at its maximum power control level.
- 3) The integration period of the power meter exceeds the repetition period of the transmitted signal by at least a factor of five.
- b) If the transmitter does not transmit continuously, measure the duty cycle (x) of the transmitter output signal as described in Section 6.0 of KDB 558074 v03r02.
- c) Measure the average power of the transmitter. This measurement is an average over both the on and off periods of the transmitter.
- d) Adjust the measurement in dB m by adding 10 log(1/x), where x is the duty cycle to the measurement result.
- 1. Place the EUT on the table and set it in the transmitting mode.
- 2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the broadband power meter and power sensor. The power sensor employs a VBW = 30 Mb which is greater than the DTS bandwidth
- 3. Measure peak & average power each channel.





§15.247(e) For digitally modulated system, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dB m in any 3 klk band any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.

5.3. Test Procedure

The measurement is recorded using the PKPSD measurement procedure in 10.2 of KDB 558074_v03r02.

- 1. Set analyzer center frequency to DTS channel center frequency.
- 2. Set the span to at least 1.5 times the DTS channel bandwidth.
- 3. Set the RBW to : 3 kHz \leq RBW \leq 100 kHz
- 4. Set the VBW \geq 3 x RBW
- 5. Detector = Peak
- 6. Sweep time = auto couple.
- 7. Trace mode = max hold.
- 8. Allow trace to fully stabilize.
- 9. Use the peak marker function to determine the maximum amplitude level within the RBW.
- 10. If measured value exceeds limit, reduce RBW (no less than 3 klb) and repeat.







High Channel



6.2. Limit

According to §15.207(a) for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 k to 30 k not exceed the limits in the following table, as measured using a 50 μ H /50 ohm line impedance stabilization network(LISN).

Compliance with the provision of this paragraph shall on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower applies at the boundary between the frequency ranges.

6.3. Test Procedures

All data rates and modes were investigated for this test. The full data for the worst case data rate are reported in this section.

AC power line conducted emissions from the EUT were measured according to the dictates of ANSI C63.4-2009

- 1. The test procedure is performed in a 6.5 m × 3.5 m × 3.5 m (L × W × H) shielded room. The EUT along with its peripherals were placed on a 1.0 m (W)× 1.5 m (L) and 0.8 m in height wooden table and the EUT was adjusted to maintain a 0.4 meter space from a vertical reference plane.
- 2. The EUT was connected to power mains through a line impedance stabilization network (LISN) which provides 50 ohm coupling impedance for measuring instrument and the chassis ground was bounded to the horizontal ground plane of shielded room.
- 3. The excess power cable between the EUT and the LISN was bundled. All connecting cables of EUT were moved to find the maximum emission.



Plots of Conducted Power line





Plots of Conducted Power line


