1.Channel 12 and 13 are enable in default mode for this device. Channel 12 and 13 use lower target power.

2.The device always use country code as geo-location information and it is determined only when the device is attached to 2G/3G/LTE network. Additionally, in case of the invalid country code, Wi-Fi driver will revert to the NV Binary code in which channels 1-13 are enabled. Therefore there will be no problem with those scenarios.
