

1.0 INTRODUCTION

1.1 Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Innovation, Science and Economic Development Canada.

1.2 PCTEST Test Location

These measurement tests were conducted at the PCTEST Engineering Laboratory, Inc. facility located at 7185 Oakland Mills Road, Columbia, MD 21046. The measurement facility is compliant with the test site requirements specified in ANSI C63.4-2014.

1.3 Test Facility / Accreditations

Measurements were performed at PCTEST Engineering Lab located in Columbia, MD 21046, U.S.A.

2.0 PRODUCT INFORMATION

2.1 Equipment Description

LTE Band 66 (1710 - 1780 MHz) overlaps the entire frequency range of LTE Band 4 (1710 - 1755 MHz). Therefore, test data provided in this report covers Band 4 as well as Band 66.

LTE Band 12 (698 - 716 MHz) overlaps the entire frequency range of LTE Band 17 (704 - 716 MHz). Therefore, test data provided in this report covers Band 17 as well as Band 12.

LTE Band 25 (1850 - 1915 MHz) overlaps the entire frequency range of LTE Band 2 (1850 - 1910 MHz). Therefore, test data provided in this report covers Band 2 as well as Band 25.

2.3 Test Configuration

The EUT was tested per the guidance of ANSI/TIA-603-E-2016 and KDB 971168 D01 v03r01. See Section 7.0 of this test report for a description of the radiated and antenna port conducted emissions tests.

3.0 DESCRIPTION OF TESTS

3.1 Measurement Procedure

The measurement procedures described in the document titled "Land Mobile FM or PM – Communications Equipment – Measurements and Performance Standards" (ANSI/TIA-603-E-2016) and "Procedures for Compliance Measurement of the Fundamental Emission Power of Licensed Wideband (> 1 MHz) Digital Transmission Systems" (KDB 971168 D01 v03r01) were used in the measurement of the EUT.

3.2 Block C Frequency Range


Two paired channels of 11 megahertz each are available for assignment in Block C in the 746-757 MHz and 776-787 MHz bands. In the event that no licenses for two channels in this Block C are assigned based on the results of the first auction in which such licenses were offered because the auction results do not satisfy the applicable reserve price, the spectrum in the 746-757 MHz and 776-787 MHz bands will instead be made available for assignment at a subsequent auction as follows: (i) Two paired channels of 6 megahertz each available for assignment in Block C1 in the 746-752 MHz and 776-782 MHz bands. (ii) Two paired channels of 5 megahertz each available for assignment in Block C2 in the 752-757 MHz and 782-787 MHz bands.

3.3 Block A Frequency Range

<u>698-746 MHz band</u>. The following frequencies are available for licensing pursuant to this part in the 698-746 MHz band: (1) Three paired channel blocks of 12 megahertz each are available for assignment as follows:











3.12 Radiated Power and Radiated Spurious Emissions

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. The test site inside the chamber is a 6m x 5.2m elliptical, obstruction-free area in accordance with Figure 5.7 of Clause 5 in ANSI C63.4-2014. Absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections for measurements above 1GHz. For measurements below 1GHz, the absorbers are removed. A raised turntable is used for radiated measurement. The turn table is a continuously rotatable, remote-controlled, metallic turntable and 2 meters (6.56 ft.) in diameter. The turn table is flush with the raised floor of the chamber in order to maintain its function as a ground plane. An 80cm tall test table made of Styrodur is placed on top of the turn table. A Styrodur pedestal is placed on top of the test table to bring the total table height to 1.5m.

The equipment under test was transmitting while connected to its integral antenna and is placed on a turntable 3 meters from the receive antenna. The receive antenna height is adjusted between 1 and 4 meter height, the turntable is rotated through 360 degrees, and the EUT is manipulated through all orthogonal planes representative of its typical use to achieve the highest reading on the receive spectrum analyzer. Radiated power levels are also investigated with the receive antenna horizontally and vertically polarized. The maximized power level is recorded using the spectrum analyzer "Channel Power" function with the integration band set to the emissions' occupied bandwidth, a RMS detector, RBW = 100kHz, VBW = 300kHz, and a 1 second sweep time over a minimum of 10 sweeps, per the guidelines of KDB 971168 D01 v03r01.

Per the guidance of ANSI/TIA-603-E-2016, a half-wave dipole is then substituted in place of the EUT. For emissions above 1GHz, a horn antenna is substituted in place of the EUT. The substitute antenna is driven by a signal generator with the level of the signal generator being adjusted to obtain the same receive spectrum analyzer level previously recorded from the spurious emission from the EUT. The power of the emission is calculated using the following formula:

Pd [dBm] = Pg [dBm] - cable loss [dB] + antenna gain [dBd/dBi]

Where, Pd is the dipole equivalent power, Pg is the generator output into the substitution antenna, and the antenna gain is the gain of the substitute antenna used relative to either a half-wave dipole (dBd) or an isotropic source (dBi). The substitute level is equal to Pg [dBm] – cable loss [dB].

The calculated P_d levels are then compared to the absolute spurious emission limit of -13dBm which is equivalent to the required minimum attenuation of 43 + 10log₁₀(Power [Watts]). For Band 7, the calculated Pd levels are compared to the absolute spurious emission limit of -25dBm which is equivalent to the required minimum attenuation of 55 + 10log₁₀(Power [Watts]). For Band 30, the calculated Pd levels are compared to the absolute spurious emission limit of -40dBm which is equivalent to the required minimum attenuation of 70 + 10log₁₀(Power [Watts]).

Plot 7-13. Occupied Bandwidth Plot (Band 5 - 1.4MHz QPSK - Full RB Configuration)




Plot 7-14. Occupied Bandwidth Plot (Band 5 - 1.4MHz 16-QAM - Full RB Configuration)



Plot 7-27. Occupied Bandwidth Plot (Band 66/4 - 10.0MHz QPSK - Full RB Configuration)






Plot 7-29. Occupied Bandwidth Plot (Band 66/4 - 15.0MHz QPSK - Full RB Configuration)




Plot 7-35. Occupied Bandwidth Plot (Band 25/2 - 3.0MHz QPSK - Full RB Configuration)

Plot 7-37. Occupied Bandwidth Plot (Band 25/2 - 5.0MHz QPSK - Full RB Configuration)





Plot 7-41. Occupied Bandwidth Plot (Band 25/2 - 15.0MHz QPSK - Full RB Configuration)





Plot 7-51. Occupied Bandwidth Plot (Band 7 - 10.0MHz QPSK - Full RB Configuration)




Plot 7-52. Occupied Bandwidth Plot (Band 7 - 10.0MHz 16-QAM - Full RB Configuration)

7.3 Spurious and Harmonic Emissions at Antenna Terminal

Test Overview

The level of the carrier and the various conducted spurious and harmonic frequencies is measured by means of a calibrated spectrum analyzer. The spectrum is scanned from the lowest frequency generated in the equipment up to a frequency including its 10th harmonic. All out of band emissions are measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies. All data rates were investigated to determine the worst case configuration. All modes of operation were investigated and the worst case configuration results are reported in this section.

The minimum permissible attenuation level of any spurious emission is 43 + $log_{10}(P_{[Watts]})$, where P is the transmitter power in Watts.

For Band 30, the minimum permissible attenuation level of any spurious emission <2288MHz and >2365MHz is 70 + log10(P[Watts]).

For Band 7, the minimum permissible attenuation level of any spurious emission is 55 + log₁₀(P_[Watts]).

Test Procedure Used

KDB 971168 D01 v03r01 - Section 6.0

Test Settings

- 1. Start frequency was set to 30MHz and stop frequency was set to at least 10 * the fundamental frequency (separated into at least two plots per channel)
- 2. Detector = RMS
- 3. Trace mode = trace average for continuous emissions, max hold for pulse emissions
- 4. Sweep time = auto couple
- The trace was allowed to stabilize
- 6. Please see test notes below for RBW and VBW settings

Figure 7-2. Test Instrument & Measurement Setup


Test Notes

Compliance with the applicable limits is based on the use of measurement instrumentation employing a resolution bandwidth of 100 kHz or greater for frequencies less than 1 GHz and 1 MHz or greater for frequencies greater than 1 GHz. However, in the 1 MHz bands immediately outside and adjacent to the frequency block a resolution bandwidth of at least one percent of the emission bandwidth of the fundamental emission of the transmitter may be employed. The emission bandwidth is defined as the width of the signal between two points, one below the carrier center frequency and one above the carrier center frequency, outside of which all emission are attenuated at least 26 dB below the transmitter power.



















Plot 7-68. Conducted Spurious Plot (Band 13 - 10.0MHz QPSK - RB Size 1, RB Offset 0)














Plot 7-77. Conducted Spurious Plot (Band 5 - 10.0MHz QPSK - RB Size 1, RB Offset 0 - High Channel)










