2.1. Limit

47 CFR Part 15

Section § 15.247(d)

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in § 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in § 15.205(a), must also comply with the radiated emission limits specified in § 15.209(a) (see § 15.205(c)).

Except as provided elsewhere in this subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table:

in any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated device is operating, the RF power that is produced shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided that the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of root-mean-square averaging over a time interval, as permitted under section 5.4(d), the attenuation required shall be 30 dB instead of 20 dB. Attenuation below the general field strength limits specified in RSS-Gen is not required.

According to RSS-Gen Issue 5, 8.9, except where otherwise indicated in the applicable RSS, radiated emissions shall comply with the field strength limits shown in table 5 and table 6. Additionally, the level of any transmitter unwanted emission shall not exceed the level of the transmitter's fundamental emission.

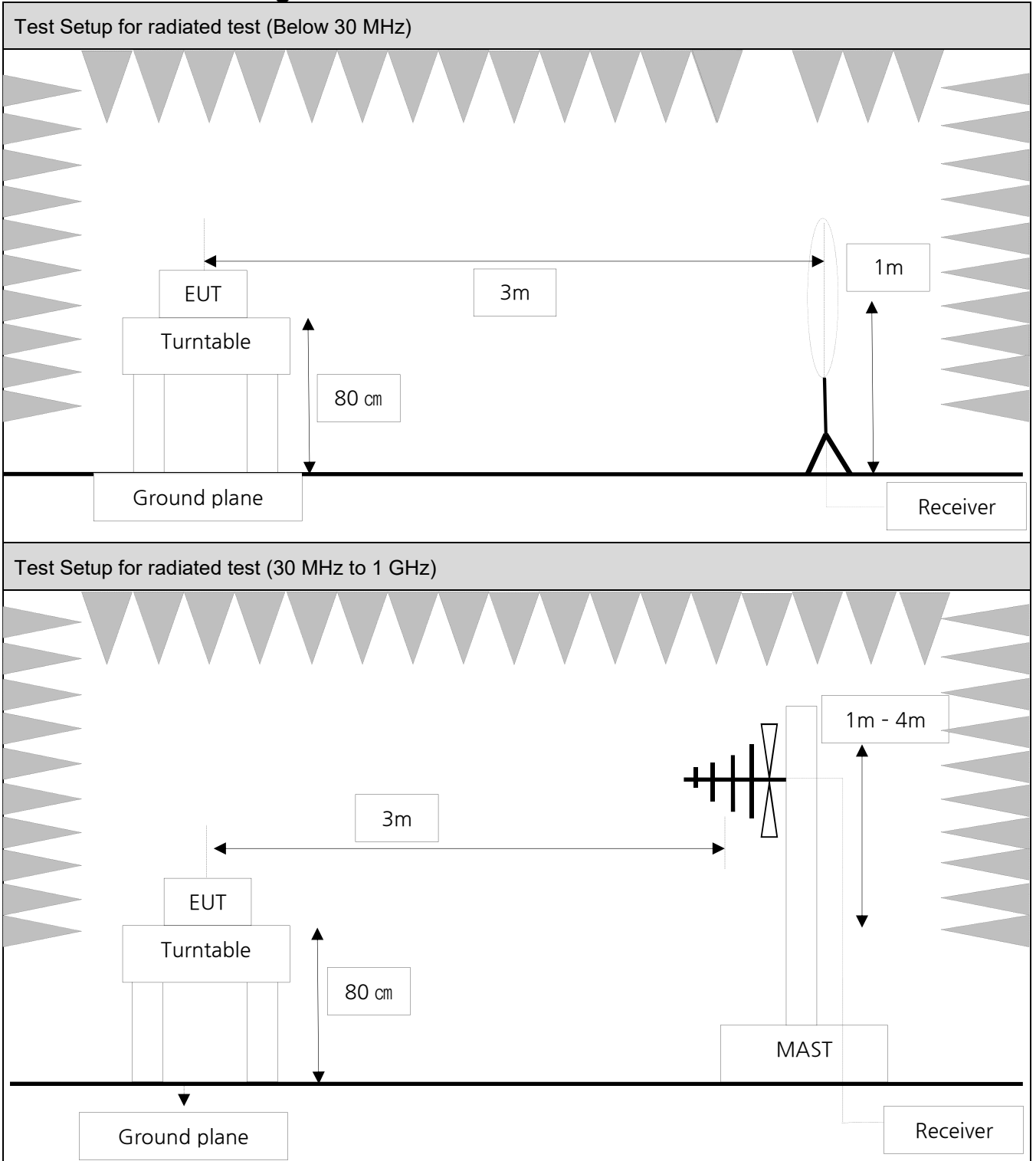

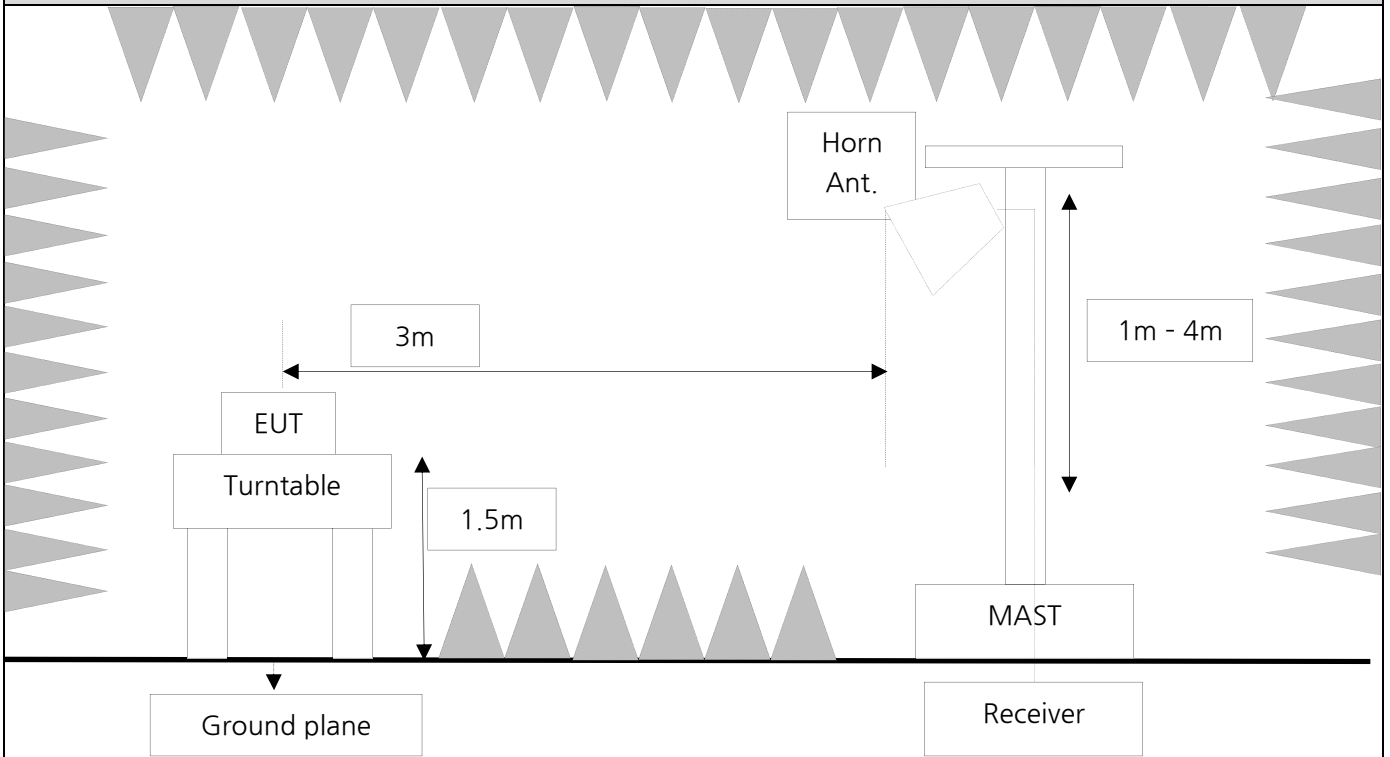

Radiated Emissions - 2 402 MHz (2nd Harmonic) (Peak)



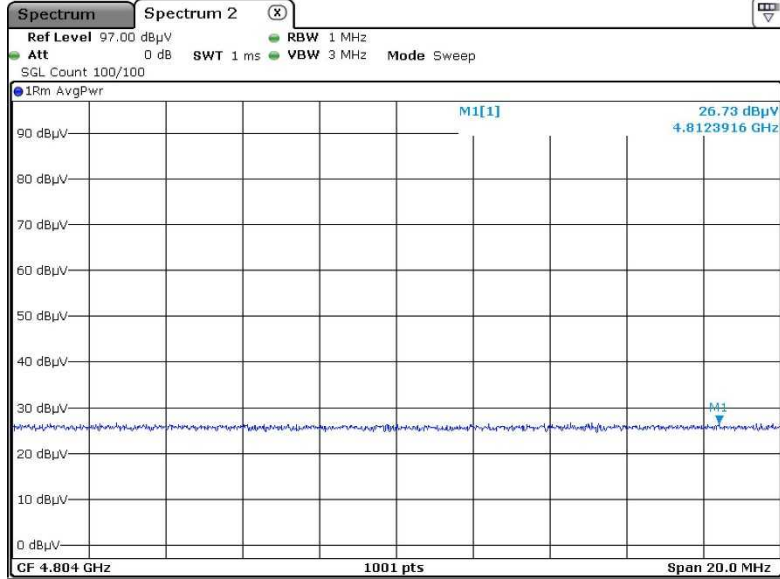

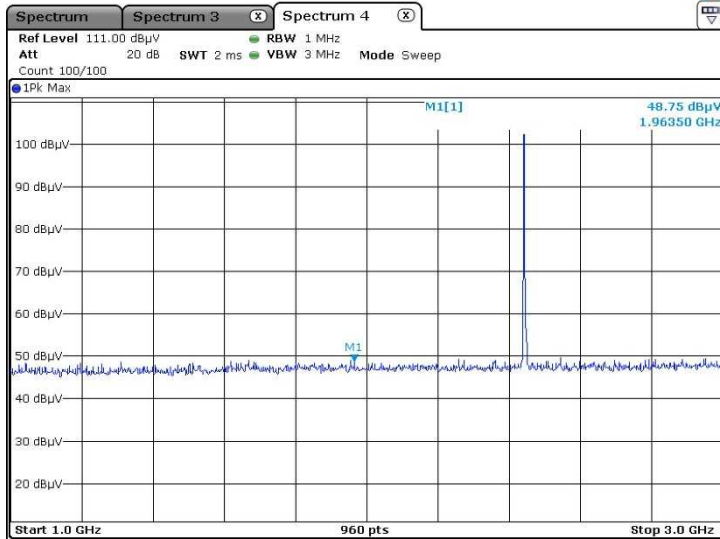

Radiated Emissions 1 GHz - 3 GHz - 2 440 MHz



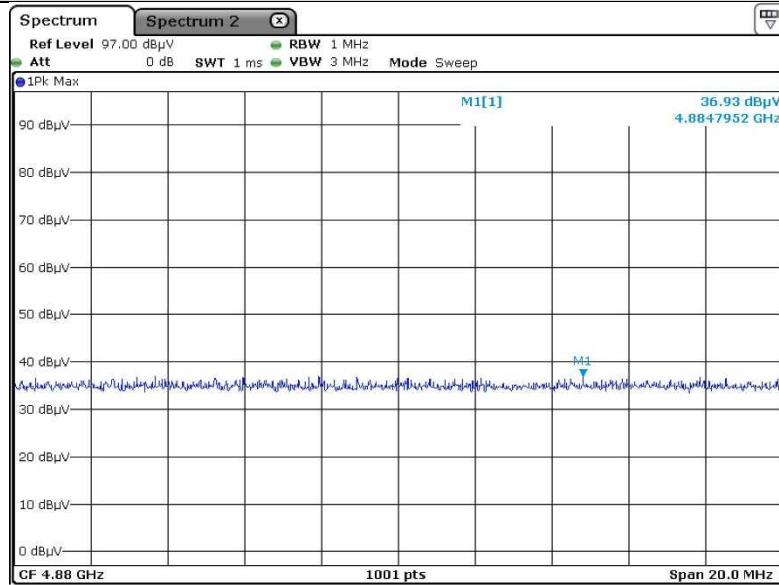

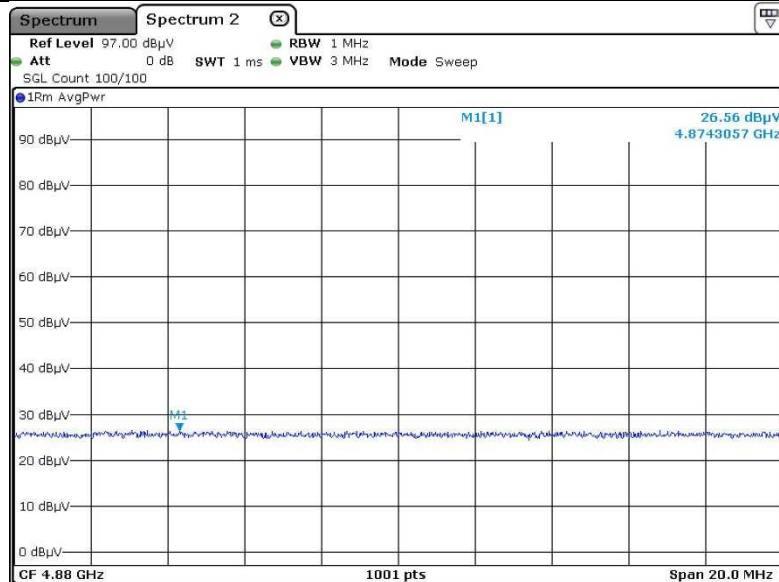

Radiated Emissions - 2 440 MHz (2nd Harmonic) (Average)



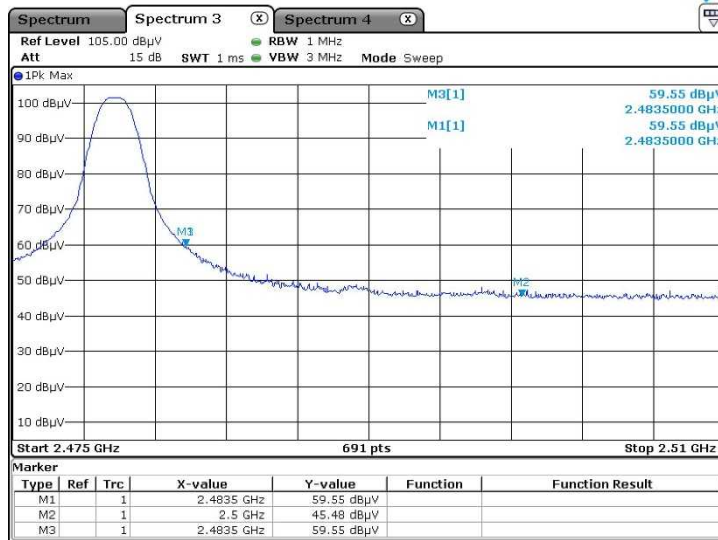

Radiated Emissions - 2 480 MHz (2nd Harmonic) (Peak)



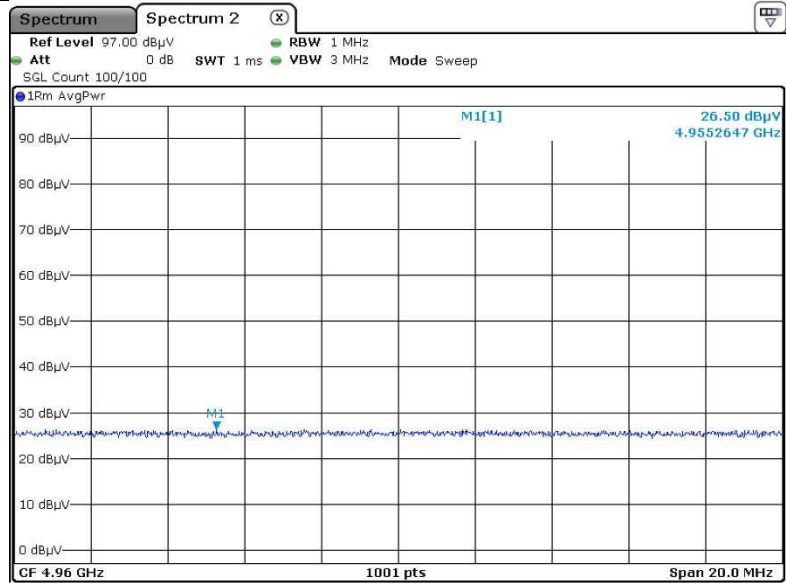

Radiated restricted band edge plot - 2 402 MHz (Average)



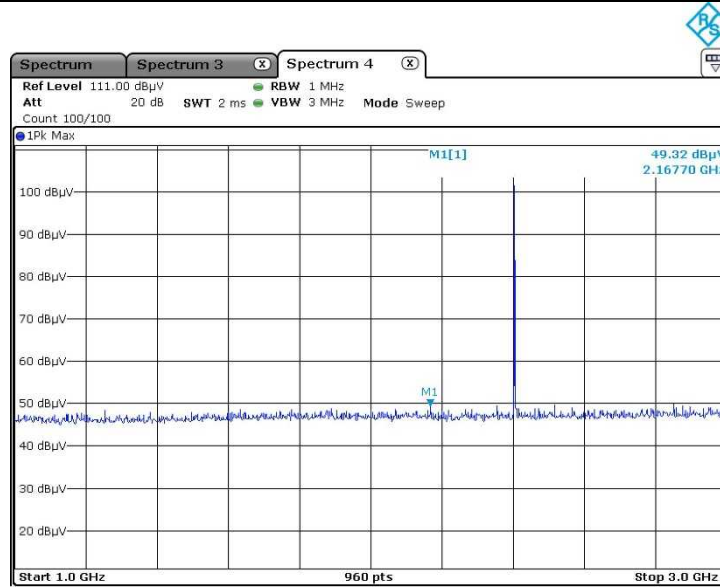

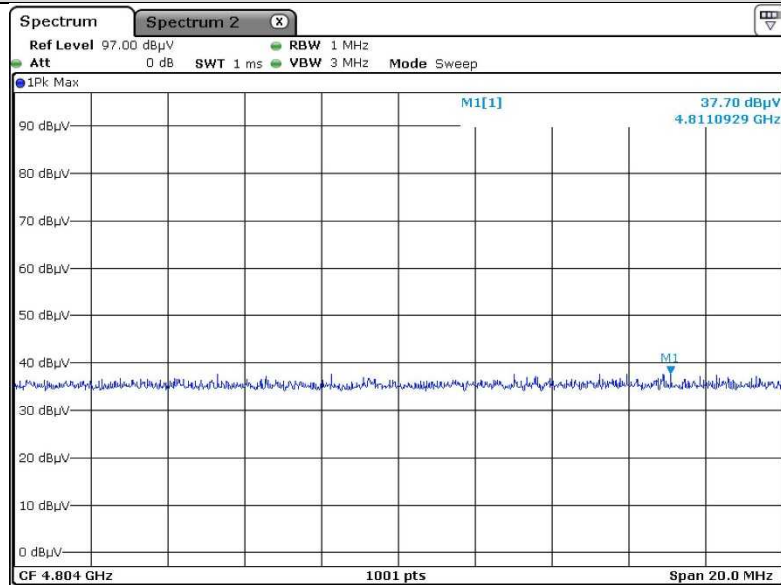

Radiated Emissions - 2 402 MHz (2nd Harmonic) (Peak)



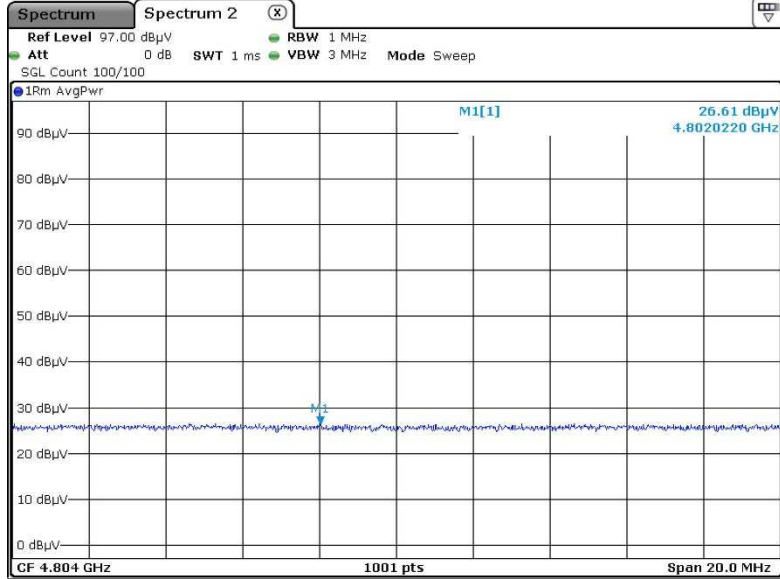

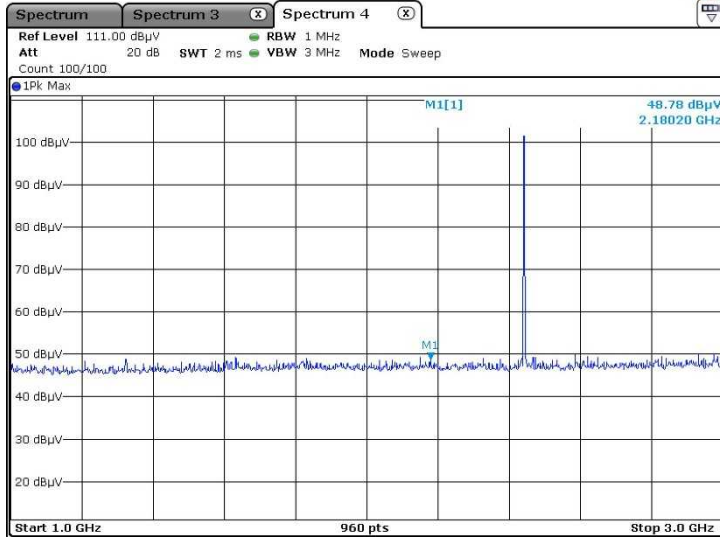

Radiated Emissions 1 GHz - 3 GHz - 2 440 MHz



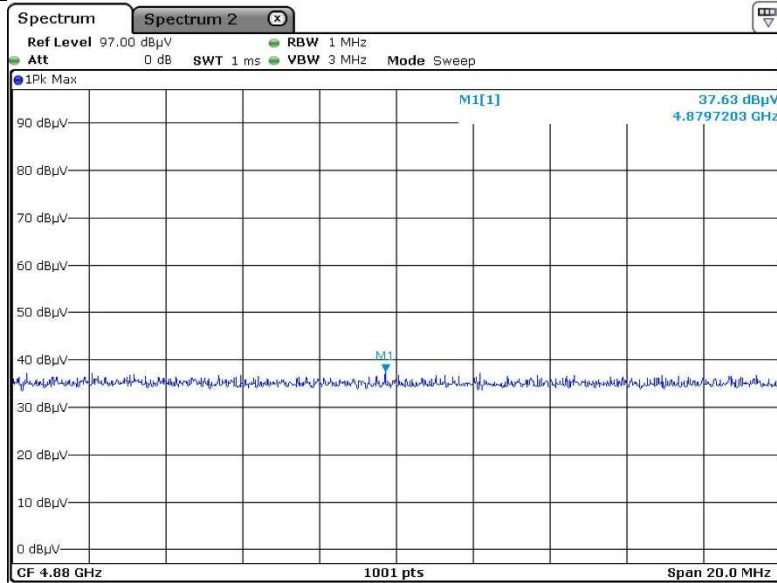

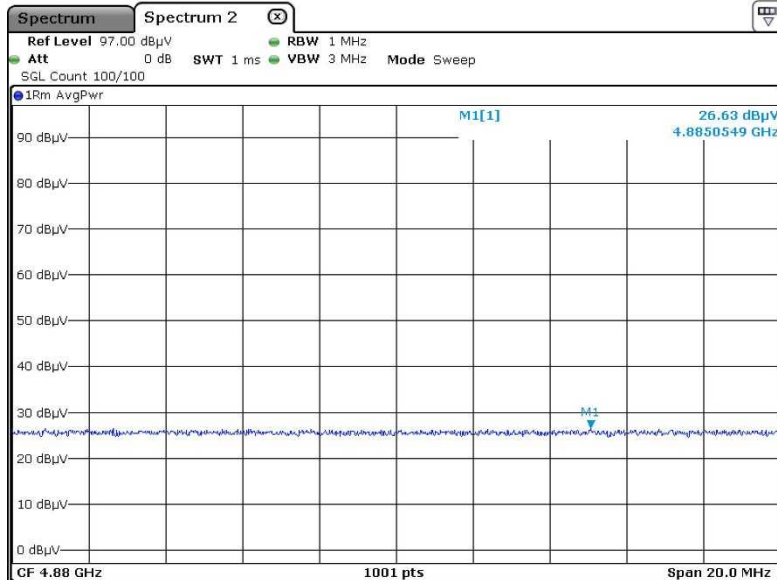

Radiated Emissions - 2 440 MHz (2nd Harmonic) (Average)



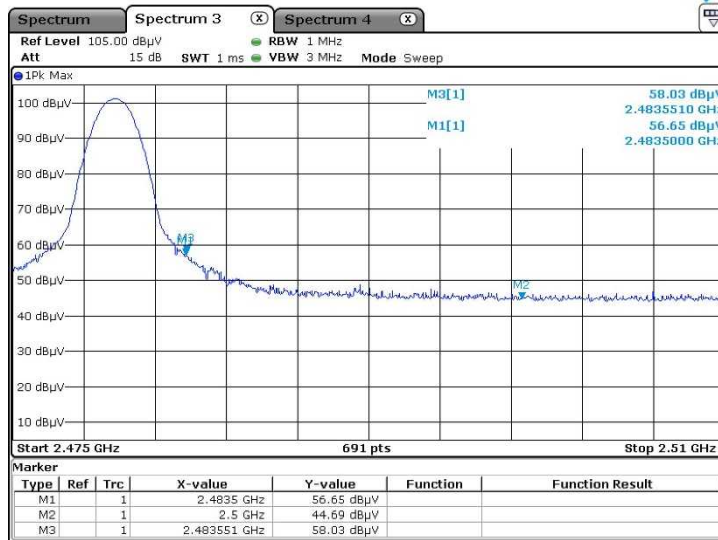

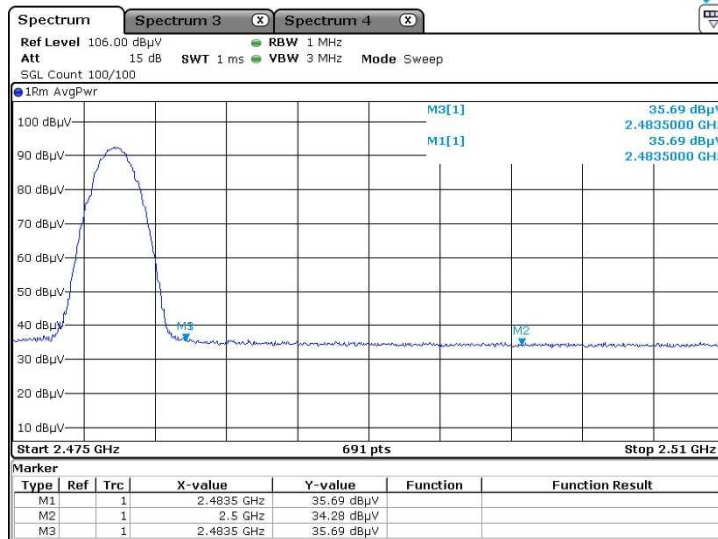

Radiated restricted band edge plot - 2 480 MHz (Average)



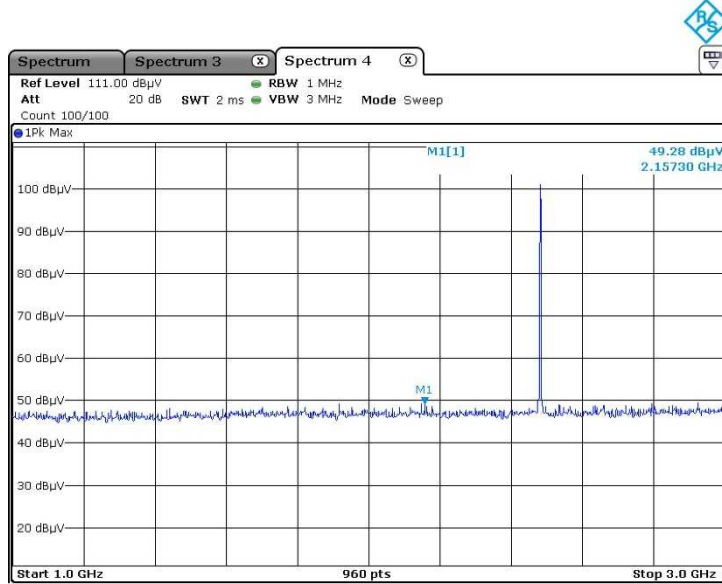

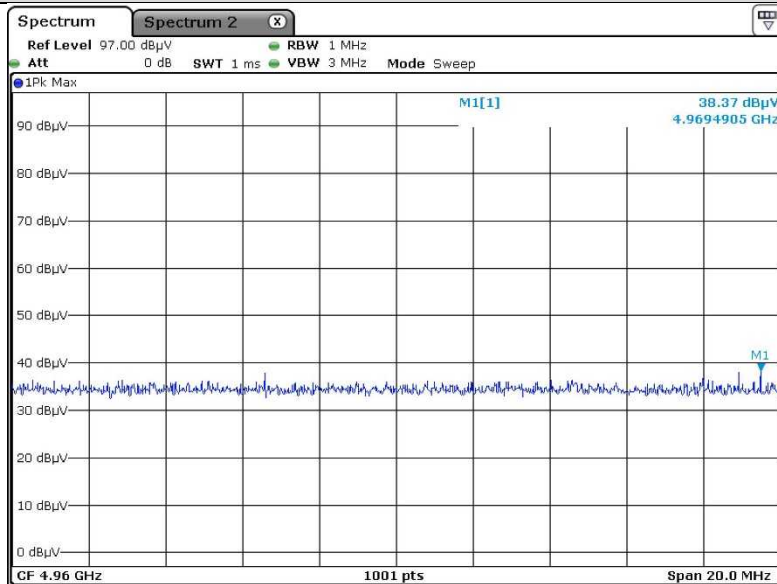

Radiated Emissions - 2 480 MHz (2nd Harmonic) (Peak)



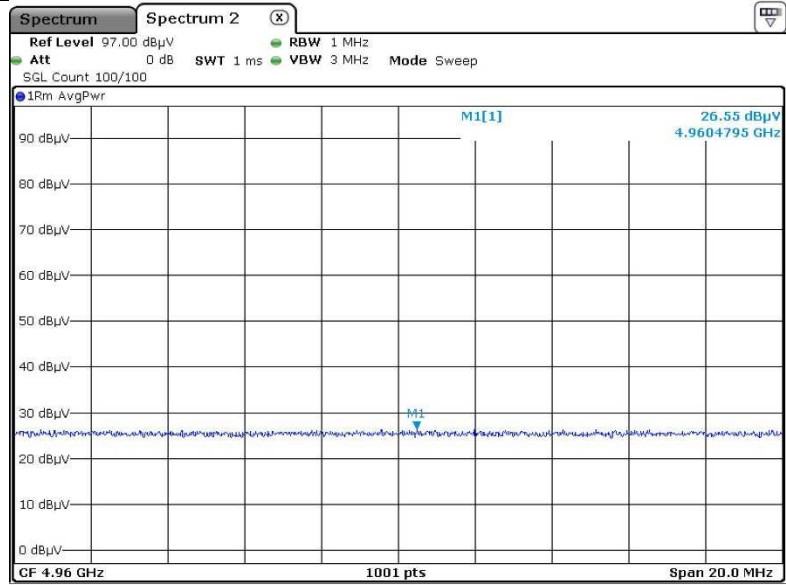

Radiated restricted band edge plot - 2 402 MHz (Average)



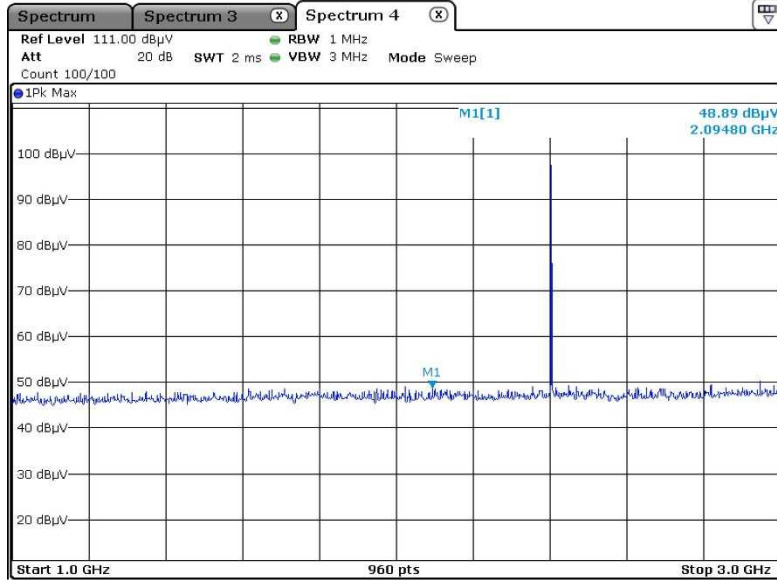

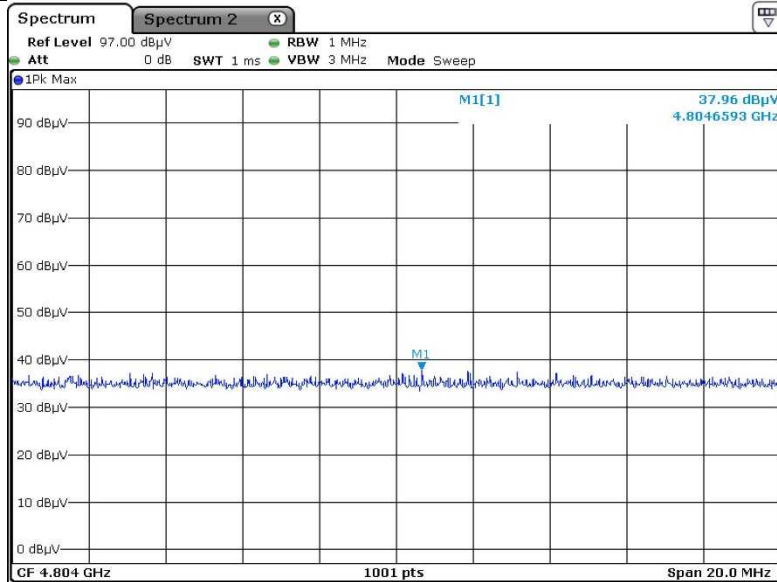

Radiated Emissions - 2 402 MHz (2nd Harmonic) (Peak)



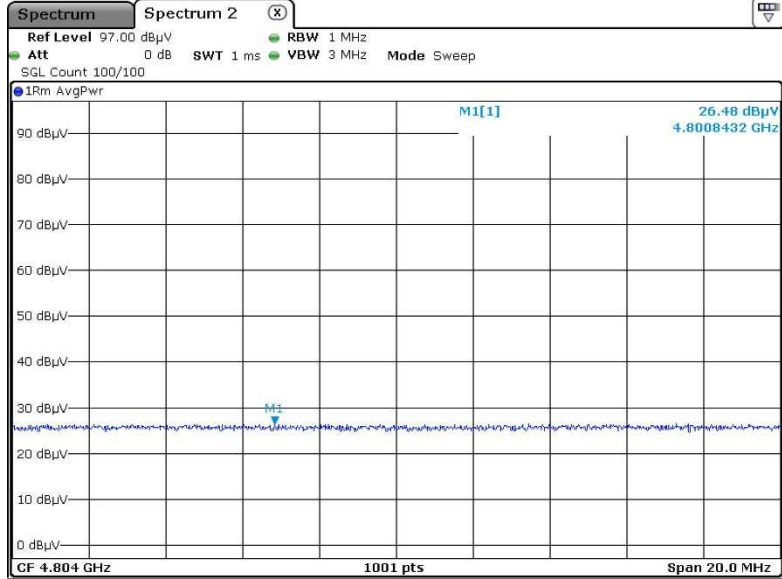

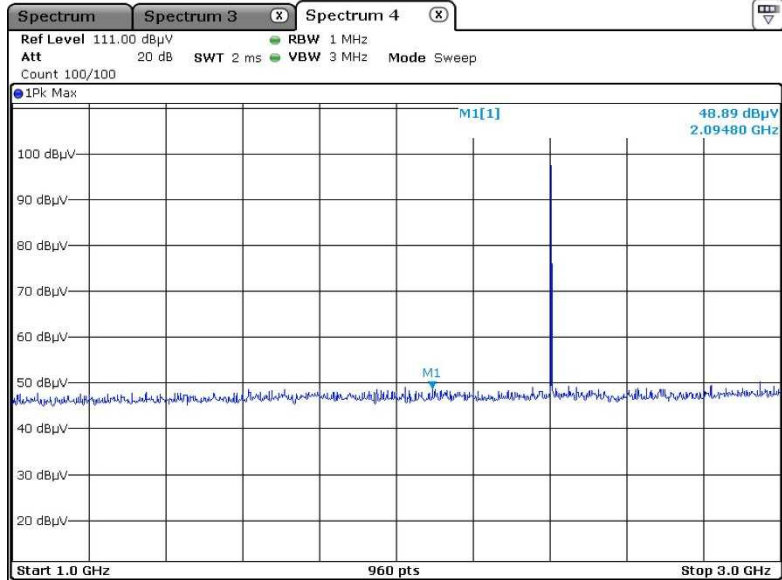

Radiated Emissions 1 GHz - 3 GHz - 2 440 MHz



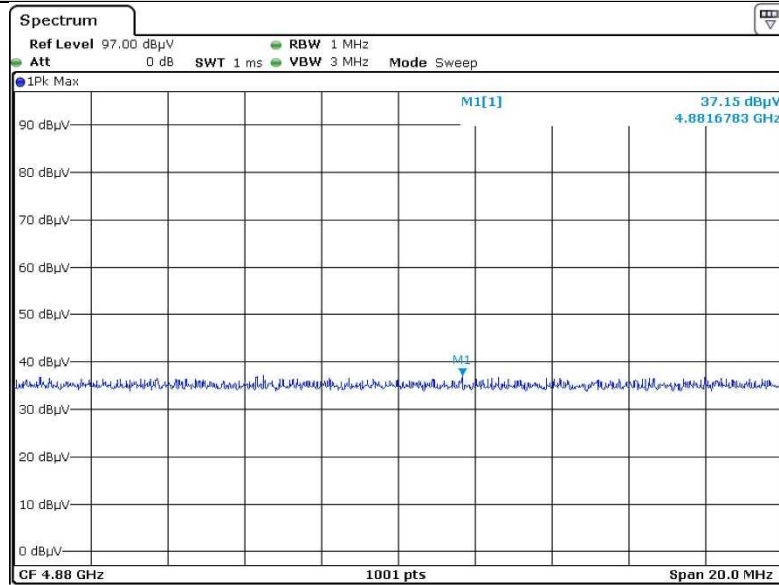

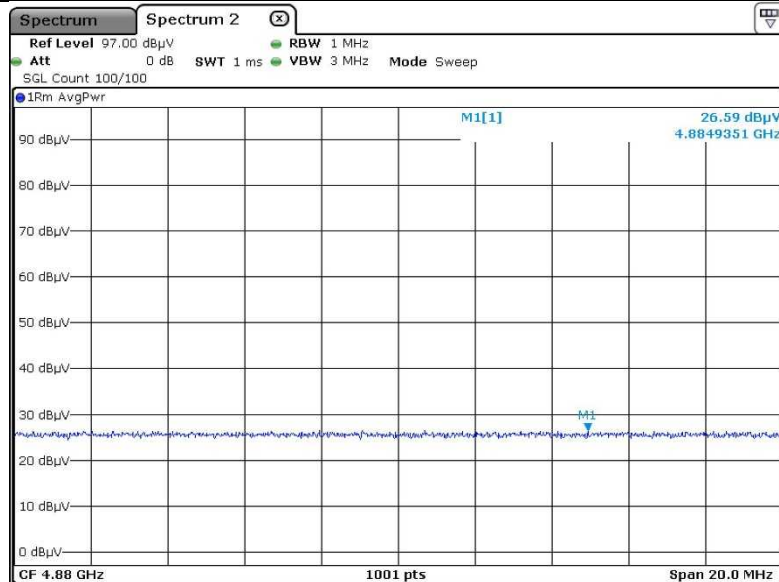

Radiated Emissions - 2 440 MHz (2nd Harmonic) (Average)



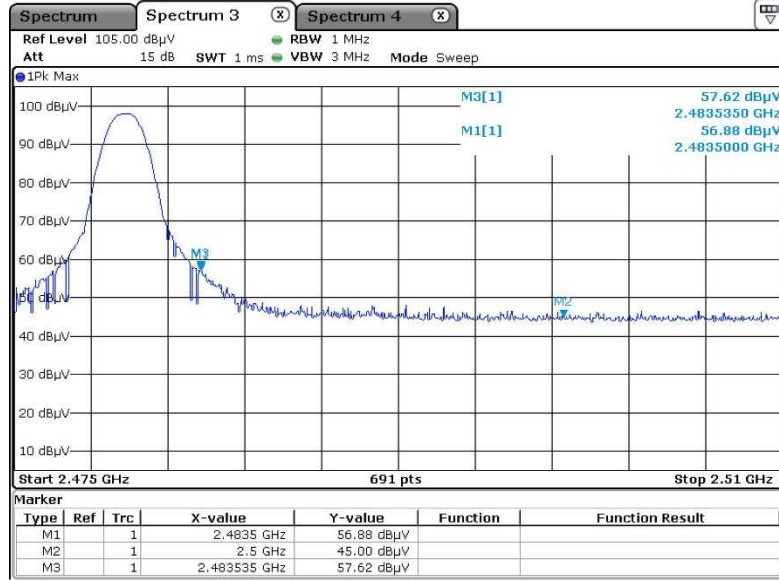

Radiated Emissions - 2 480 MHz (2nd Harmonic) (Peak)



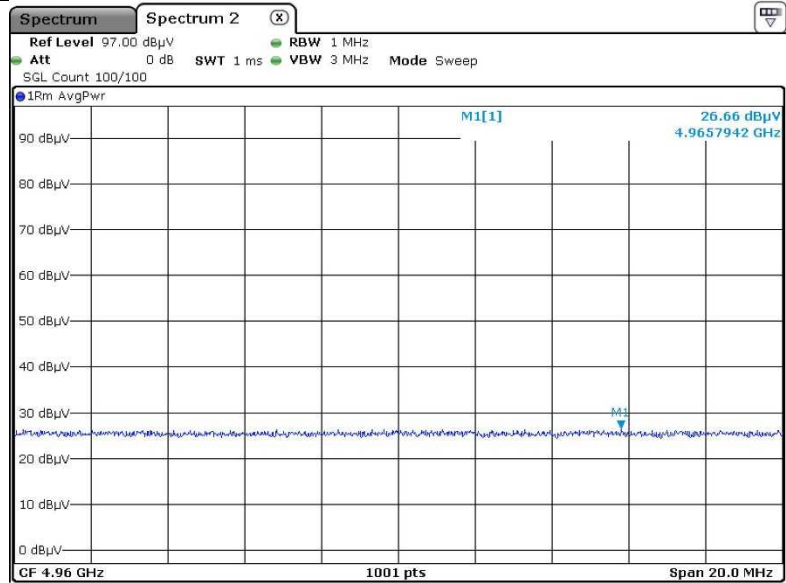

Radiated Emissions - 2 402 MHz (2nd Harmonic) (Peak)



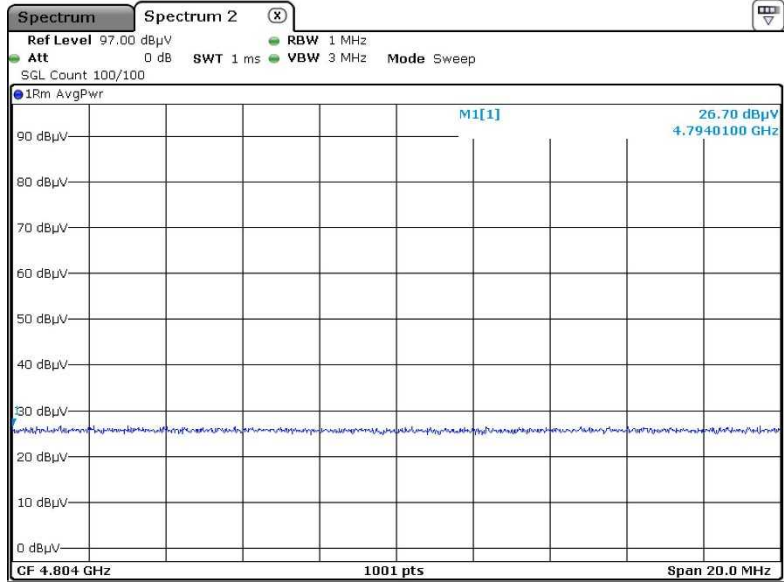

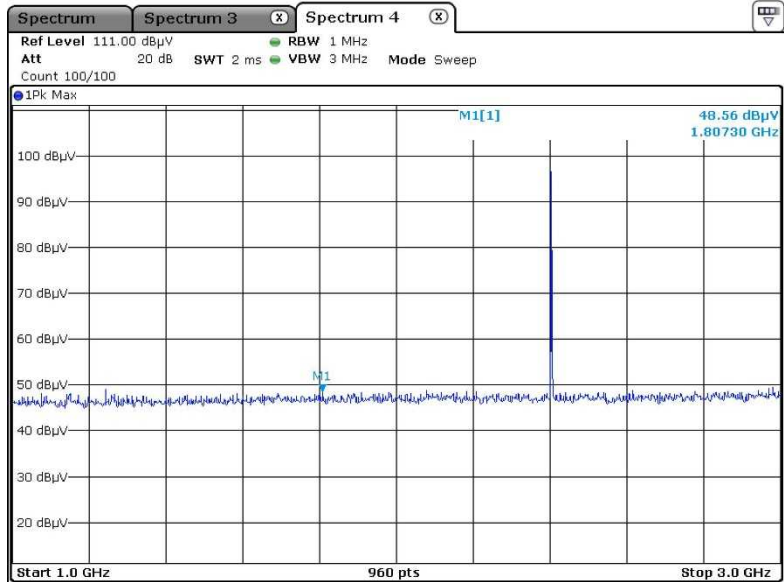

Radiated Emissions 1 GHz - 3 GHz - 2 440 MHz



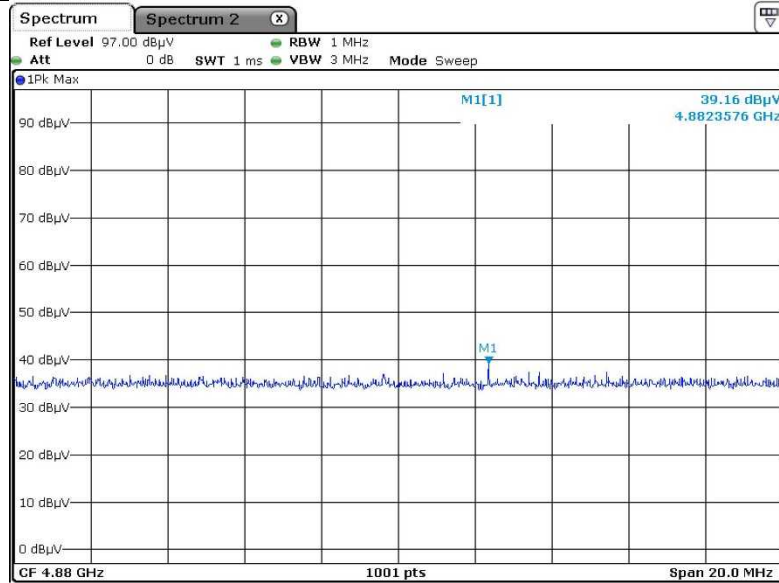

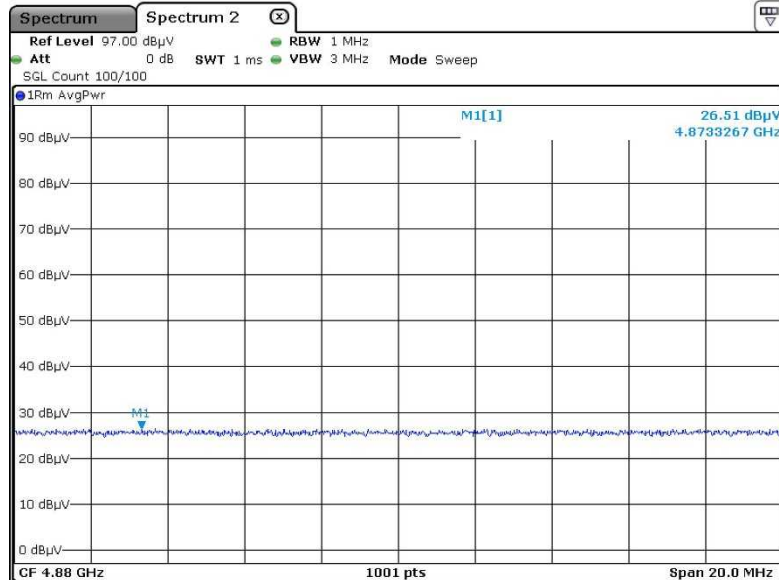

Radiated Emissions - 2 440 MHz (2nd Harmonic) (Average)



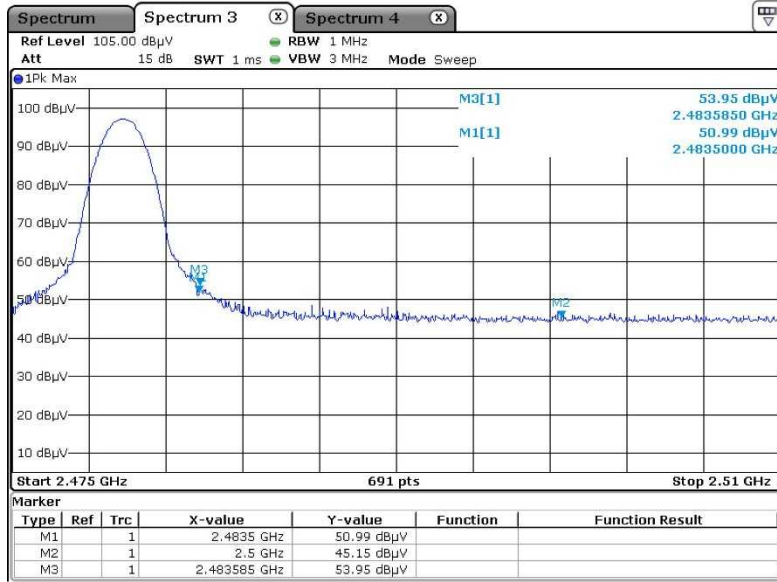

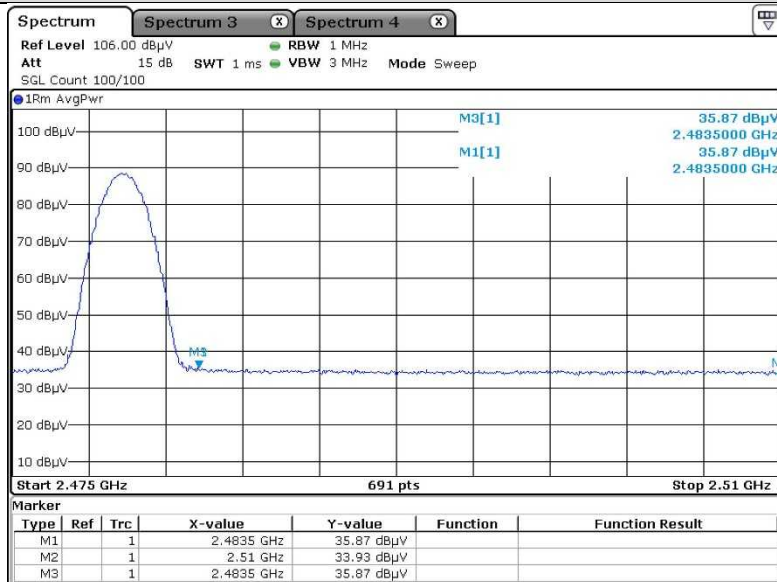

Radiated restricted band edge plot - 2 480 MHz (Average)



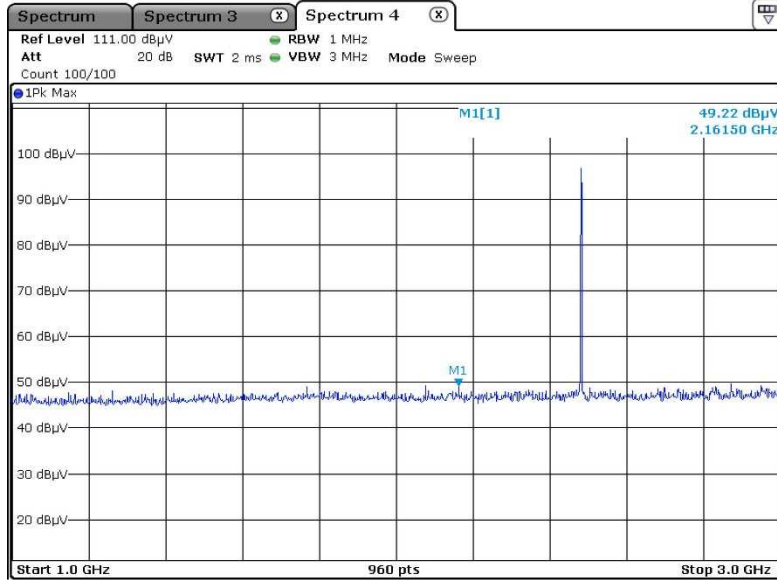

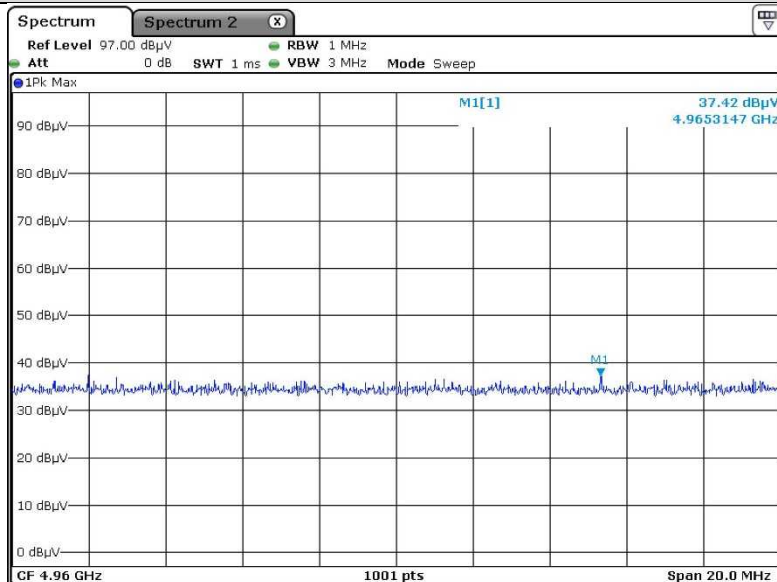

Radiated Emissions - 2 480 MHz (2nd Harmonic) (Peak)



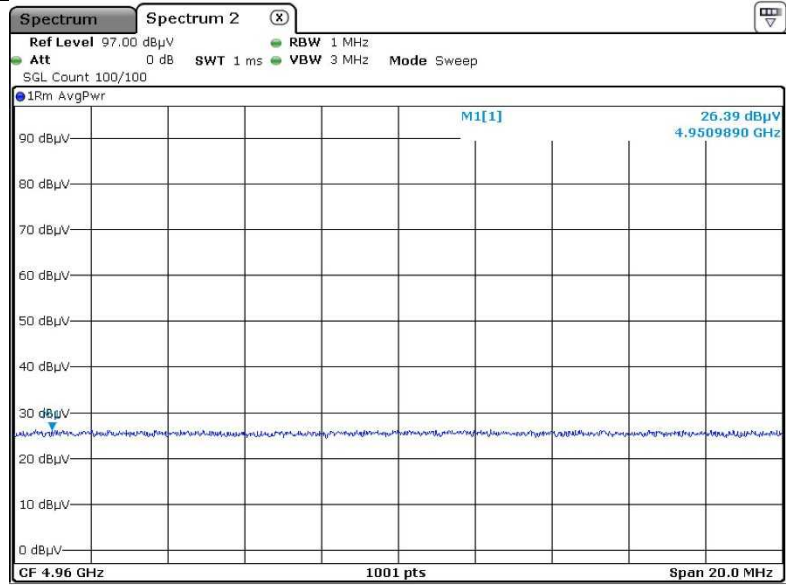

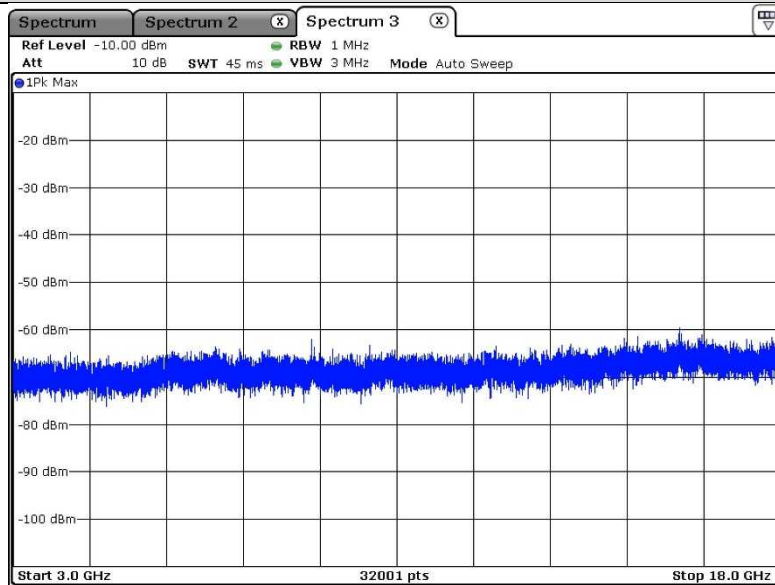

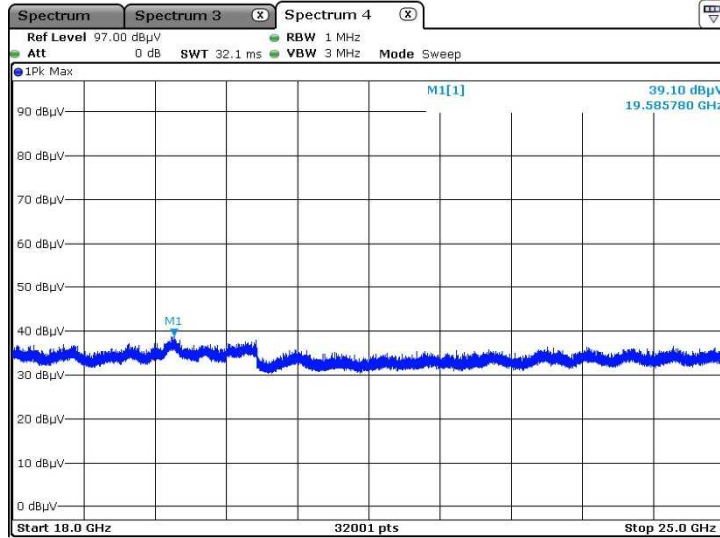
