INTRODUCTION 1.0

1.1 Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Innovation, Science and Economic Development Canada.

1.2 **PCTEST Test Location**

These measurement tests were conducted at the PCTEST Engineering Laboratory, Inc. facility located at 7185 Oakland Mills Road, Columbia, MD 21046. The measurement facility is compliant with the test site requirements specified in ANSI C63.4-2014.

1.3 Test Facility / Accreditations

Measurements were performed at PCTEST Engineering Lab located in Columbia, MD 21046, U.S.A.

2.3 **Test Configuration**

The EUT was tested per the guidance of KDB 789033 D02 v02r01. ANSI C63.10-2013 was used to reference the appropriate EUT setup for radiated spurious emissions testing. See Section Radiated Emissions for radiated emissions test setups.

This device supports wireless charging capability and, thus, is subject to the test requirements of KDB 648474 D03 v01r04. Additional radiated spurious emission measurements were performed with the EUT lying flat on an authorized wireless charging pad (WCP) FCC ID: PWMA-W815A while operating under normal conditions in a simulated call or data transmission configuration. The worst case radiated emissions data is shown in this report.

3.0 DESCRIPTION OF TESTS

3.1 Evaluation Procedure

The measurement procedures described in the American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices (ANSI C63.10-2013) and the guidance provided in KDB 789033 D02 v02r01 were used in the measurement of the EUT.

3.2 Radiated Emissions

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. The test site inside the chamber is a 6m x 5.2m elliptical, obstruction-free area in accordance with Figure 5.7 of Clause 5 in ANSI C63.4-2014. Absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections for measurements above 1GHz. An 80cm tall test table made of Styrodur is placed on top of the turn table. For measurements above 1GHz, an additional Styrodur pedestal is placed on top of the test table to bring the total table height to 1.5m.

For all measurements, the spectrum was scanned through all EUT azimuths and from 1 to 4 meter receive antenna height using a broadband antenna from 30MHz up to the upper frequency shown in 15.33 depending on the highest frequency generated or used in the device or on which the device operates or tunes. For frequencies above 1GHz, linearly polarized double ridge horn antennas were used. For frequencies below 30MHz, a calibrated loop antenna was used. When exploratory measurements were necessary, they were performed at 1 meter test distance inside the semi-anechoic chamber using broadband antennas, broadband amplifiers, and spectrum analyzers to determine the frequencies and modes producing the maximum emissions. Sufficient time for the EUT, support equipment, and test equipment was allowed in order for them to warm up to their normal operating condition. The test set-up was placed on top of the 1 x 1.5 meter table. The EUT, support equipment, and interconnecting cables were arranged and manipulated to maximize each emission. Appropriate precaution was taken to ensure that all emissions from the EUT were maximized and investigated. The system configuration, mode of operation, turntable azimuth, and receive antenna height was noted for each frequency found.

Final measurements were made in the semi-anechoic chamber using calibrated, linearly polarized broadband and horn antennas. The test setup was configured to the setup that produced the worst case emissions. The spectrum analyzer was set to investigate all frequencies required for testing to compare the highest radiated disturbances with respect to the specified limits. The turntable containing the EUT was rotated through 360 degrees and the height of the receive antenna was varied 1 to 4 meters and stopped at the azimuth and height producing the maximum emission. Each emission was maximized by changing the orientation of the EUT through three orthogonal planes and changing the polarity of the receive antenna, whichever produced the worst-case emissions.

All radiated measurements are performed in a chamber that meets the site requirements per ANSI C63.4-2014. Additionally, radiated emissions below 30MHz are also validated on an Open Area Test Site to assert correlation with the chamber measurements per the requirements of KDB 474788 D01.

3.3 Environmental Conditions

The temperature is controlled within range of 15°C to 35°C. The relative humidity is controlled within range of 10% to 75%. The atmospheric pressure is monitored within the range 86-106kPa (860-1060mbar).

7.2 Radiated Spurious Emission Measurements – Above 1GHz §15.407(b) §15.205 §15.209; RSS-Gen [8.9]

Test Overview and Limit

All out of band radiated spurious emissions are measured with a spectrum analyzer connected to a receive antenna while the EUT is operating at its maximum duty cycle, at its maximum power control level, as defined in ANSI C63.10-2013 and KDB 789033 D02 v02r01, and at the appropriate frequencies. All channels, modes (e.g. 802.11a, 802.11n (20MHz BW), 802.11n (40MHz BW), and 802.11ac (80MHz)), and modulations/data rates were investigated among all UNII bands. Only the radiated emissions of the configuration that produced the worst case emissions are reported in this section.

For transmitters operating in the 5.15-5.25 GHz and 5.25-5.35 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an EIRP of -27 dBm/MHz.

For transmitters operating in the 5.47-5.725 GHz band: All emissions outside of the 5.47-5.725 GHz band shall not exceed an EIRP of -27 dBm/MHz.

For transmitters operating in the 5.725-5.85 GHz band: All emissions shall be limited to a level of -27 dBm/MHz at 75 MHz or more above or below the band edge increasing linearly to 10 dBm/MHz at 25 MHz above or below the band edge, and from 25 MHz above or below the band edge increasing linearly to a level of 15.6 dBm/MHz at 5 MHz above or below the band edge, and from 5 MHz above or below the band edge increasing linearly to a level of 27 dBm/MHz at the band edge.




Figure 7-1. Test Instrument & Measurement Setup

- 1. All emissions that lie in the restricted bands (denoted by a * next to the frequency) specified in §15.205 and Section 8.10 of RSS-Gen are below the limit shown in Table 7-30.
- 2. All spurious emissions lying in restricted bands specified in §15.205 and Section 8.10 of RSS-Gen are below the limit shown in Table 7-30. Since the emissions produced from MIMO operation were found to be more than 20dB below the limit, the MIMO emissions are not reported.
- 8. The wide spectrum spurious emissions plots shown on the following pages are used only for the purpose of emission identification. Any emissions found to be within 20dB of the limit are fully investigated and the results are shown in this section.
- 9. The "-" shown in the following RSE tables are used to denote a noise floor measurement.







Plot 7-1. Radiated Spurious Plot above 1GHz SISO ANT1 (802.11a - U1 Ch. 40)




Plot 7-2. Radiated Spurious Plot above 1GHz SISO ANT1 (802.11a - U2A Ch. 56)




Plot 7-4. Radiated Spurious Plot above 1GHz SISO ANT1 (802.11a - U3 Ch. 157)









Plot 7-7. Radiated Spurious Plot above 1GHz SISO ANT2 (802.11a - U1 Ch. 40)




Plot 7-8. Radiated Spurious Plot above 1GHz SISO ANT2 (802.11a - U2A Ch. 56)




Plot 7-10. Radiated Spurious Plot above 1GHz SISO ANT2 (802.11a - U3 Ch. 157)






Plot 7-13. Radiated Spurious Plot above 1GHz (2.4GHz - 5GHz)


Plot 7-15. Radiated Spurious Plot above 26.5GHz (2.4GHz - 5GHz)

Plot 7-16. Radiated Lower Band Edge Plot SISO ANT1 (Average - UNII Band 1)




Plot 7-17. Radiated Lower Band Edge Plot SISO ANT1 (Peak - UNII Band 1)






Plot 7-20. Radiated Lower Band Edge Plot SISO ANT1 (Average – UNII Band 2C)




Plot 7-22. Radiated Upper Band Edge Plot SISO ANT1 (Peak – UNII Band 3)








Plot 7-25. Radiated Lower Band Edge Plot SISO ANT1 (Average - UNII Band 1)




Plot 7-26. Radiated Lower Band Edge Plot SISO ANT1 (Peak - UNII Band 1)

Plot 7-27. Radiated Upper Band Edge Plot SISO ANT1 (Average - UNII Band 2A)




Plot 7-28. Radiated Upper Band Edge Plot SISO ANT1 (Peak - UNII Band 2A)




Plot 7-29. Radiated Lower Band Edge Plot SISO ANT1 (Average - UNII Band 2C)




Plot 7-31. Radiated Upper Band Edge Plot SISO ANT1 (Peak - UNII Band 3)



Plot 7-32. Radiated Band Edge Plot SISO ANT1 (Average - WCP)










Plot 7-34. Radiated Lower Band Edge Plot SISO ANT1 (Average - UNII Band 1)




Plot 7-35. Radiated Lower Band Edge Plot SISO ANT1 (Peak - UNII Band 1)




Plot 7-38. Radiated Lower Band Edge Plot SISO ANT1 (Average – UNII Band 2C)




Plot 7-43. Radiated Lower Band Edge Plot SISO ANT2 (Average – UNII Band 1)




Plot 7-44. Radiated Lower Band Edge Plot SISO ANT2 (Peak – UNII Band 1)






Plot 7-47. Radiated Lower Band Edge Plot SISO ANT2 (Average – UNII Band 2C)




Plot 7-56. Radiated Lower Band Edge Plot SISO ANT2 (Average – UNII Band 2C)






Plot 7-74. Radiated Lower Band Edge Plot CDD (Average – UNII Band 2C)






Plot 7-79. Radiated Lower Band Edge Plot MIMO (Average – UNII Band 1)




Plot 7-80. Radiated Lower Band Edge Plot MIMO (Peak – UNII Band 1)






Plot 7-83. Radiated Lower Band Edge Plot MIMO (Average – UNII Band 2C)


Plot 7-85. Radiated Upper Band Edge Plot MIMO (Peak – UNII Band 3)



Plot 7-86. Radiated Band Edge Plot MIMO (Average – WCP)




Plot 7-87. Radiated Band Edge Plot MIMO (Peak – WCP)






Plot 7-88. Radiated Lower Band Edge Plot MIMO (Average - UNII Band 1)




Plot 7-89. Radiated Lower Band Edge Plot MIMO (Peak - UNII Band 1)

Plot 7-90. Radiated Upper Band Edge Plot MIMO (Average - UNII Band 2A)




Plot 7-91. Radiated Upper Band Edge Plot MIMO (Peak - UNII Band 2A)




Plot 7-92. Radiated Lower Band Edge Plot MIMO (Average – UNII Band 2C)




Plot 7-97. Radiated Lower Band Edge Plot MIMO (Average – UNII Band 1)




Plot 7-98. Radiated Lower Band Edge Plot MIMO (Peak – UNII Band 1)


Plot 7-102. Radiated Lower Band Edge Plot MIMO (Peak - UNII Band 2C)






Figure 7-2. Radiated Test Setup < 30MHz




Figure 7-3. Radiated Test Setup < 1GHz






Plot 7-106. Radiated Spurious Plot below 1GHz SISO ANT1 (802.11a - U3 Ch. 157)




Plot 7-107. Radiated Spurious Plot below 1GHz SISO ANT2 (802.11a - U3 Ch. 157)
