### Product Description for Equipment under Test (EUT)

The *b mobile HK Limited*'s product, model number: AX675 (FCC ID: ZSW-30-023) or the "EUT" in this report was a *Mobile Phone*, which was measured approximately: 125 mm (L) × 64.6 mm (W) × 11.9 mm (H), rated with input voltage: DC 3.7V rechargeable Li-ion battery or DC 5.0V from adapter.

#### Adapter Information:

Input: AC 100-240V, 50/60Hz, 0.15A

Output: DC 5.0V, 500mA

### Objective

This type approval report is prepared on behalf of *b mobile HK Limited* in accordance with Part 2, Part 22-Subpart H, Part 24-Subpart E and Part 27 of the Federal Communication Commissions rules.

The objective is to determine the compliance of EUT with FCC rules for output power, modulation characteristic, occupied bandwidth, and spurious emission at antenna terminal, spurious radiated emission, frequency stability, and band edge.

### Test Methodology

All tests and measurements indicated in this document were performed in accordance with the Code of Federal Regulations Title 47 Part 2, Sub-part J as well as the following parts:

Part 22 Subpart H - Public Mobile Services

Part 24 Subpart E - Personal Communication Services

Part 27 – Miscellaneous wireless communications services

Applicable Standards: TIA/EIA 603-D, ANSI C63.4-2014.

All radiated and conducted emissions measurements were performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.91 dB for 30MHz-1GHz and 4.92 dB for above 1GHz, 1.95dB for conducted measurement.

## **Test Facility**

The Test site used by Bay Area Compliance Laboratories Corp.(Shenzhen) to collect test data is located in the 6/F, the 3rd Phase of WanLi Industrial Building, ShiHua Road, FuTian Free Trade Zone Shenzhen, Guangdong, China.

Test site at Bay Area Compliance Laboratories Corp. (Shenzhen) has been fully described in reports submitted to the Federal Communication Commission (FCC). 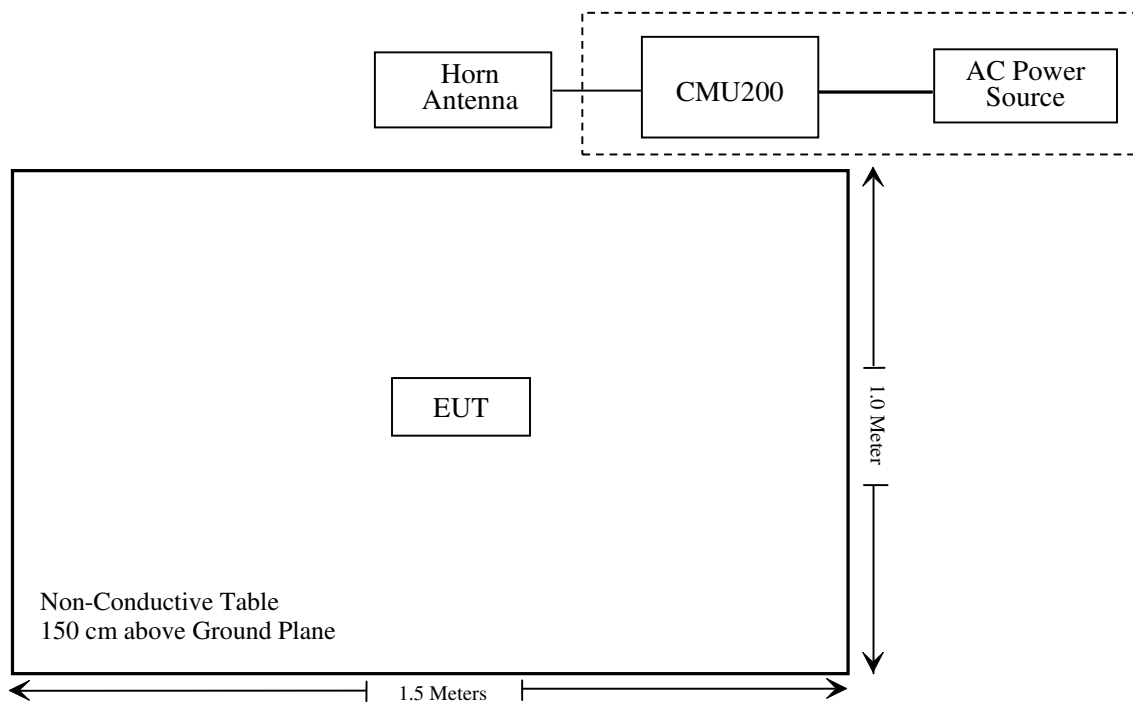

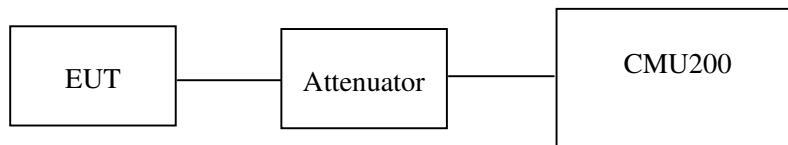
According to §27.50(d), the maximum EIRP must not exceed 1Watts (30dBm) for 1710-1755MHz. The peak-to-average power ratio (PAPR) of the transmitter output power must not exceed 13 dB.

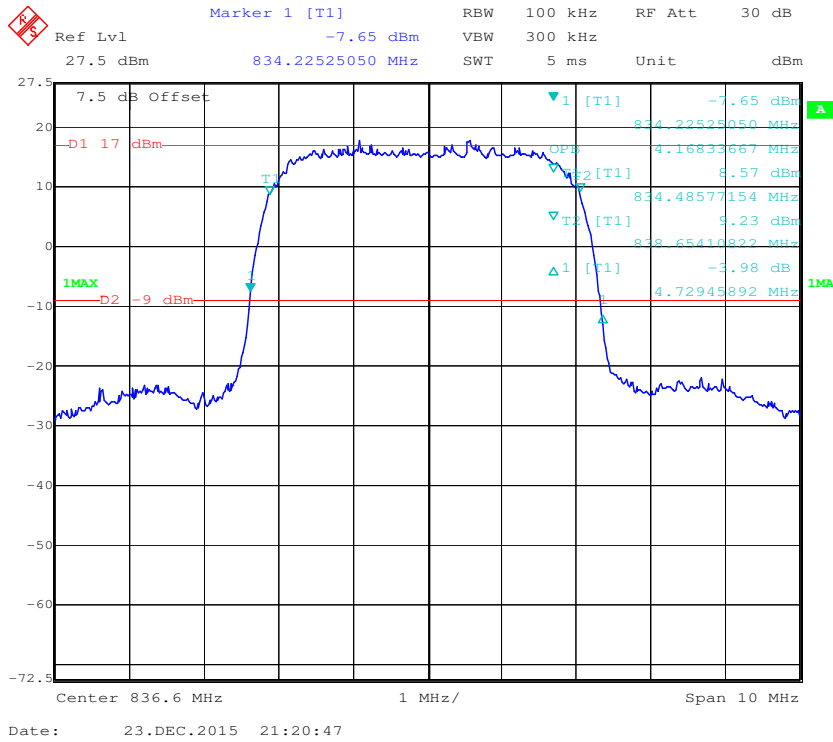
**99% Occupied & 26 dB Emissions Bandwidth for GSM (GMSK) Mode**



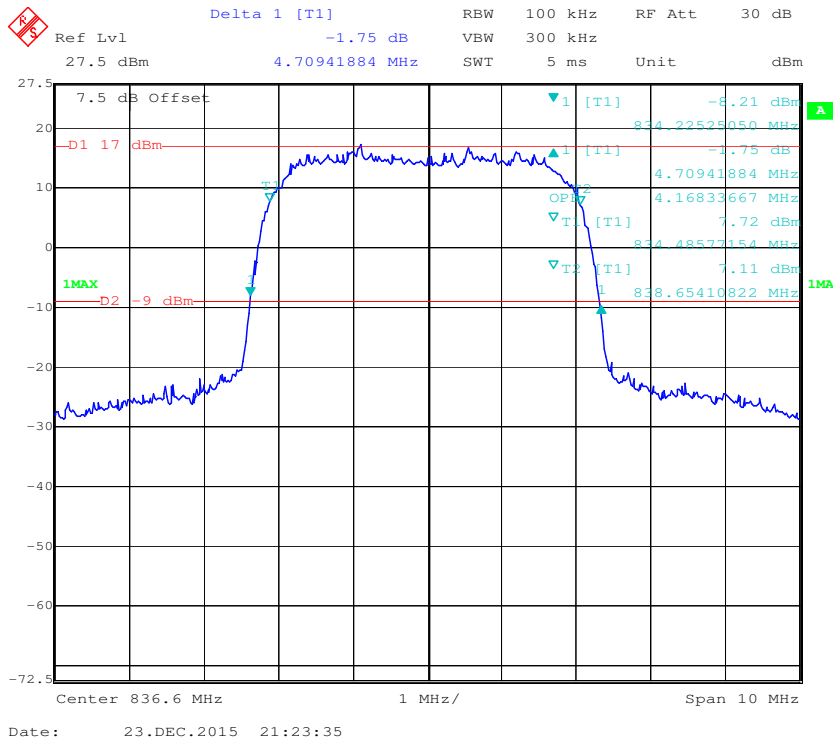
**99% Occupied & 26 dB Emissions Bandwidth for EDGE Mode**



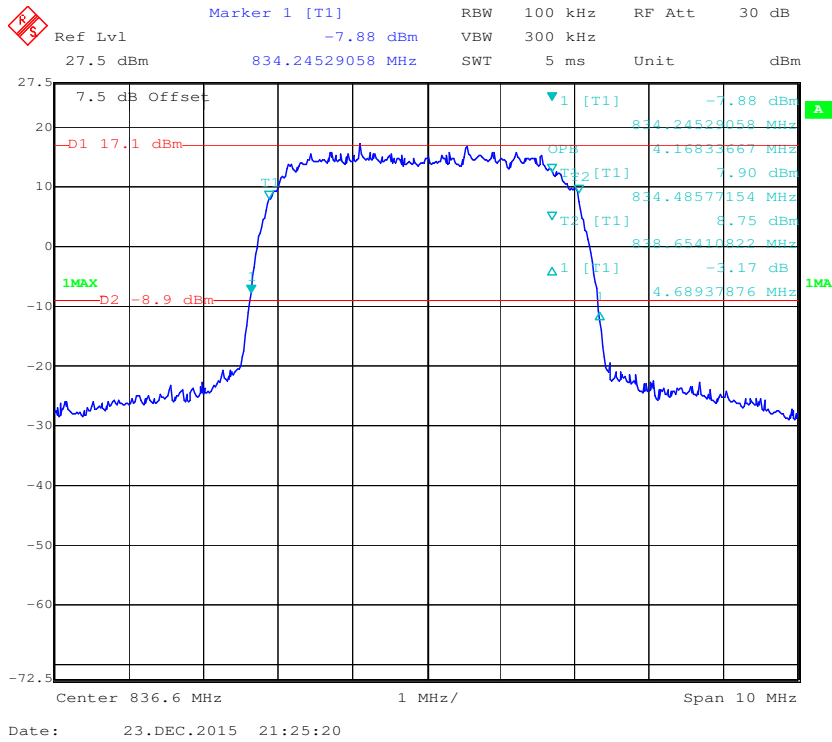
**99% Occupied & 26 dB Emissions Bandwidth for WCDMA (BPSK) Mode**



**99% Occupied & 26 dB Emissions Bandwidth for HSUPA (BPSK) Mode**

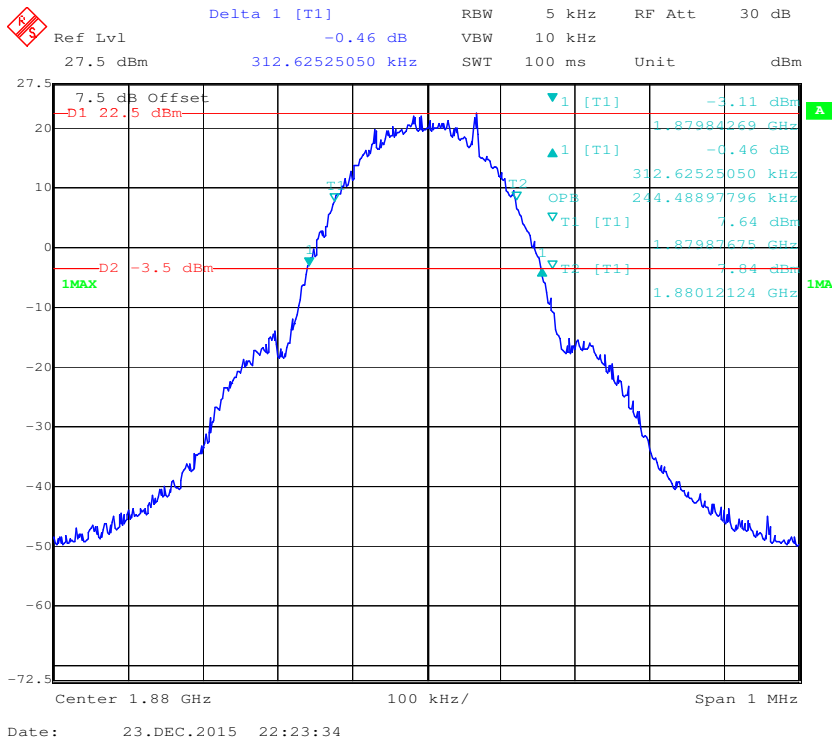


**99% Occupied & 26 dB Emissions Bandwidth for HSDPA (16QAM) Mode**

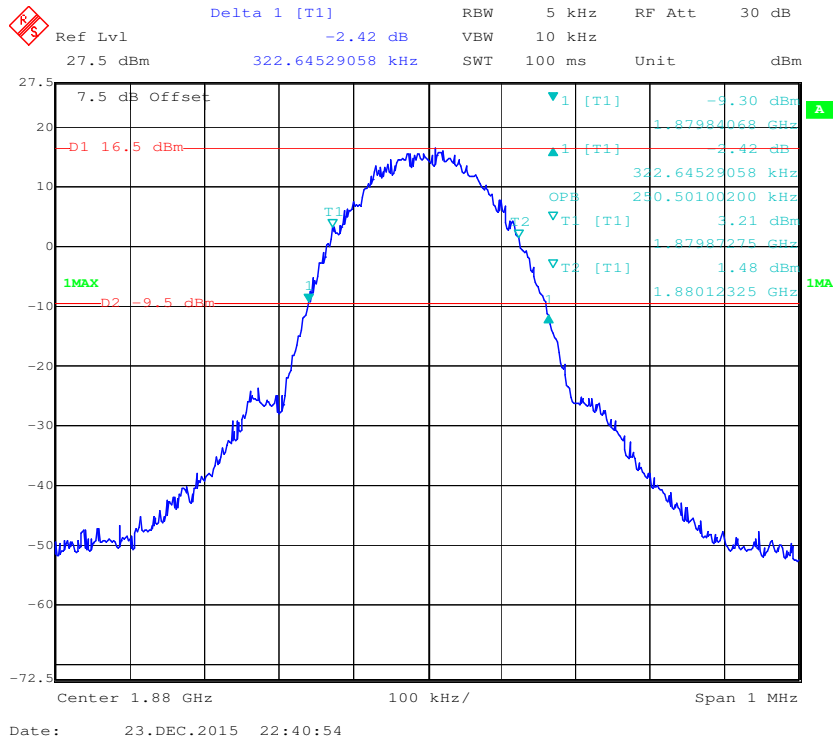

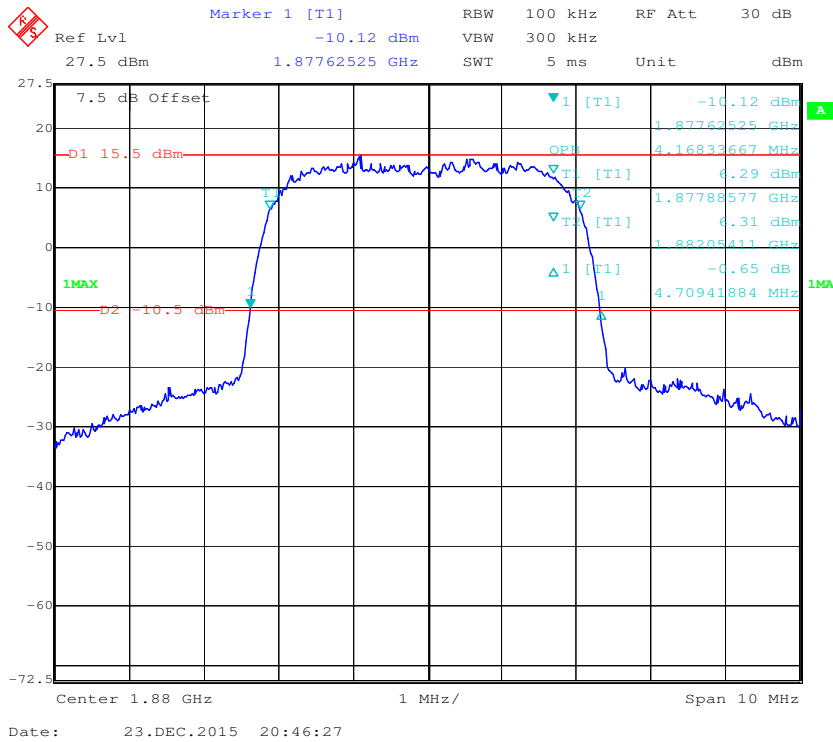
**99% Occupied & 26 dB Emissions Bandwidth for GSM (GMSK) Mode**



**99% Occupied & 26 dB Emissions Bandwidth for EGPRS Mode**

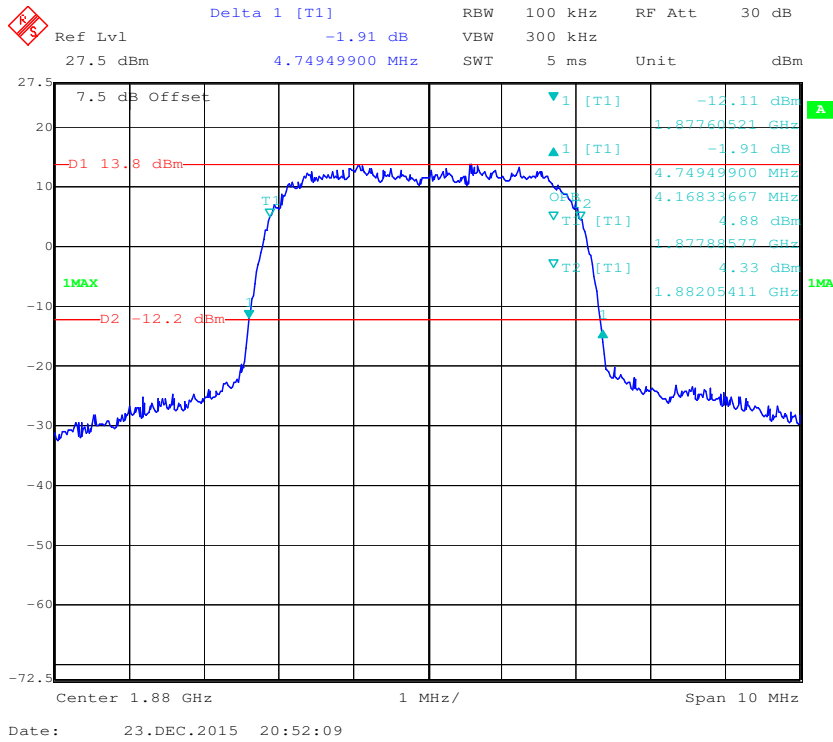


**999% Occupied & 26 dB Emissions Bandwidth for WCDMA (BPSK) Mode**

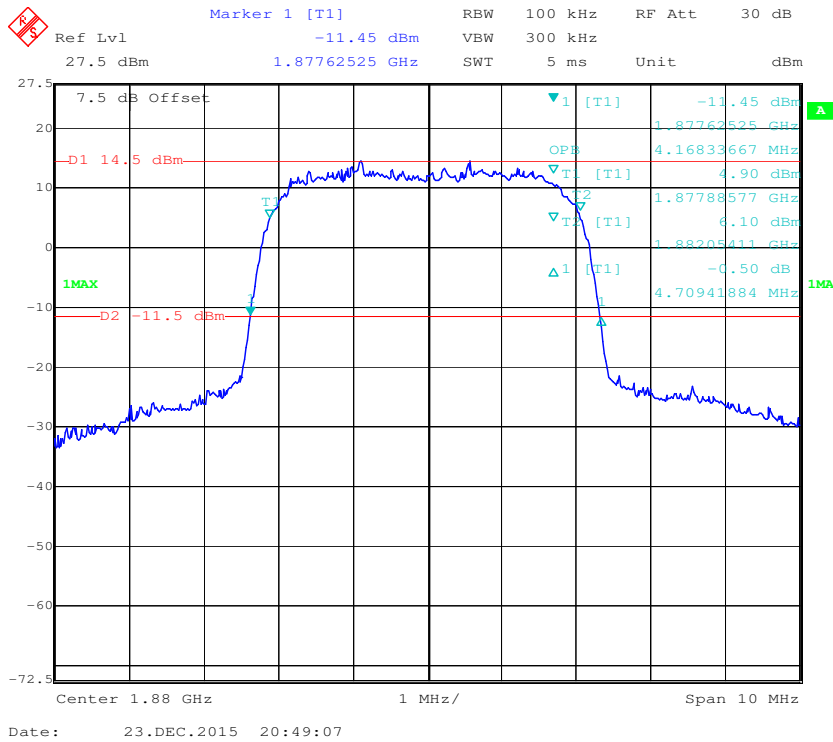




**99% Occupied & 26 dB Emissions Bandwidth for HSUPA (BPSK) Mode**

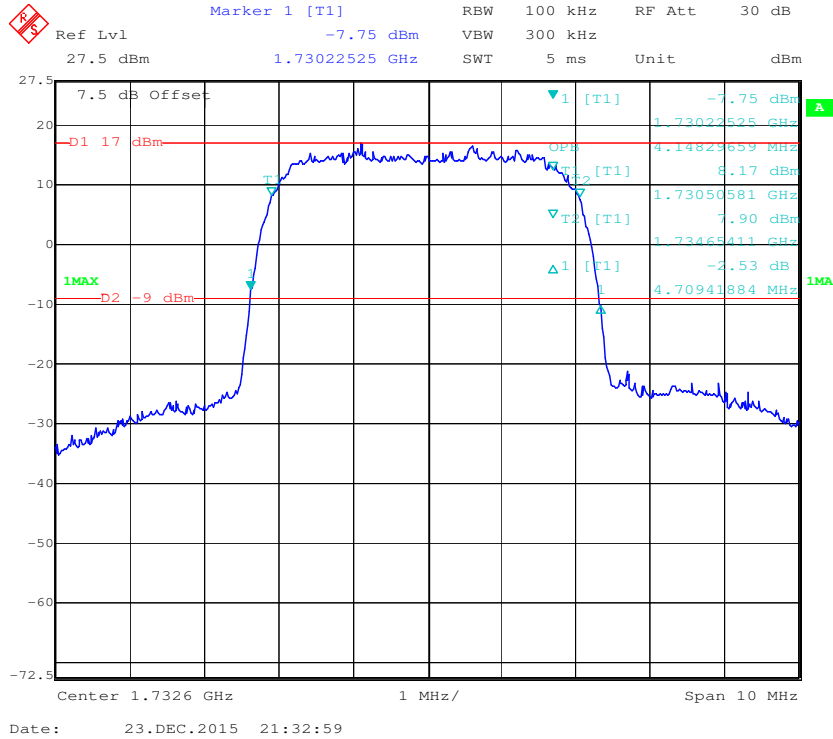


**99% Occupied & 26 dB Emissions Bandwidth for HSDPA (16QAM) Mode**

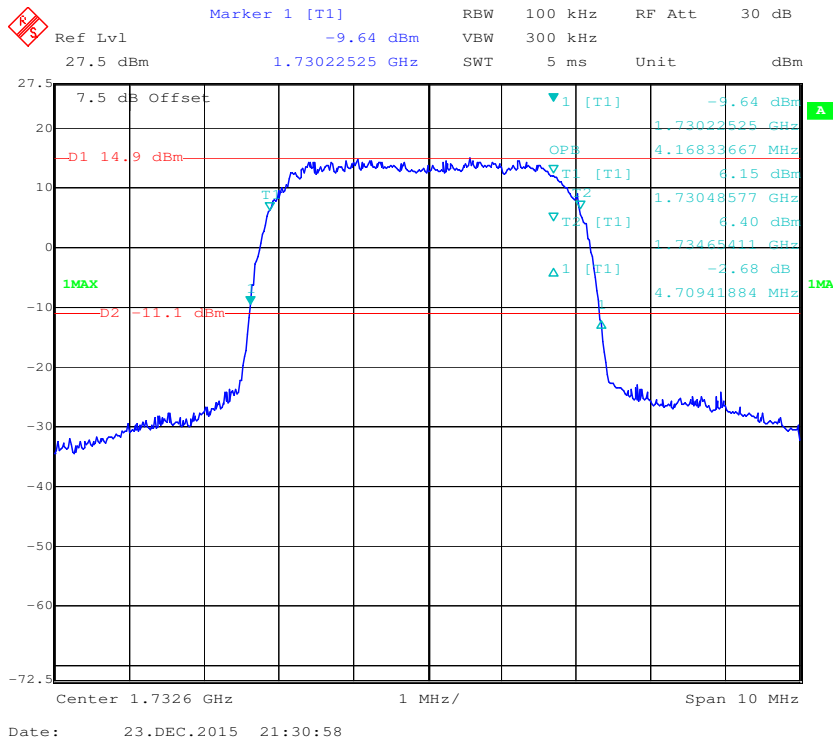

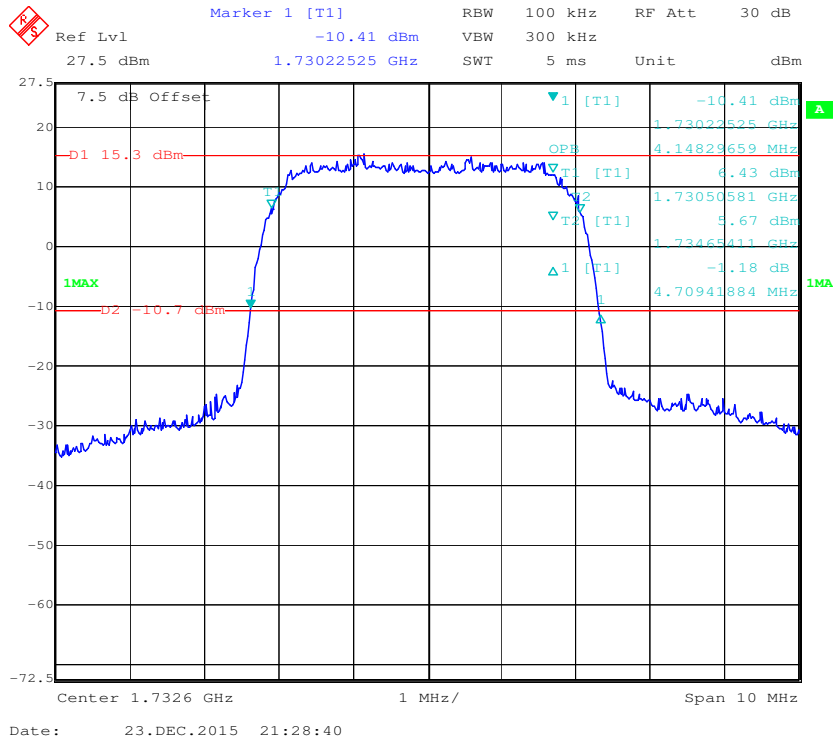
99% Occupied & 26 dB Emissions Bandwidth for WCDMA (BPSK) Mode

**Cellular Band, Left Band Edge for GSM (GMSK) Mode**



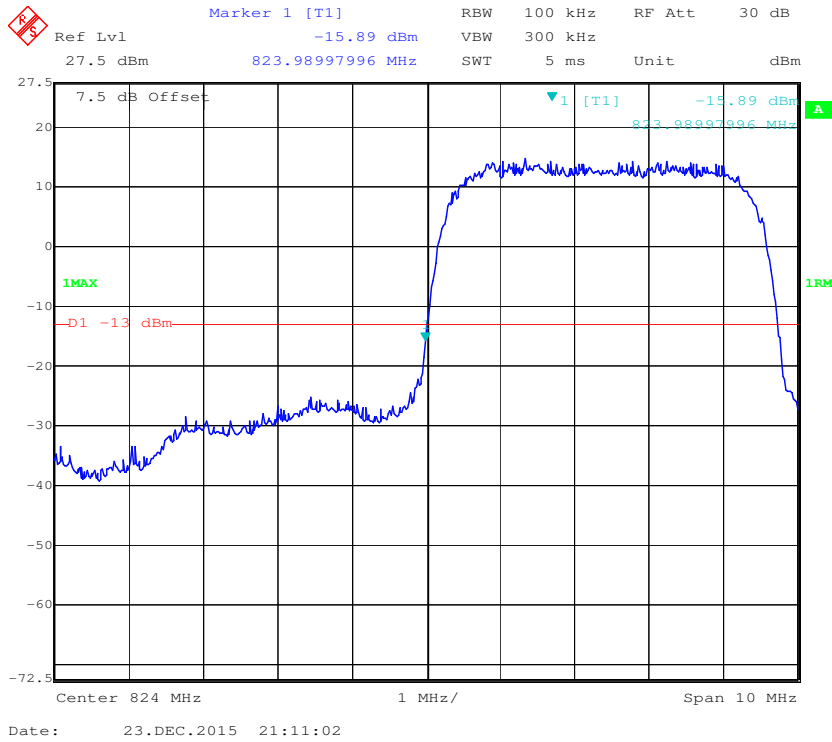
