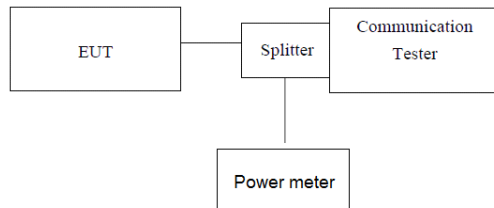

#### **TEST PROCEDURE**

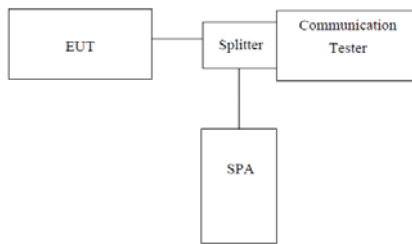
1. The transmitter output port was connected to base station.
2. The RF output of EUT was connected to the power meter by RF cable and attenuator, the path loss was compensated to the results for each measurement.
3. Set EUT at maximum power through base station.
4. Select lowest, middle, and highest channels for each band and different modulation.
5. Measure the maximum burst average power.

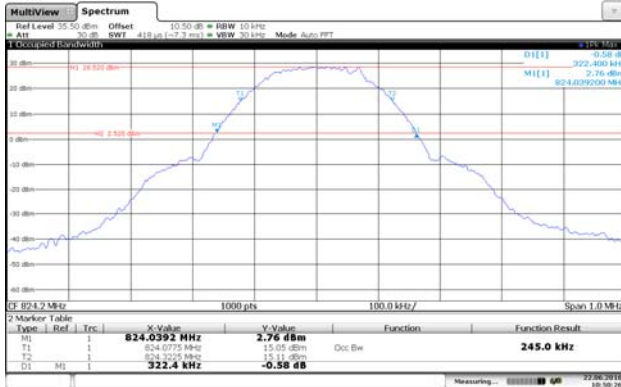
1. The EUT's output RF connector was connected with a short cable to the spectrum analyzer
2. RBW was set to about 1% of emission BW, VBW= 3 times RBW.
3. -26dBc display line was placed on the screen (or 99% bandwidth), the occupied bandwidth is the delta frequency between the two points where the display line intersects the signal trace.

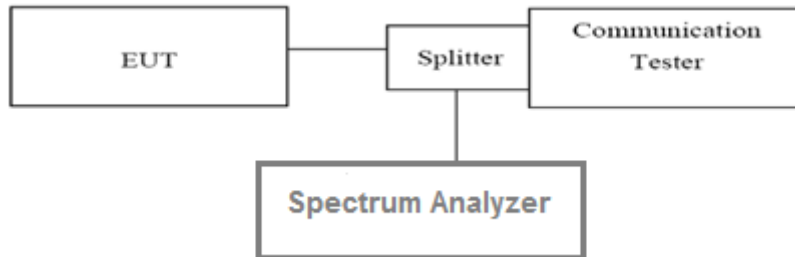
### 4.3. Out of band emission at antenna terminals

#### LIMIT

Part 24.238 and Part 22.917 specify that the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least  $43 + 10 \log(P)$  dB.

The specification that emissions shall be attenuated below the transmitter power (P) by at least  $43 + 10 \log(P)$  dB, translates in the relevant power range (1 to 0.001 W) to -13 dBm. At 1 W the specified minimum attenuation becomes 43 dB and relative to a 30 dBm (1 W) carrier becomes a limit of -13 dBm. At 0.001 W (0 dBm) the minimum attenuation is 13 dB, which again yields a limit of -13 dBm. In this way a translation of the specification from relative to absolute terms is carried out.

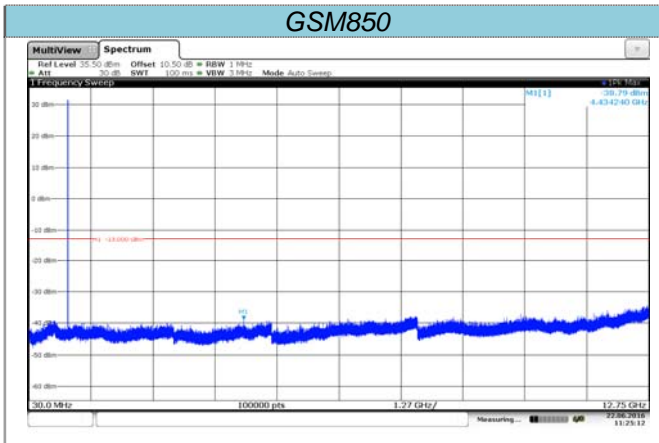

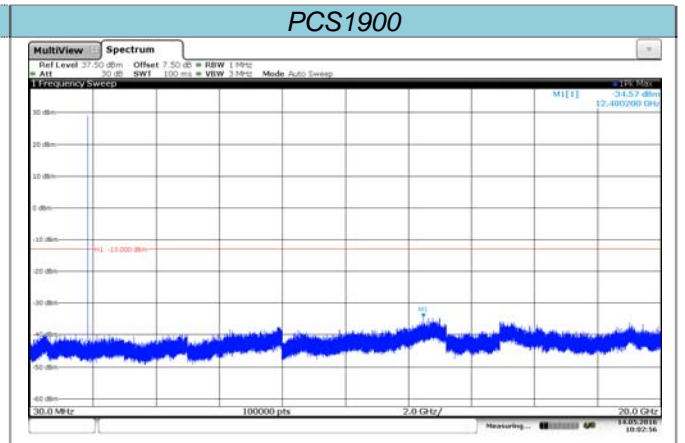
#### TEST PROCEDURE

1. The RF output of the transceiver was connected to a spectrum analyzer through appropriate attenuation.
2. The resolution bandwidth of the spectrum analyzer was set at 1MHz, sufficient scans were taken to show the out of band Emissions if any up to 10th harmonic.
3. For the out of band: Set the RBW= 1MHz, VBW = 3MHz, Start=30MHz, Stop= 10th harmonic.

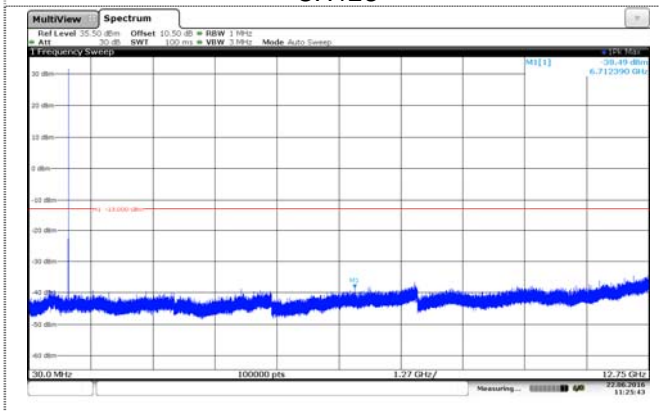

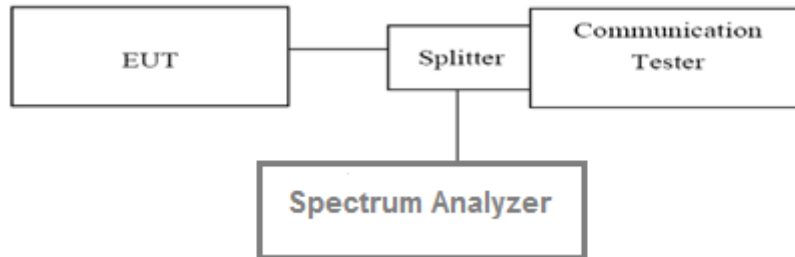
#### 4.4. Band Edge compliance

##### LIMIT

At 0.001 W (0 dBm) the minimum attenuation is 13 dB, which again yields a limit of -13 dBm. In this way a translation of the specification from relative to absolute terms is carried out.

An RF Signal source for the frequency band of interest is connected to the substitution antenna with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A power (PMea) is applied to the input of the substitution antenna, and adjust the level of the signal generator output until the value of the receiver

reach the previously recorded (Pr). The power of signal source (PMea) is recorded. The test should be performed by rotating the test item and adjusting the receiving antenna polarization.

5. A amplifier should be connected to the Signal Source output port. And the cable should be connect between the Amplifier and the Substitution Antenna. The cable loss (Pcl) ,the Substitution Antenna Gain (Ga) and the Amplifier Gain (PAg) should be recorded after test.

7. This value is EIRP since the measurement is calibrated using an antenna of known gain (2.15 dBi) and known input power.  
 ERP can be calculated from EIRP by subtracting the gain of the dipole,  $\text{ERP} = \text{EIRP} - 2.15\text{dBi}$ .
