- 2. The EUT is placed on a turn table which is 1.5 meter above ground. The turn table is rotated 360 degrees to determine the position of the maximum emission level.
- 3. The EUT waspositioned such that the distance from antenna to the EUT was 3 meters.
- 4. The antenna is scanned from 1 meter to 4 meters to find out the maximum emission level. Thisis repeated for both horizontal and vertical polarization of the antenna. In order to find themaximum emission, all of the interface cables were manipulated according to ANSI C63.10:2013 on radiated measurement.
- The receiver set as follow: RBW=1MHz, VBW=3MHz Peak detector for Peak value. RBW=1MHz, VBW=3MHz RMS detector for Average value.

- 2. The EUT is placed on a turn table which is 0.8 meter above ground for below 1 GHz, and 1.5 m for above 1 GHz. The turn table is rotated 360 degrees to determine the position of the maximum emission level.
- 3. The EUT was set 3 meters from the receiving antenna, which was mounted on the top of a variable height antenna tower.
- 4. For each suspected emission, the EUT was arranged to its worst case and then tune the Antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level to comply with the guidelines.
- 5. Set to the maximum power setting and enable the EUT transmit continuously.
- 6. Use the following spectrum analyzer settings






Radiated Emissions
