

FCC CFR Title 47 Part 15 Subpart C Section 15.247 (a)(1):Frequency hopping systems shall have hopping channel carrier fre-quencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hop-ping channel, whichever is greater. 
The pseudorandom frequency hopping sequence may be generated in a nice-stage shift register whose 5th and 9th stage outputs are added in a modulo-two addition stage. And the result is fed back to the input of the friststage. The sequence begins with the frist one of 9 consecutive ones, for example: the shift register is initialized with nine ones.

- Number of shift register stages: 9
- Length of pseudo-random sequence:29-1=511 bits
- Longest sequence of zeros: 8 (non-inverted signal)



5.11. Conducted Band edge and Spurious Emission



TEST PROCEDURE

- 2. The EUT is placed on a turn table which is 0.8 meter above ground for below 1 GHz, and 1.5 m for above 1 GHz. The turn table is rotated 360 degrees to determine the position of the maximum emission level.

Otherwise, the emission measurement will be repeated using the quasi-peak detector and reported.

c) Set RBW=1MHz, VBW=3MHz for >1GHz, Sweep time=auto, Detector=peak, Trace=max hold for Peak measurement




