EXHIBIT 1 GENERAL DESCRIPTION

1.0 **General Description**

1.1 Product Description

The equipment under test (EUT) is a Clock Radio with Bluetooth function. The EUT can play music through Bluetooth function or Audio Input. The EUT is operated by AC 100-240V, 50-60Hz. For more information, please refer to user manual.

The Model: Model M (with Bluetooth) is the same as the Model: Model M DAB+ (with Bluetooth) in hardware aspect, except without/with DAB+ function. The models are difference in the appearance and model no. for trading purpose.

Antenna Type: Integral antenna

Modulation Type: GFSK, $\pi/4$ –DQPSK and 8-DPSK

For electronic filing, the brief circuit description is saved with filename: descri.pdf.

1.2 Related Submittal(s) Grants

This is an application for certification of a transceiver for the Clock Radio which has Bluetooth function, and there is no corresponding unit for certification.

1.3 Test Methodology

Both AC mains line-conducted and radiated emission measurements were performed according to the procedures in ANSI C63.4 (2009). Radiated emission measurement was performed in Semi-anechoic chamber and conducted emission measurement was performed in shielding room. For radiated emission measurement, preliminary scans were performed in the semi-anechoic chamber only to determine the worst case modes. All radiated tetsts were performed at an anenna to EUT distance of 3 meters, unless stated otherwise in the "Justification Section" of this Application. All other measurements were made in accordance with the procedures in part 2 of CFR 47.

1.4 Test Facility

The Semi-anechoic chamber and shielding room used to collect the radiated data and conducted data are **Intertek Testing Services Shenzhen Ltd. Kejiyuan Branch** and located at 6F, D Block, Huahan Building, Langshan Road, Nanshan District, Shenzhen, P. R. China. This test facility and site measurement data have been fully placed on file with the FCC(Registration Number: 242492).

EXHIBIT 2 SYSTEM TEST CONFIGURATION

2.0 **System Test Configuration**

2.1 Justification

The system was configured for testing in a typical fashion (as a customer would normally use it), and in the confines as outlined in ANSI C63.4 (2009).

The EUT was powered by AC 120V/60Hz during the test.

All packets DH1, DH3 & DH5 mode in all modulation type GFSK, $\pi/4$ –DQPSK and 8-DPSK were tested, and only the worst data was reported in this report.

For maximizing emissions, the EUT was rotated through 360°, the antenna height was varied from 1 meter to 4 meters above the ground plane, and the antenna polarization was changed. This step by step procedure for maximizing emissions led to the data reported in Exhibit 3.

The equipment under test (EUT) was configured for testing in a typical fashion (as a customer would normally use it). The EUT was placed on a turn table, which enabled the engineer to maximize emissions through its placement in the three orthogonal axes.

The EUT exercise program (provided by client) used during testing was designed to exercise the various system components in a manner similar to a typical use.

3.0 **Emission Results**

3.1 Radiated Test Results

A sample calculation, configuration photographs and data tables of the emissions are included.

3.1.1 Field Strength Calculation

The field strength is calculated by adding the reading on the Spectrum Analyzer to the factors associated with preamplifiers (if any), antennas, cables, pulse desensitization and average factors (when specified limit is in average and measurements are made with peak detectors). A sample calculation is included below.

$$FS = RA + AF + CF - AG + PD + AV$$

Where $FS = Field Strength in dB\mu V/m$

RA = Receiver Amplitude (including preamplifier) in dBμV

CF = Cable Attenuation Factor in dB

AF = Antenna Factor in dB AG = Amplifier Gain in dB

PD = Pulse Desensitization in dB

AV = Average Factor in -dB

In the radiated emission table which follows, the reading shown on the data table may reflect the preamplifier gain. An example of the calculations, where the reading does not reflect the preamplifier gain, follows:

$$FS = RA + AF + CF - AG + PD + AV$$

Assume a receiver reading of 62.0 dBµV is obtained. The antenna factor of 7.4 dB and cable factor of 1.6 dB is added. The amplifier gain of 29 dB is subtracted. The pulse desensitization factor of the spectrum analyzer was 0 dB, and the resultant average factor was -10 dB. The net field strength for comparison to the appropriate emission limit is 32 dBµV/m. This value in dBµV/m was converted to its corresponding level in μ V/m.





8.0 <u>Miscellaneous Information</u>

This miscellaneous information includes details of the measured bandedge, the test procedure and calculation of factor such as pulse desensitization.

8.1 Bandedge Plot

For electronic filing, the plot shows the fundamental emission when modulated is saved with filename: bandedge.pdf. From the plot, the field strength of any emissions outside of the specified frequency band are attenuated to the general radiated emission limits in section 15.209. It fulfils the requirement of 15.249(d).

Peak Measurement

Bandedge compliance is determined by applying marker-delta method, i.e (Bandedge Plot).

(i) Lower channel 2402MHz:

Peak Resultant field strength = Fundamental emissions (peak value) - delta from the bandedge plot

 $= 97.1 dB\mu v/m - 45.44 dB$ = 51.66 dB $\mu v/m$

(ii) Upper channel 2480MHz:

Peak Resultant field strength = Fundamental emissions (peak value) - delta from the bandedge plot

 $= 97.8 \text{ dB}\mu\text{v/m} -43.99 \text{ dB}$ = 53.81 dB $\mu\text{v/m}$

The resultant field strength meets the general radiated emission limit in section 15.209, which does not exceed 74dBµv/m (Peak Limit) and 54dBµv/m (Average Limit).

8.1 Bandedge Plot (cont'd)

Pursuant to FCC part 15 Section 15.215(c), the 20dB bandwidth of the emission was contained within the frequency band designated (mentioned as above) which the EUT operated. The effects, if any, from frequency sweeping, frequency hopping, other modulation techniques and frequency stability over excepted variations in temperature and supply voltage were considered.

8.2 Discussion of Pulse Desensitization

Pulse desensitivity is not applicable for this device. The effective period (T_{eff}) is approximately 625µs for Bluetooth. With a resolution bandwidth (3dB) of 1MHz, so the pulse desensitivity factor is 0dB.

8.3 Transmitter Duty Cycle Calculation, FCC Rule 15.35(b, c)

Based on the Bluetooth Specification Version 2.1+EDR, transmitter ON time is independent of packet type (DH1, DH3 and DH5) and packet length

Channel hop rate = 800 hops/second (AFH Mode)

Adjusted channel hop rate for DH5 mode = 133.33 hops/second

Time per channel hop = 1 / 133.33 hops/second = 7.5 ms

Time to cycle through all channels = 7.5×20 channels = 150 ms

Number of times transmitter hits on one channel = 100 ms / 150 ms = 1 time(s)

Worst case dwell time = 7.5 ms

Duty cycle connection factor = $20log_{10}(7.5ms / 100ms) = -22.5 dB$

8.4 Emissions Test Procedures

The following is a description of the test procedure used by Intertek Testing Services in the measurements of transmitters operating under Part 15, Subpart C rules.

The test set-up and procedures described below are designed to meet the requirements of ANSI C63.4 - 2009.

The transmitting equipment under test (EUT) is placed on a wooden turntable which is four feet in diameter and approximately one meter in height above the ground plane. During the radiated emissions test, the turntable is rotated and any cables leaving the EUT are manipulated to find the configuration resulting in maximum emissions. The EUT is adjust through all three orthogonal axes to obtain maximum emission levels. The antenna height and polarization are varied during the testing to search for maximum signal levels.

Detector function for radiated emissions is in peak mode. Average readings, when required, are taken by measuring the duty cycle of the equipment under test and subtracting the corresponding amount in dB from the measured peak readings.

The frequency range scanned is from the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or 40 GHz, whichever is lower.

Detector function for conducted emissions is in QP & AV mode and IFBW setting is 9 kHz from the frequency band 150 kHz to 30MHz.

8.4 Emissions Test Procedures (cont'd)

The EUT is warmed up for 15 minutes prior to the test.

AC power to the unit is varied from 85% to 115% nominal and variation in the fundamental emission field strength is recorded. If battery powered, a new, fully charged battery is used.

Conducted measurements are made as described in ANSI C63.4 - 2009.

The IF bandwidth used for measurement of radiated signal strength was 10 kHz for emission below 30 MHz and 120 kHz for emission from 30 MHz to 1000 MHz. Where pulsed transmissions of short enough pulse duration warrant, a greater bandwidth is selected according to the recommendations of Hewlett Packard Application Note 150-2. Above 1000 MHz, a resolution bandwidth of 1 MHz is used.

Transmitter measurements are normally conducted at a measurement distance of three meters. However, to assure low enough noise floor in the restricted bands and above 1 GHz, signals are acquired at a distance of one meter or less. All measurements are extrapolated to three meters using inverse scaling, but those measurements taken at a closer distance are so marked.
