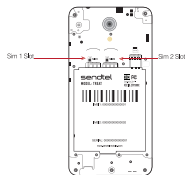

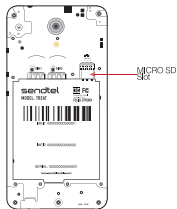


## INSERT SIM CARD

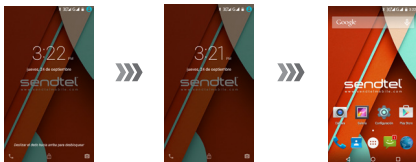

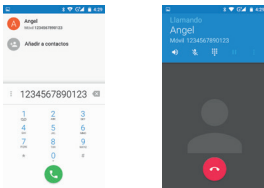
## LOCK AND UNLOCK THE SCREEN
